**Re: Mid-level Randolph Bus Stand**

Dear Alderman Reilly:

In response to a request from your office, CDOT staff investigated whether the bus stand on the middle level of Randolph Street between Columbus Drive and Lake Shore Drive can be moved from the north side of the street to the south. We have no objection to this suggestion. We recommend starting the bus stand 200 feet east of Columbus, since eastbound drivers are moving from daylight onto a shaded lower level street. This will give their eyes a moment to adjust to the light conditions before they encounter a parked bus. From there, the bus stand could run east to the beginning of the right turn lane at Lake Shore Drive. If you wish to proceed, please introduce the appropriate ordinances to City Council. Suggested language is provided here for your consideration:

Repeal the existing ordinance for a bus stand on the north side of middle level Randolph. Replace it with the following:

**No Parking - tow-away zone - all times**

Introduce the following language for a south side bus stand:

**West Randolph Street, middle level (south side) from a point 200 feet east of North Columbus Drive to a point 520 feet west of North Lake Shore Drive - tow away zone - except for bus stand 3PM-6PM**


