ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the **RM 5 Residential Multi-Unit District** symbols and indications as shown on Map No. 3-F in the area bounded by

a line 565.60 feet south of and parallel to West North Avenue; North Wieland Street; a line 615.60 feet south of and parallel to West North Avenue; and a line 102.2 feet west of and parallel to North Wieland Street

to those of a **B2-3 Neighborhood Mixed-Use District**.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

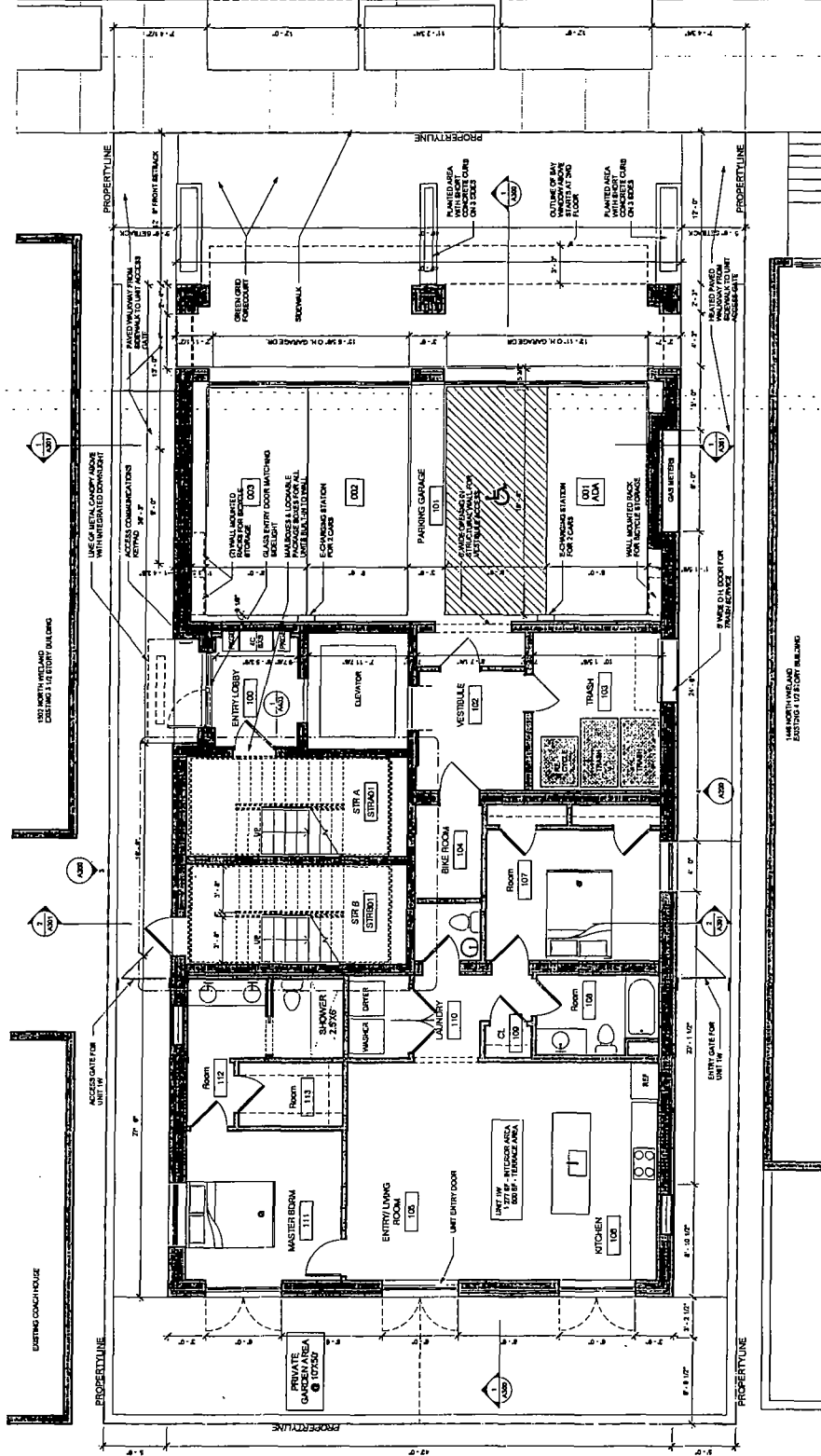

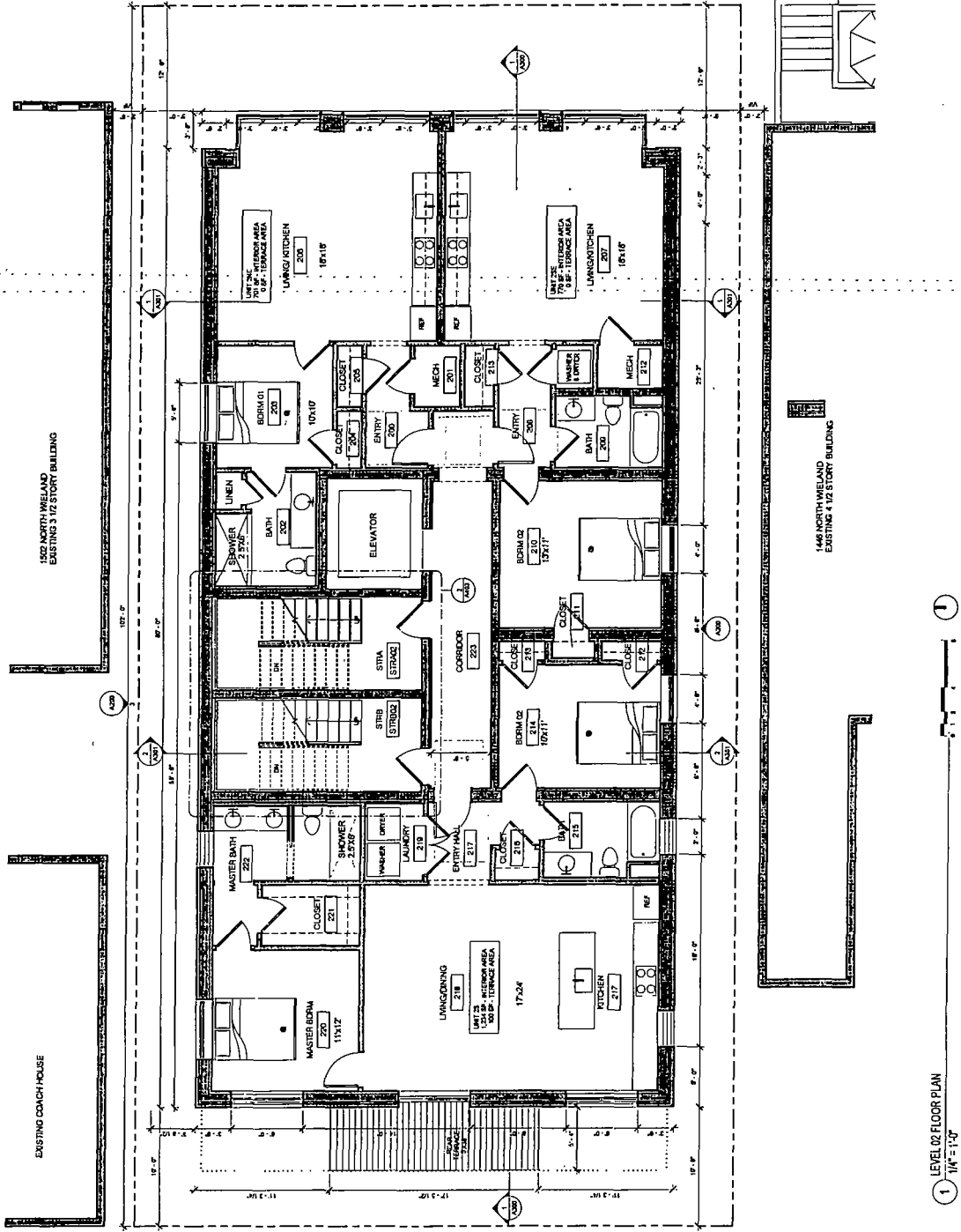

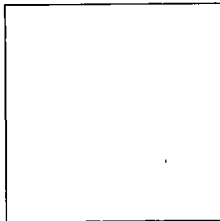

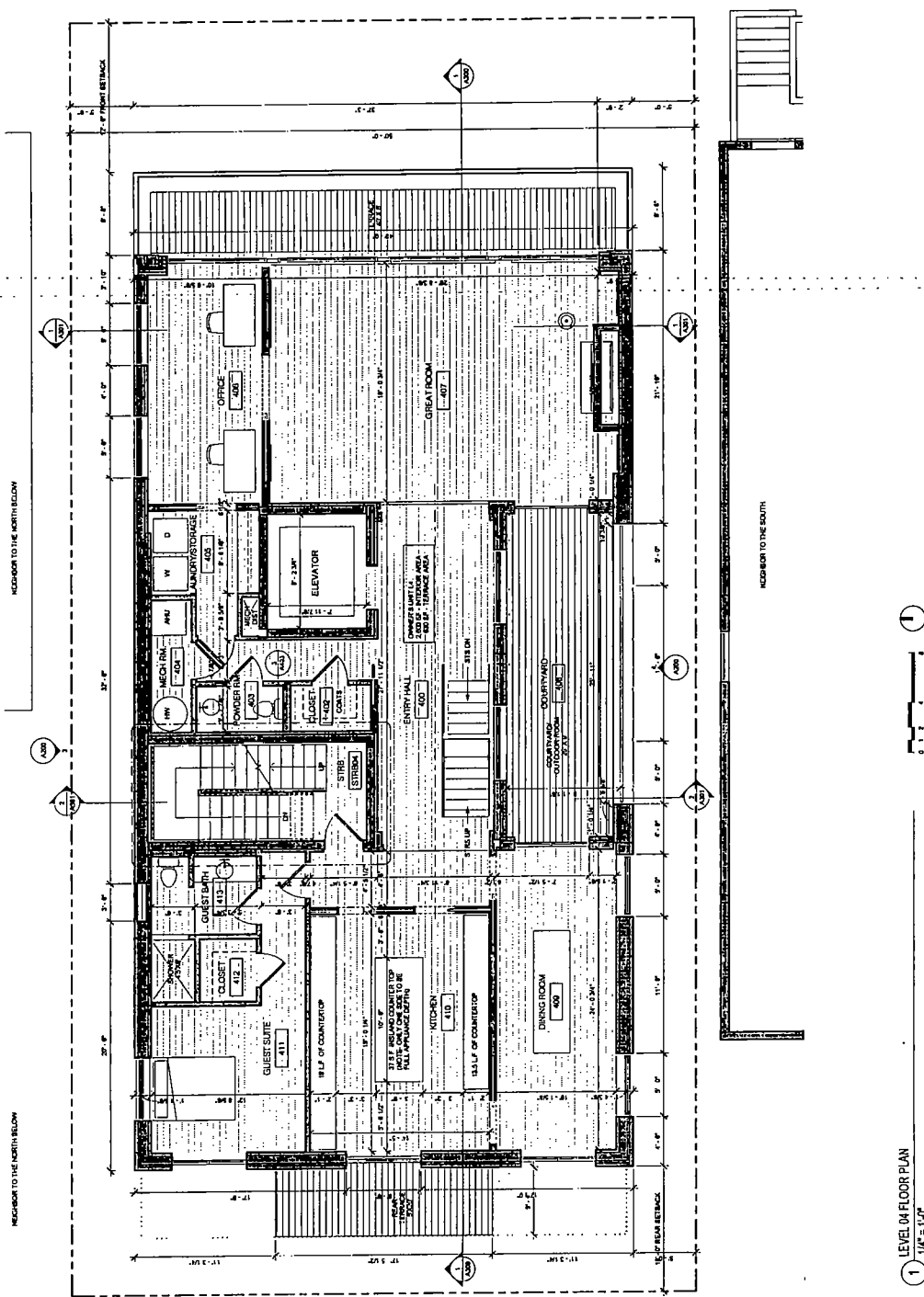

In accordance with Section 17-13-0107 of the Chicago Zoning Ordinance, please be informed that on or about February 10, 2020, the undersigned will file an application for a change in zoning from a RM5 Residential Multi-Unit District to a B2-3 Neighborhood Mixed-Use District on behalf of Nader and Juan Hindo (the "Applicant") for the property located at 1458-1500 N. Wieland Street, Chicago, IL 60610 (the "Subject Property").

The Applicant is seeking a zoning amendment for the Subject Property to demolish all the existing buildings on both lots and combine the two lots into one new 50' x 102.2' zoned lot in order to construct a five-story, seven dwelling unit masonry building with the Applicant occupying one dwelling on the entire 4th floor that is duplexed to a portion of the 3rd floor as an owner occupied unit. The first floor will contain an attached garage with three parking spaces, and the Applicant will seek to establish a Transit Served Location as the Subject Property is within 1,320 feet of the CTA Brown Line Sedgwick Station to reduce the parking requirement by 4 spaces. The proposed height of the building is 58 feet, with exterior rear balconies provided on the 2nd, 3rd, & 4th floors, and with roof decks on either side of the 5th floor stairway enclosure. No commercial uses are proposed.

C. 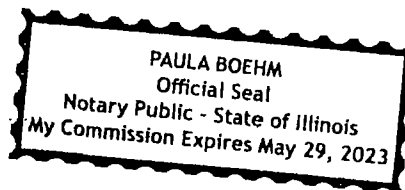
