***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

***SECTION 1.*** Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the B3-1 Community Shopping District symbols and indications as shown on Map No. 17-O in the area bounded by

a line 145.63 feet northwest of the intersection of North Northwest Highway and West Devon Avenue as measured along the southwesterly right-of-way line of North Northwest Highway and perpendicular thereto; North Northwest Highway; West Devon Avenue; and the alley next southwest of and parallel to North Northwest Highway

to those of a B3-1.5 Community Shopping District and a corresponding use district is hereby established in the area above described.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage and due publication.
