A line 150 feet East of and parallel to South Princeton Avenue, West 22<sup>nd</sup> Place, a line 175 feet East of and parallel to South Princeton Avenue, the public alley next South of and parallel to West 22<sup>nd</sup> Place.

to those of a B2-3 Neighborhood Mixed-Use District.

SECTION 2. This ordinance takes effect after its passage and due publication.
