SINGLE DIRECTION

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, Section 010 of the Municipal Code of Chicago, the operator of a vehicle shall operate such vehicle only in the Direction Specified below on the public ways between the limits indicated:

WARD SINGLE DIRECTION:

- 3 West 17th Street; West 17th Street from South State Street to South Dearborn Street; Single Direction - Westerly -- (17-07152517) [O2017-7113]
- 3 West 16th Street from South State Street to South Dearborn Street; Single Direction - Westerly -- (17-07152253) [O2017-7115]
- 24 West 13th Street from South Troy Street to South Albany Street; Single Direction - Easterly [O2018-5958]
- 24 West 13th Street from South Troy Street to South Kedzie Avenue; Single Direction - Westerly [O2018-5959]
- 45 West Waveland Avenue from North Milwaukee Avenue to North Lowell Avenue; Single Direction - Northeasterly [Or2018-251]

WARD AMEND SINGLE DIRECTION:

- 26 North Spaulding Avenue; Amend Ordinance which reads: North Spaulding Avenue from West Division Street to the first Alley south; Single Direction - Northerly by Striking: Single Direction - Northerly and Inserting: Two-Way Traffic in lieu thereof -- (18-01731961) [O2018-4310]
- 50 West Rosemont Avenue; Repeal Ordinance which reads; West Rosemont Avenue from North Albany Avenue to North Kedzie Avenue; Single Direction, by Striking the above [O2018-5957]

SECTION 2. This ordinance shall take effect and be in force here in after its passage and publication.
