ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all of the C1-1 Neighborhood Commercial District symbols and indications as shown on Map 1-G in the area bounded by:

West Fulton Market; North Green Street; West Wayman Street; a line 125 feet east of and parallel to North Green Street; a line 50 feet south of and parallel to West Wayman Street; and a line 100 feet east of and parallel to North Green Street

to those of DX-5 Downtown Mixed-Use District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication

Thor 816-820 West Fulton LLC is the “Applicant” for a Type 1 Zoning Map Amendment for the subject property located 816 through 824 West Fulton Market from the C1-1 Neighborhood Commercial District to the DX-5 Downtown District. The Applicant proposes the construction of a four-story commercial building.

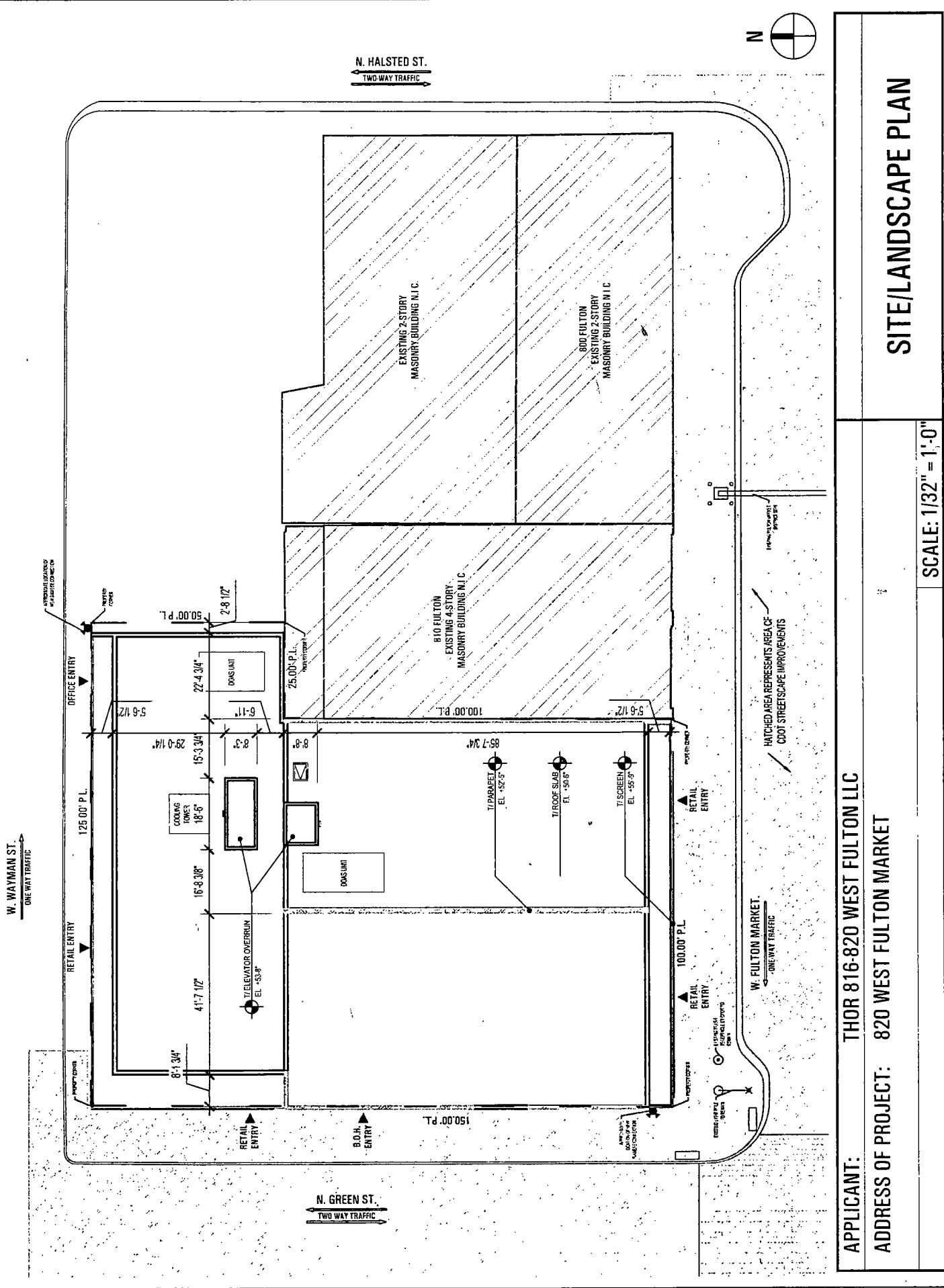
The site is located at the northeast corner of West Fulton Market and North Green Street. The site is located within the Kinzie Industrial Corridor and in the Downtown Expansion Area per Section 17-1-1500 of the Zoning Ordinance effective June 1, 2016. To the north of the subject property are properties zoned PMD 4A, to the south is C1-1 zoning, to the west is C3-2 zoning, and to the east is C2-5 zoning.

The subject property consists of approximately 16,250 square feet and is currently occupied by existing 2-, 3- and 4-story buildings. The Applicant proposes to add on to the existing buildings. The result will be a four-story commercial building containing up to 60,440 square feet of floor area.

Parking will not be provided. The subject property is within 1,000 feet from the Morgan Street CTA Station entrance.

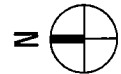

SITE/LANDSCAPE PLAN

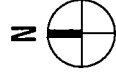
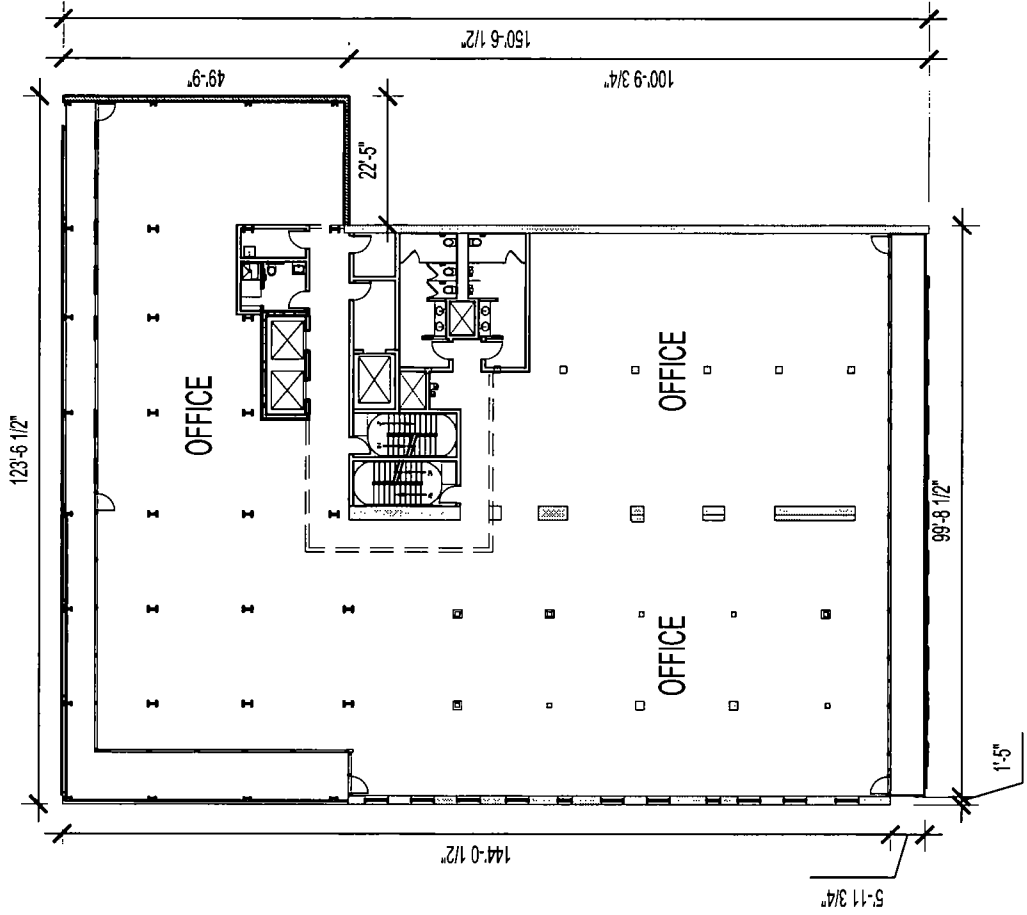

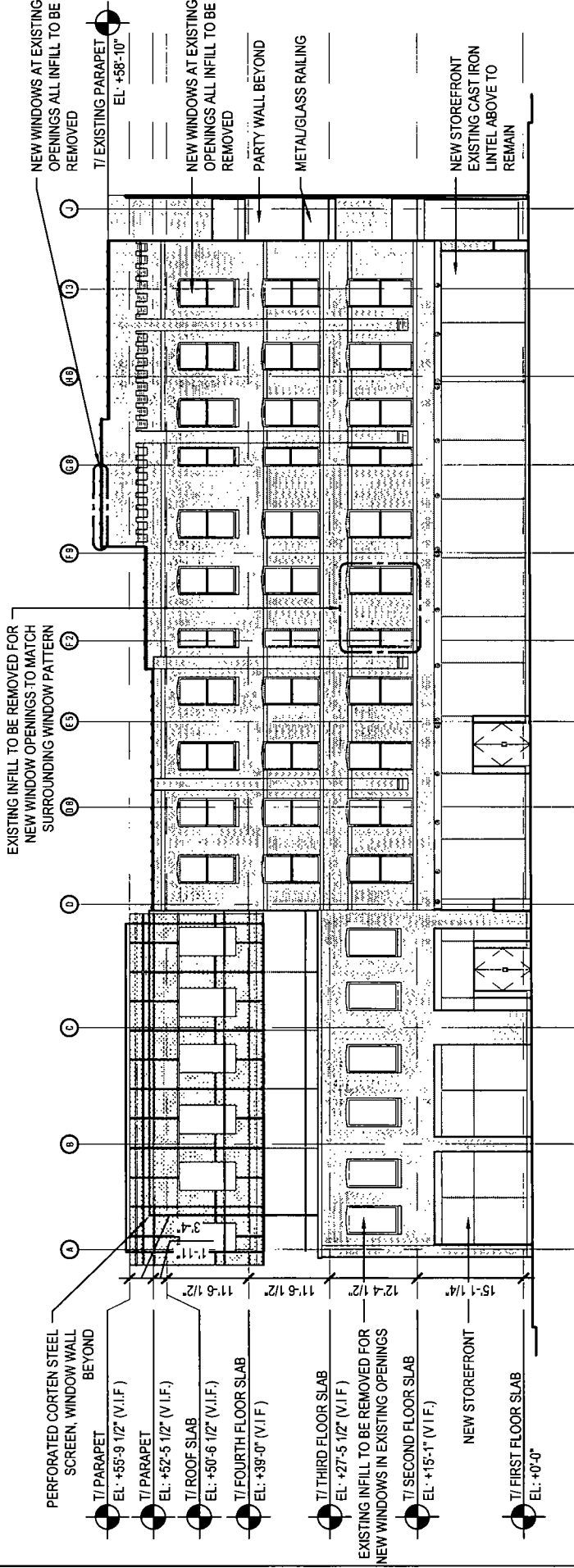


SOUTH ELEVATION

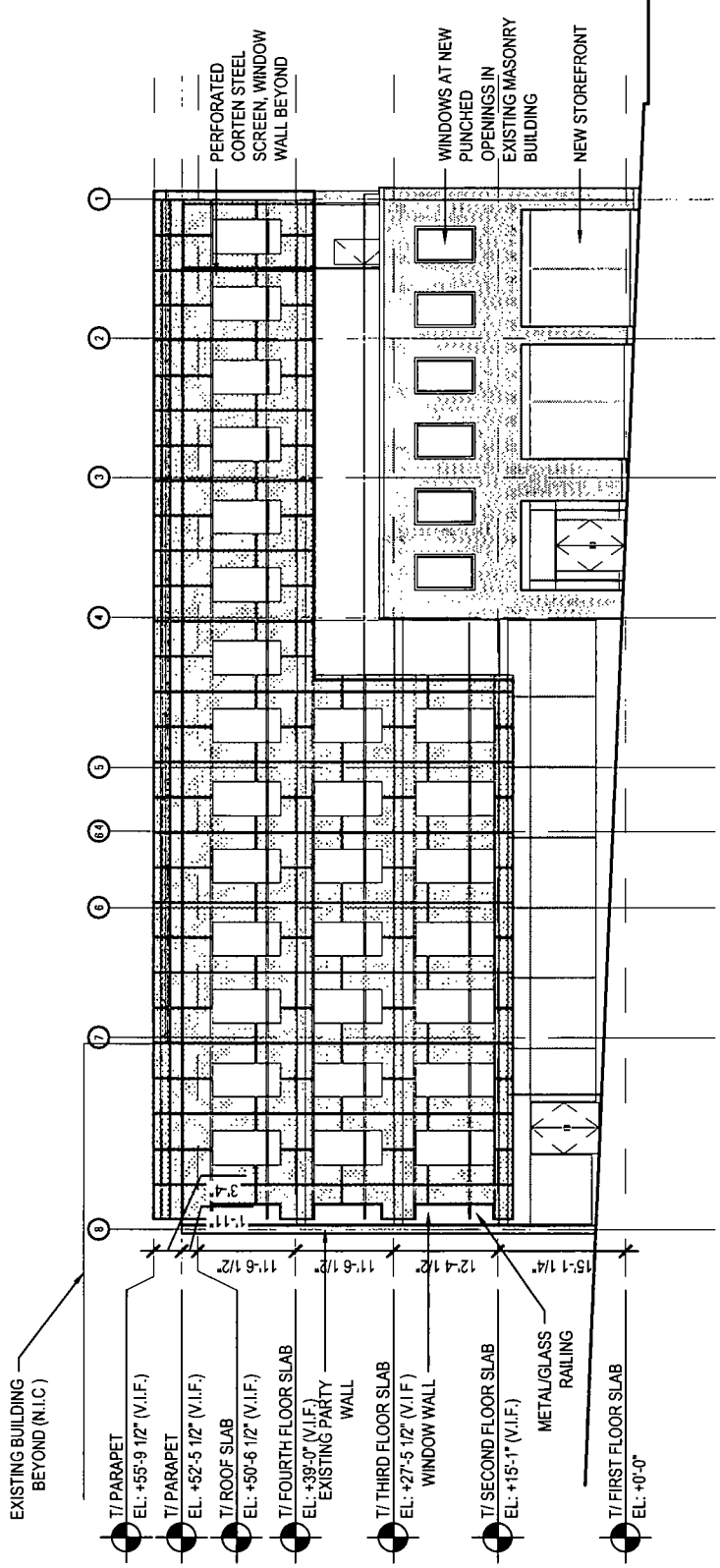

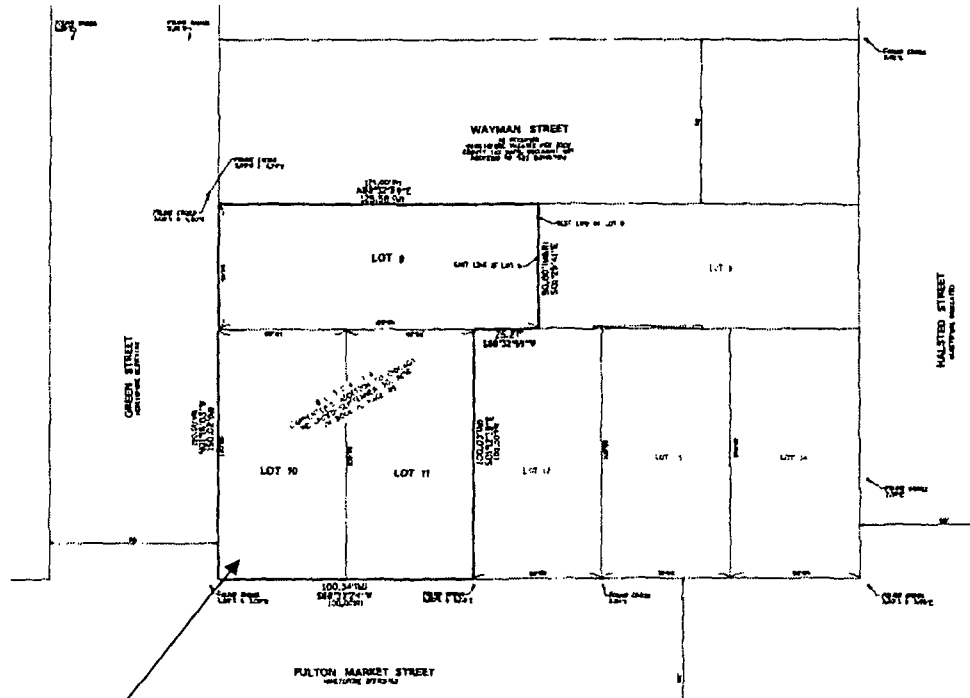
WEST ELEVATION

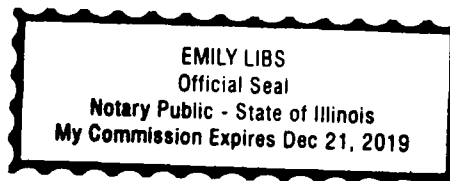

As required by Section 17-13-0107 of the Municipal Code of the City of Chicago, please be informed that on or about April 14, 2017, the undersigned, on behalf of Thor 816-820 West Fulton LLC (the "Applicant"), intends to file an application to rezone the property located at 816-824 West Fulton Market/301-315 North Green Street/813-825 West Wayman Street, Chicago, IL from the C1-1 Neighborhood Commercial District to the DX-5 Downtown Mixed-Use District. A map of the development site is printed on the reverse side of this letter.
