Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to PILSEN GATEWAY LLC upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use nineteen (19) Landscaping(s) on the public right-of-way for beautification purposes adjacent to its premises known as 1461 S BLUE ISLAND AVE.

Said Landscaping(s) at S Blue Island Ave measure(s):

One (1) at twenty-five (25) feet in length and four (4) feet in width for a total of one hundred (100) square feet.

One (1) at twenty-seven point five (27.5) feet in length and four (4) feet in width for a total of one hundred ten (110) square feet.

One (1) at forty (40) feet in length and four (4) feet in width for a total of one hundred sixty (160) square feet.

One (1) at forty (40) feet in length and four (4) feet in width for a total of one hundred sixty (160) square feet.

One (1) at fifty-four (54) feet in length and four (4) feet in width for a total of two hundred sixteen (216) square feet.

One (1) at thirty (30) feet in length and four (4) feet in width for a total of one hundred twenty (120) square feet.

One (1) at twenty (20) feet in length and four (4) feet in width for a total of eighty (80) square feet.

Said Landscaping(s) at W 14th Pl measure(s):

One (1) at twenty-five (25) feet in length and nine point three three (9.33) feet in width for a total of two hundred thirty-three point two five (233.25) square feet.

One (1) at twenty (20) feet in length and nine point three three (9.33) feet in width for a total of one hundred eighty-six point six (186.6) square feet.

One (1) at thirty (30) feet in length and nine point three three (9.33) feet in width for a total of two hundred seventy-nine point nine (279.9) square feet.

Said Landscaping(s) at S Racine Ave measure(s):

One (1) at fifty (50) feet in length and six point six six (6.66) feet in width for a total of three hundred thirty-three (333) square feet.

One (1) at twenty point five (20.5) feet in length and six point six six (6.66) feet in width for a total of one hundred thirty-six point five three (136.53) square feet.

One (1) at thirty-five (35) feet in length and six point six six (6.66) feet in width for a total of two hundred thirty-three point one (233.1) square feet.

One (1) at nineteen point three three (19.33) feet in length and six point six six (6.66) feet in width for a total of one hundred twenty-eight point seven four (128.74) square feet.

Said Landscaping(s) at W 15th Place measure(s):

One (1) at thirty-five (35) feet in length and six point three three (6.33) feet in width for a total of two hundred twenty-one point five five (221.55) square feet

Two (2) at forty-five (45) feet in length and six point three three (6.33) feet in width for a total of five hundred sixty-nine point seven (569.7) square feet.

One (1) at thirty-four (34) feet in length and six point three three (6.33) feet in width for a total of two hundred fifteen point two two (215.22) square feet.

One (1) at thirty (30) feet in length and six point three three (6.33) feet in width for a total of one hundred eighty-nine point nine (189.9) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP 1566614 herein granted the sum of Zero (\$0.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.

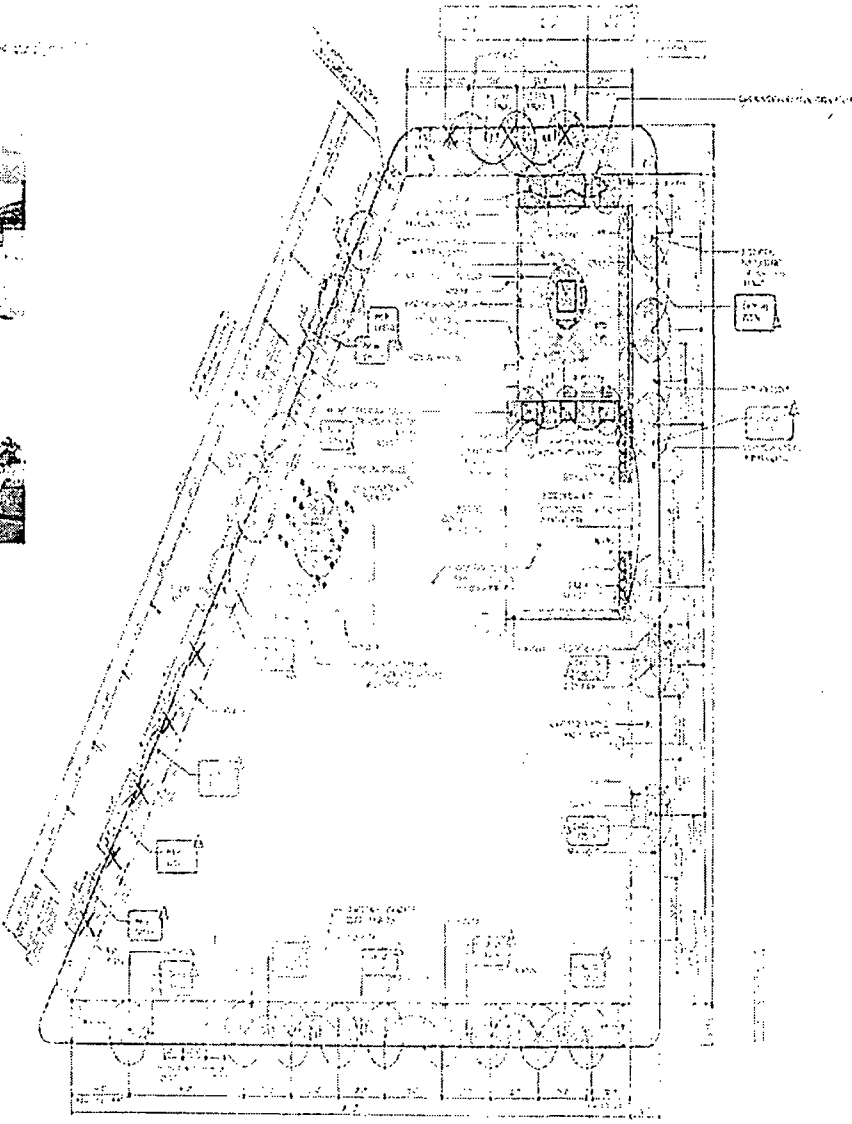
