

**SECTION 1.** Section 10-20-430 of the Municipal Code of Chicago, the Commissioner of Transportation is hereby authorized and directed to exempt **Dollar Express / Ashland FD LLC** from the provisions requiring barriers as a prerequisite to prohibit alley ingress and egress to parking facilities for premise address at **4524 South Ashland Avenue**.

**SECTION 2.** This ordinance shall take effect and be in force from and after its passage and publication.

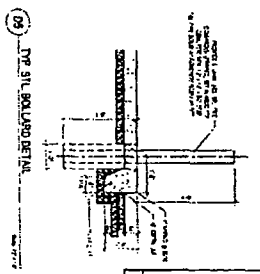
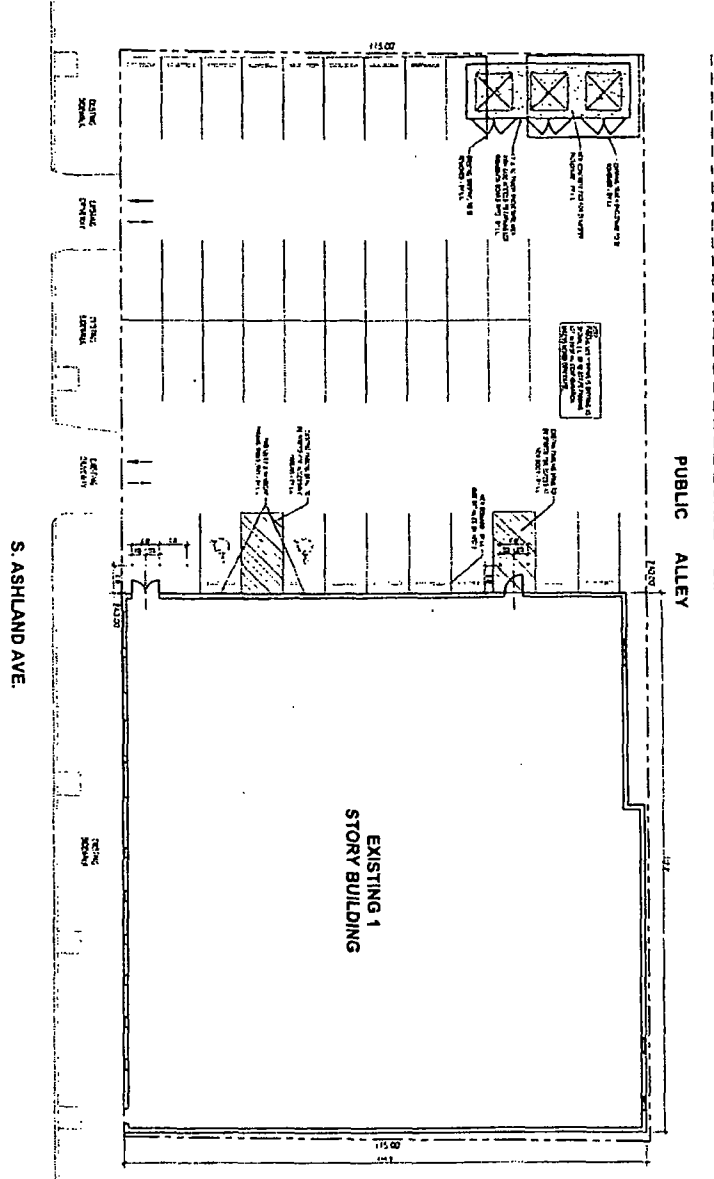
