ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-2, Limited Manufacturing / Business Park District, District symbols and indications as shown on Map No. <u>8-G</u> in the area bounded by:

A line 52 feet South of West 36th Street; the public alley East of South Morgan Street; a line 260 feet South of West 36th Street; South Morgan Street.






