**ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-2, Limited Manufacturing / Business Park District, District symbols and indications as shown on Map No. 8-G in the area bounded by:

A line 52 feet South of West 36<sup>th</sup> Street; the public alley East of South Morgan Street; a line 260 feet South of West 36<sup>th</sup> Street; South Morgan Street.

to those of the RM4.5 District, Residential Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and due publication.

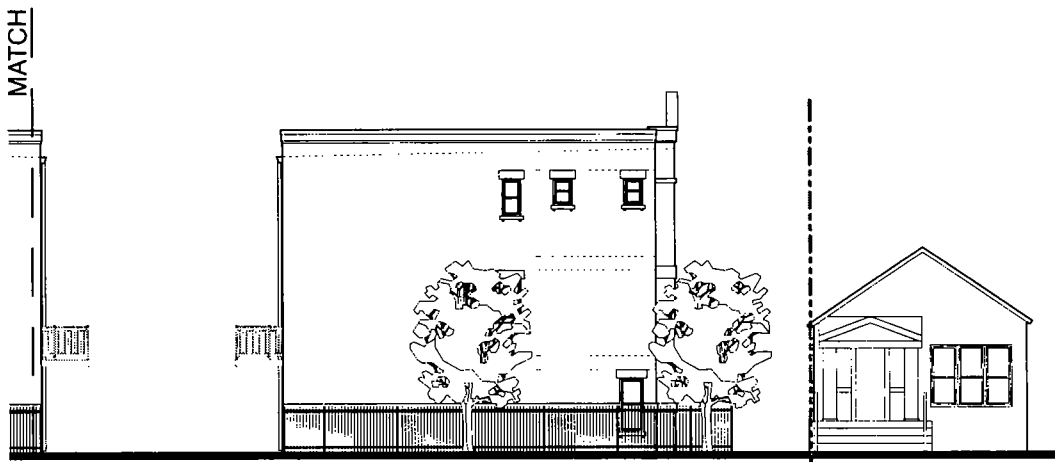

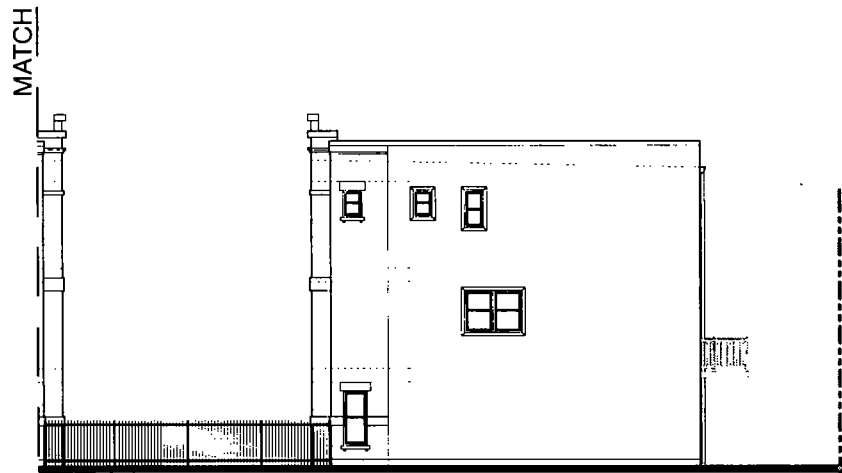
