**SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RT4 Residential Two-Flat, Townhouse and Multi-Unit District and the B3-1 Community Shopping District symbols as shown on Map No. 6-J**

**in the area bounded by:**

**A line 50 feet north of and parallel to West 25<sup>th</sup> Street; the public alley next east of and parallel to South Christiana Avenue; West 25<sup>th</sup> Street; and South Christiana Avenue.**

**To those of a B3-1 Community Shopping District**

**SECTION 2. This Ordinance takes effect after its passage and due publication.**
