

BE IT ORDAINED BY THE CITY COUNCIL OF CHICAGO:

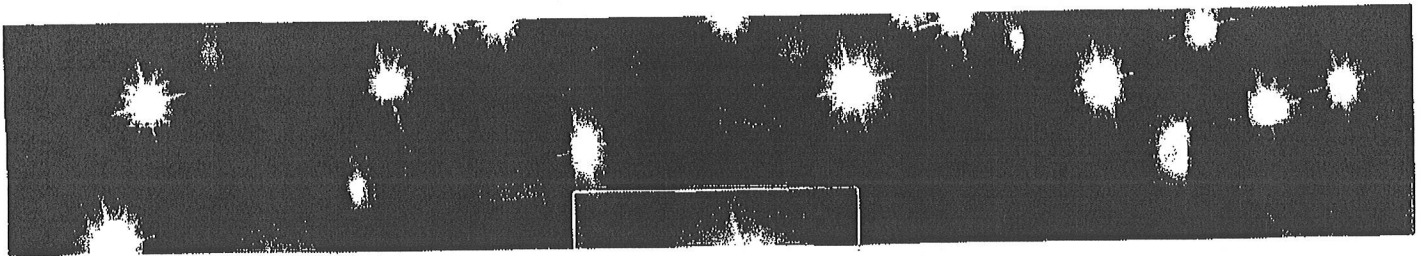

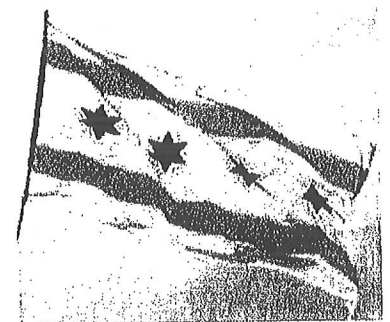


