ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-2 Neighborhood Commercial District symbols and indications as shown on Map No. 4-G in the area bounded by

South Blue Island Avenue; a line 50 feet south of West 19<sup>th</sup> Street running a distance of 120 feet that is perpendicular to South Blue Island Avenue; the public alley next southeast of and parallel to South Blue Island Avenue; a line 100 feet south of West 19<sup>th</sup> Street running a distance of 119.87 feet that is perpendicular to South Blue Island Avenue;

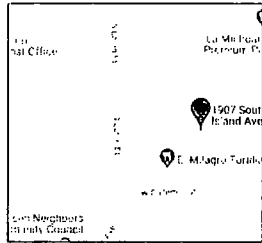
to those of RM-5.5 Residential Multi-Unit District

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

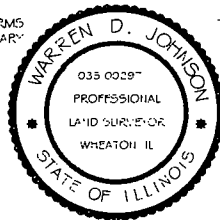

In accordance with the Amendment to the Zoning Code enacted by the City Council, Section 17-13-0107-A of the Chicago Zoning Ordinance, please be advised that on or about May 17, 2018, the undersigned, will file an application for a change in zoning for the property located 1907-1909 S Blue Island Avenue from a C1-2 Neighborhood Commercial District to a RM-5.5 Residential Multi-Unit District.

The applicant of the Zoning Amendment Application is Ventus Blue Island LLC located at 10 S LaSalle St., Suite 1420, Chicago, IL 60603.

The owner of the property is FLG Corporation located at 1065 W. Argyle St. 2E, Chicago, IL 60640.

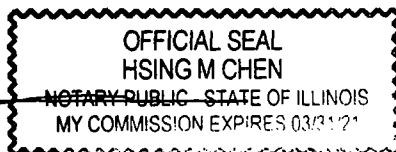

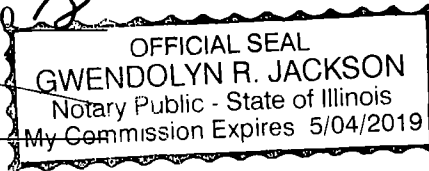

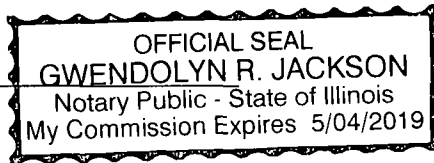
