BE IT ORDAINED BY THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-2 Neighborhood Shopping District symbols and indicators as shown on Map No. 7-L in the area bounded by

The public alley next north of and parallel to West Fullerton Avenue; a line 177.16 feet east of and parallel to North Lockwood Avenue; West Fullerton Avenue; and a line 227.16 feet east of and parallel to North Lockwood Avenue.

to those of a C1-3 Neighborhood Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.



In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about September 28, 2016, the undersigned will file an application for a change in zoning from B1-2 Neighborhood Shopping District to C1-3 Neighborhood Commercial District on behalf of Victor Mizhquiri for the property located at 5236-5240 West Fullerton Avenue, Chicago, IL 60639.

The applicant seeks the zoning change so that he can lease first-floor commercial space in the subject property to a tenant who will obtain a tavern liquor license. Subsequent to the zoning change and before the issuance of this license, the applicant will seek to have the liquor moratorium on the subject block lifted by City Council ordinance. This zoning change would allow a tenant to operate such a business without any off-street parking requirement. The property will continue to have three second-floor dwelling units in the current structure and no off-street parking spaces.



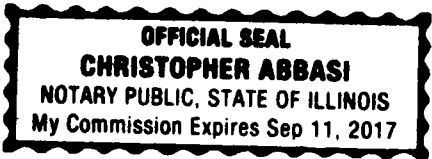
