ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1: That Title 17 of the Municipal Code of Chicago, Chicago Zoning Ordinance, be amended by changing all the C3-5 Commercial, Manufacturing and Employment District symbols and indications as shown on Map No. 3-G in the area bounded by:

West North Avenue; North Fremont Street; a line 227.5 feet south of and parallel to West Weed Street; the alley next northeast of and parallel to North Kingsbury Street, a line 308.38 feet northwest of and parallel to West Blackhawk Street; North Kingsbury Street; a line 400.00 feet northwest of and parallel to West Blackhawk Street; the alley next northeast of and parallel to North Kingsbury Street; West Weed Street; a line 190.30 feet west of and parallel to North Fremont Street; the alley next north of and parallel to Weed Street, a line 125.00 feet west of and parallel to North Fremont Street,

to the designation of C2-5 Motor Vehicle-Related Commercial District and a corresponding use district is hereby established in the area above described.

SECTION 2: That Title 17 of the Municipal Code of Chicago, Chicago Zoning Ordinance, be amended by changing all the C2-5 Motor Vehicle-Related Commercial District symbols and indications as shown on Map No. 3-G in the area bounded by:

West North Avenue; North Fremont Street; a line 227.5 feet south of and parallel to West Weed Street; the alley next northeast of and parallel to North Kingsbury Street, a line 308.38 feet northwest of and parallel to West Blackhawk Street; North Kingsbury Street; a line 400.00 feet northwest of and parallel to West Blackhawk Street; the alley next northeast of and parallel to North Kingsbury Street; West Weed Street; a line 190.30 feet west of and parallel to North Fremont Street; the alley next

north of and parallel to Weed Street, a line 125.00 feet west of and parallel to North Fremont Street,

to the designation of a Residential Business Planned Development which is hereby established in the area above described, subject to such use and bulk regulations as are set forth in the Plan of Development attached herewith and made a part thereof and to no others.

SECTION 3: This ordinance shall take effect upon its passage and due publication.

PLANNED DEVELOPMENT STATEMENTS

1. The area delineated herein as Residential Business Planned Development Number _____, (“Planned Development”) consists of approximately 108,820 square feet of property which is depicted on the attached Planned Development Boundary and Property Line Map (“Property”) and is owned, controlled or zoning consent has been received by the Co-Applicants, FREMONT SQUARE LLC and WEED STREET III LLC.
2. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors. All rights granted hereunder to the Applicant shall inure to the benefit of the Applicant’s successors and assigns and, if different than the Applicant, the legal title holder and any ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time of application for amendments, modifications or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under single ownership or designated control. Single designated control is defined in Section 17-8-0400 of the Zoning Ordinance.
3. All applicable official reviews, approvals or permits are required to be obtained by the Applicant or its successors, assignees or grantees. Any dedication or vacation of streets or alleys or grants of easements or any adjustment of the right-of-way shall require a separate submittal to the Department of Transportation on behalf of the Applicant or its successors, assign or grantees. Any requests for grants of privilege, or any items encroaching on the public way, shall be in compliance with the Plans.

Ingress or egress shall be pursuant to the Plans and may be subject to the review and approval of the Departments of Planning and Development and Transportation. Closure of all or any public street or alley during demolition or construction shall be subject to the review and approval of the Department of Transportation.

All work proposed in the public way must be designed and constructed in accordance with the Department of Transportation Construction Standards for Work in the Public Way and in compliance with the Municipal Code of the City of Chicago. Prior to the issuance of any Part II approval, the submitted plans must be approved by the Department of Transportation.

4. This Plan of Development consists of 15 Statements: a Bulk Regulations Table; an Existing Zoning Map; an Existing Land-Use Map; a Planned Development Boundary and Property Line Map; Sub-Area Map; Sub-Area Site Plans; Sub-Area; A Landscape Plan; Sub-Area Parking and Floor Plans; Sub-Area A Green Roof Plan; Sub-Area A Building Section Plan; and Building Elevations (North, South, East and West) prepared by RTKL and dated September 24, 2015, submitted herein. Full-sized copies of the Site Plan, Landscape Plan and Building Elevations are on file with the Department of Planning and Development. In any instance where a provision of this Planned Development conflicts with the Chicago Building Code, the Building Code shall control. This Planned Development conforms to the

intent and purpose of the Zoning Ordinance, and all requirements thereto, and satisfies the established criteria for approval as a Planned Development. In case of a conflict between the terms of this Planned Development Ordinance and the Zoning Ordinance, this Planned Development Ordinance shall control.

5. The following uses are permitted in the area delineated herein as a Residential Business Planned Development. In each of the following Sub Areas, the following uses shall be permitted in this Planned Development:

Sub-Area A: residential uses, including up to 407 dwelling units, commercial uses, general retail sales, eating and drinking establishments, liquor sales as an incidental use, accessory parking, of which 45% of the required residential parking (maximum 110 spaces) may be leased out on a daily, weekly or monthly basis to persons who are not residents, tenants, patrons, employees or guests of the principal uses, co-location of wireless telecommunication and satellite facilities, related facilities and accessory uses and all other permitted uses within the C2-5 Motor Vehicle-Related Commercial District.

Sub-Area B: commercial uses, general retail sales, eating and drinking establishments, liquor sales as an incidental use, accessory parking, co-location of wireless telecommunication and satellite facilities, related facilities and accessory uses and all other permitted uses within the C2-5 Motor Vehicle-Related Commercial District.

Sub-Area C: commercial uses, general retail sales, eating and drinking establishments, liquor sales as an incidental use, accessory parking, co-location of wireless telecommunication and satellite facilities, related facilities and accessory uses and all other permitted uses within the C2-5 Motor Vehicle-Related Commercial District.

6. On-Premise signs and temporary signs, such as construction and marketing signs, shall be permitted within the Planned Development, subject to the review and approval of the Department of Planning and Development. Off-Premise signs are prohibited within the boundary of the Planned Development.
7. For purposes of height measurement, the definitions in the Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations, if any, established by the Federal Aviation Administration.
8. The maximum permitted Floor Area Ratio ("FAR") for the site shall be in accordance with the attached Bulk Regulations Table. For the purposes of FAR calculations and measurements, the definitions in the Zoning Ordinance shall apply. The permitted Floor Area Ratio identified in the Bulk Regulations Table has been determined using a Net Site Area of 108,820 square feet and a base FAR of 5.00.
9. Upon review and determination, "Part II Review", pursuant to Section 17-13-0610 of the Zoning Ordinance, a Part II Review Fee shall be assessed by the Department of Planning and Development. The fee, as determined by staff at the time, is final and binding on the

Applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval.

10. The Site and Landscape Plans shall be in substantial conformance with the Landscape Ordinance and any other corresponding regulations and guidelines. Final landscape plan review and approval will be by the Department of Planning and Development. Any interim reviews associated with site plan review or Part II reviews, are conditional until final Part II approval.
11. The Applicant shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioners of the Departments of Streets and Sanitation, Environment and Buildings, under Section 13-32-125 of the Municipal Code, or any other provision of that Code.
12. The terms and conditions of development under this Planned Development ordinance may be modified administratively, pursuant to section 17-13-0611-A of the Zoning Ordinance by the Zoning Administrator upon the application for such a modification by the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors.
13. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enables and maximizes universal access throughout the Property. Plans for all buildings and improvements on the Property shall be reviewed and approved by the Mayor's Office for People with Disabilities to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.
14. The Applicant acknowledges that it is in the public interest to design, construct, renovate and maintain all buildings in a manner that provides healthier indoor environments, reduces operating costs and conserves energy and natural resources. (At the time of a hearing before the Chicago Plan Commission, all developments must be in substantial compliance with the current City of Chicago Sustainable Development Policy set forth by the Housing and Economic Development. The proposed Planned Development shall be in compliance with the Sustainable Development Policy by obtaining LEED certification and by providing a green roof of at least 50% of Net Roof Area of the new buildings constructed in Sub-Area A containing a green roof of 10,606 square feet and shall meet the applicable storm water requirements of the Department of Planning and Development.
15. This Planned Development shall be governed by Section 17-13-0612 of the Zoning Ordinance. Should this Planned Development ordinance lapse, the Commissioner of the Department of Planning and Development shall initiate a Zoning Map Amendment to rezone the property to the C2-5 Motor Vehicle-Related Commercial District.

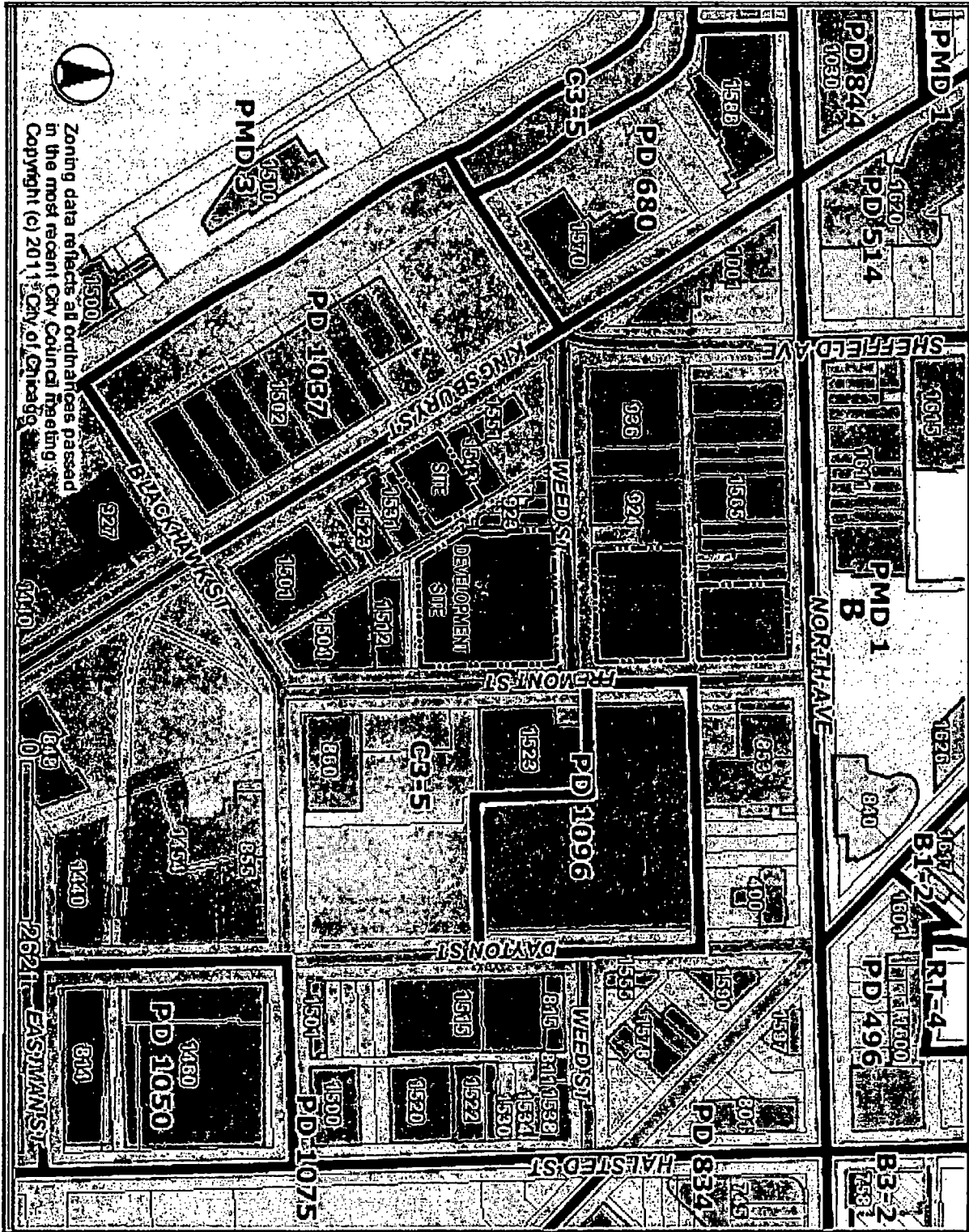

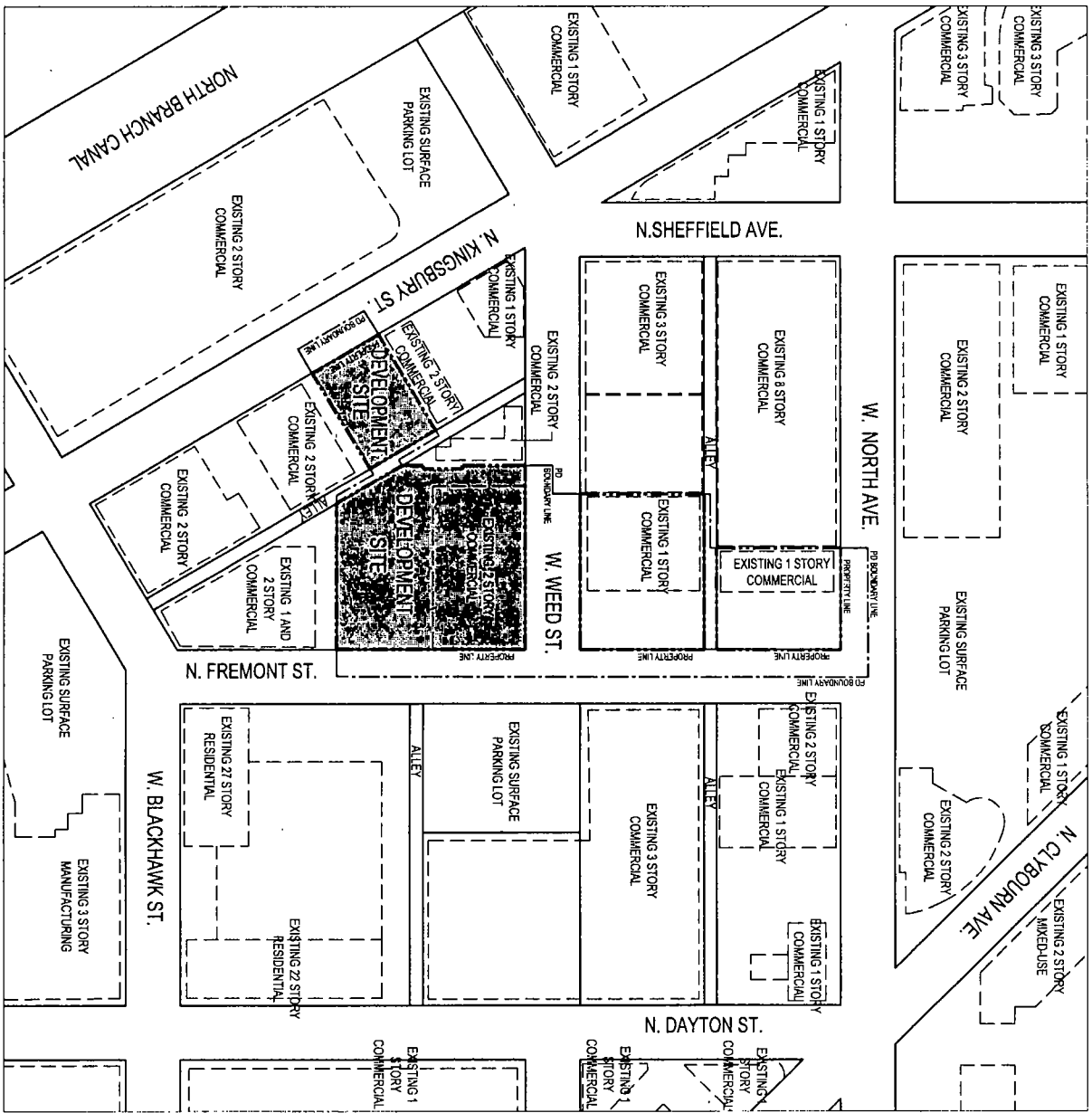

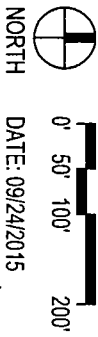

 EXISTING LAND-USE MAP

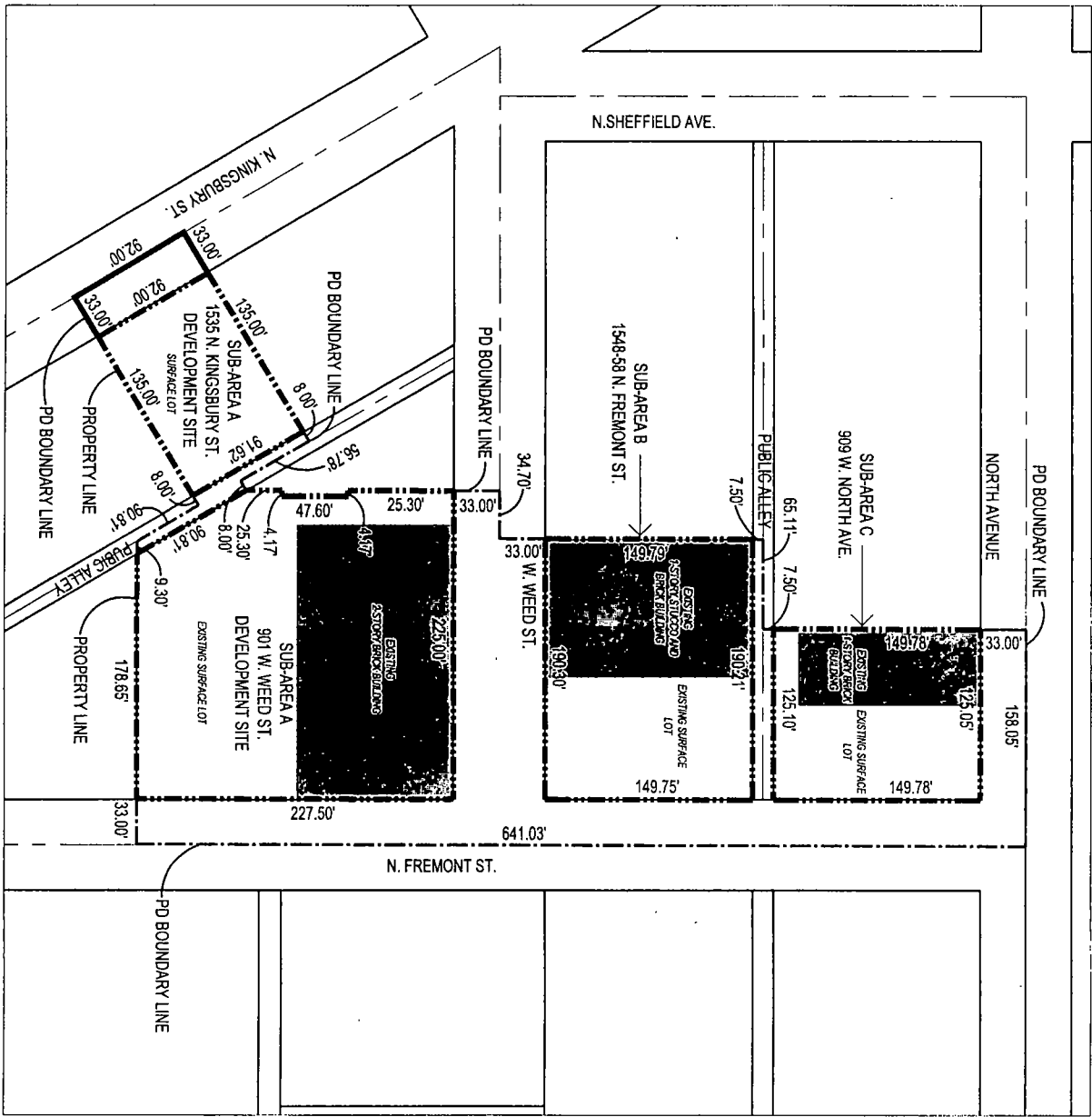

 PD BOUNDARY/ PROPERTY LINE MAP

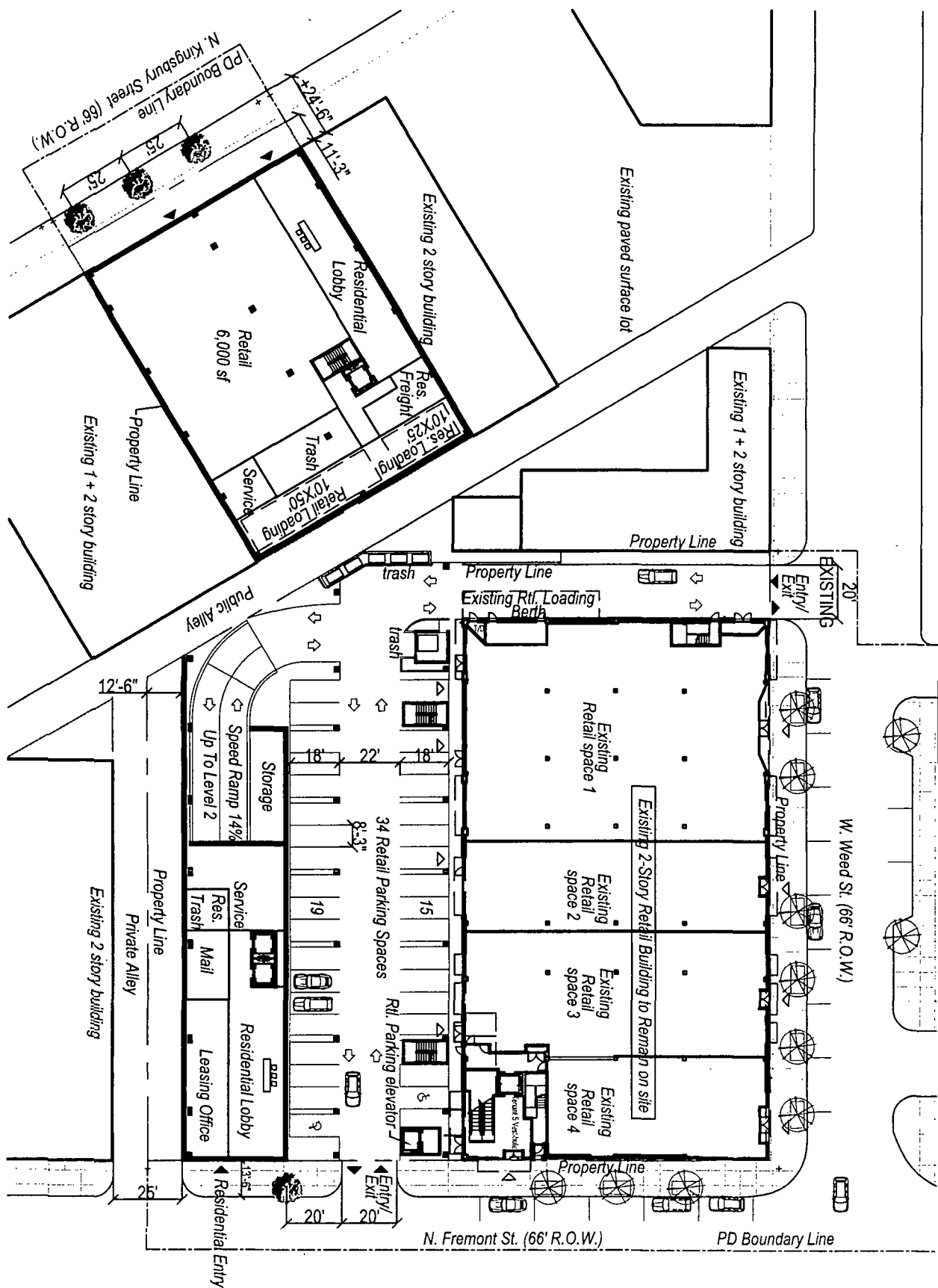

 SITE PLAN - SUB-AREA A

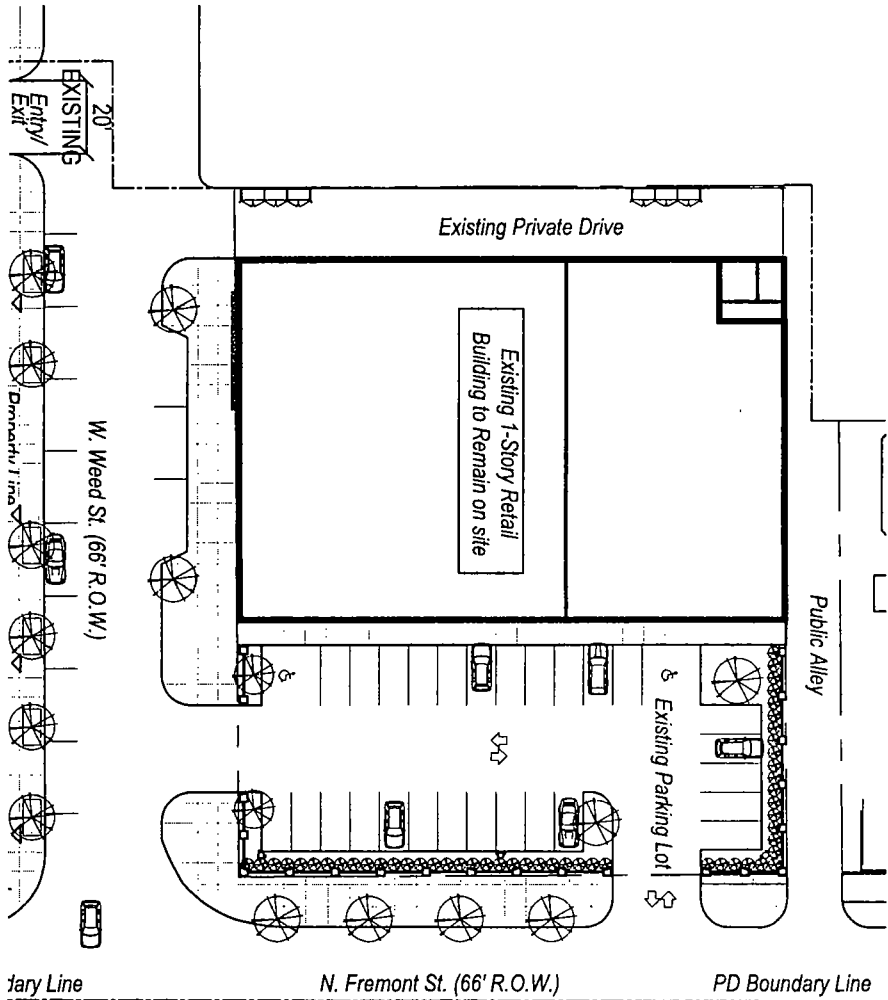

 SITE PLAN - SUB-AREA B

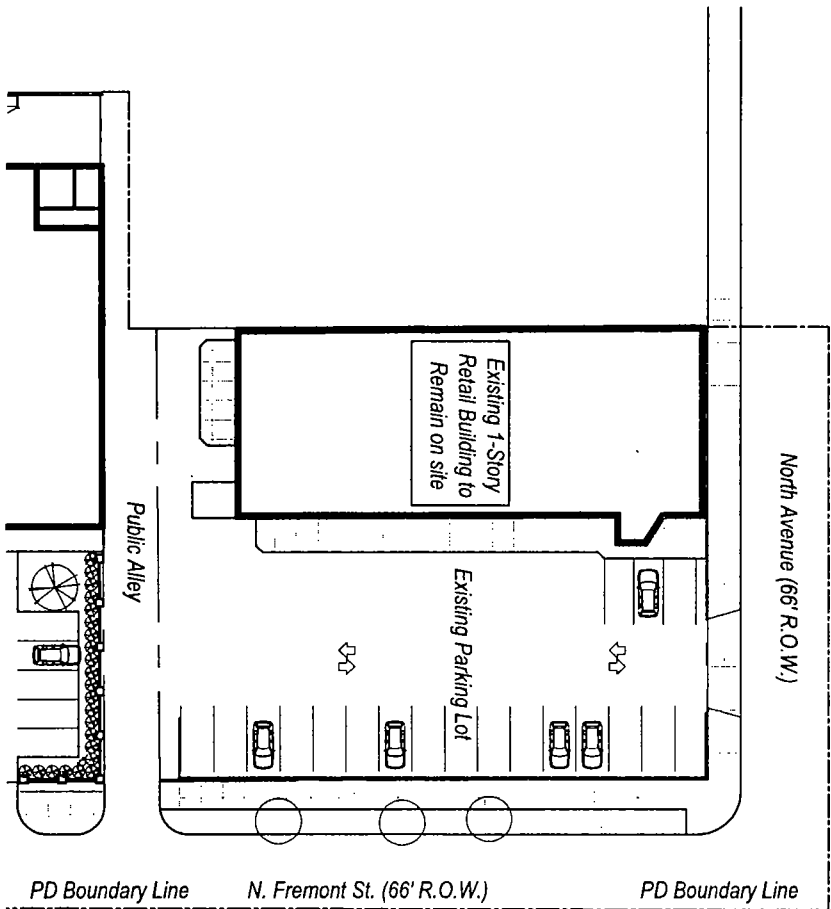

SITE PLAN - SUB-AREA C



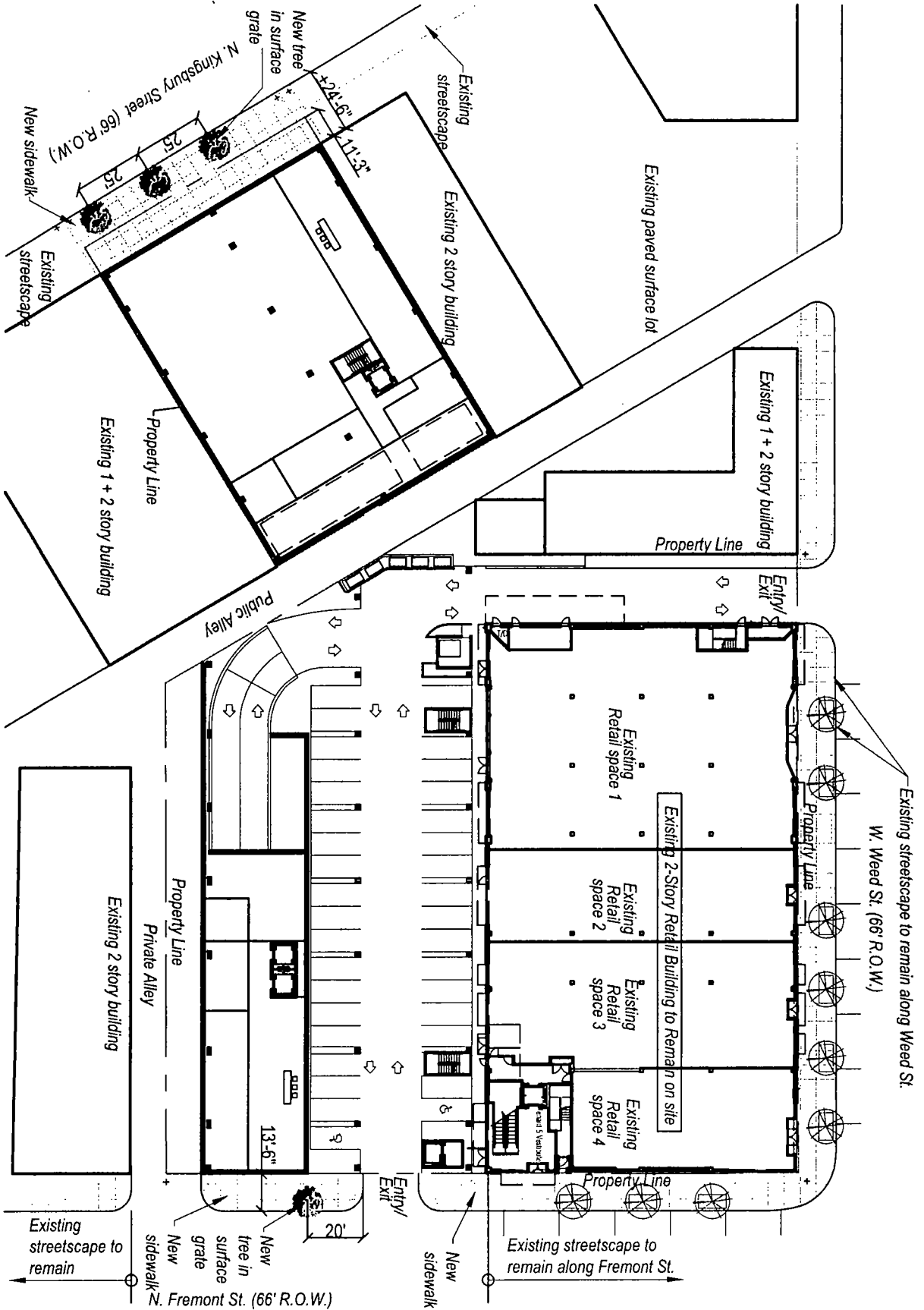

 LANDSCAPE PLAN - SUB-AREA A

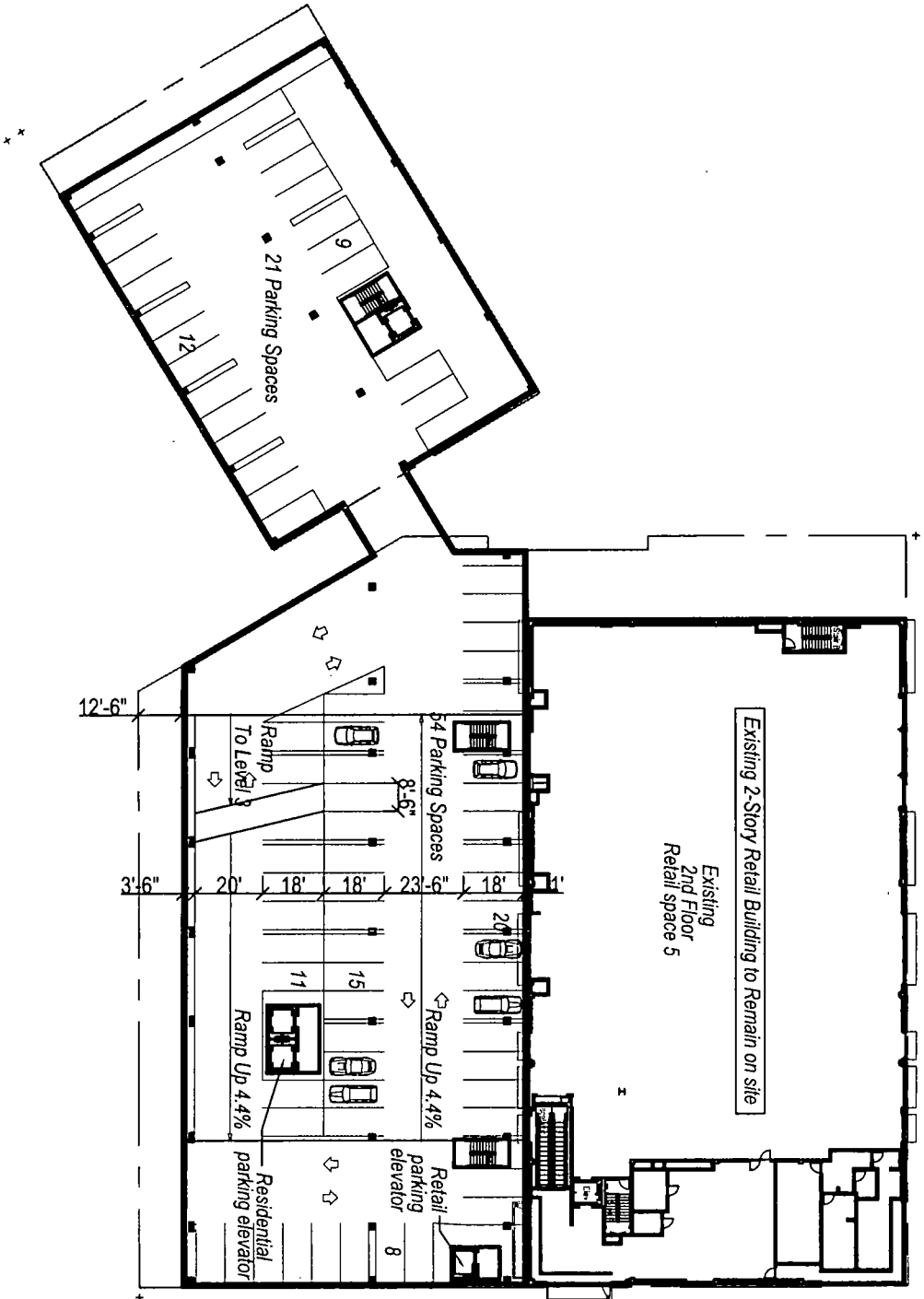

 LEVEL 2 PARKING PLAN - SUB-AREA A

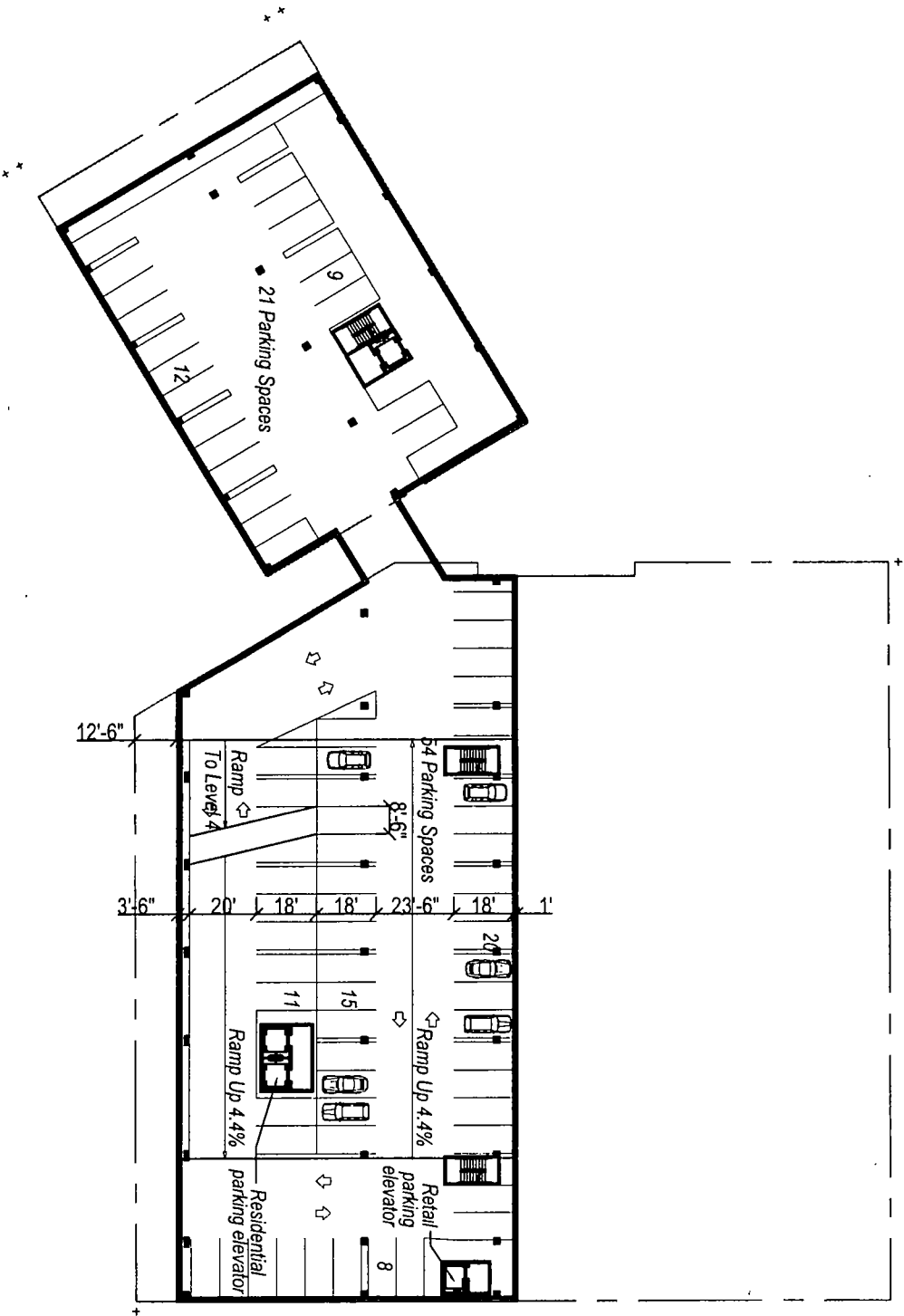

 LEVEL 3 PARKING PLAN - SUB-AREA A

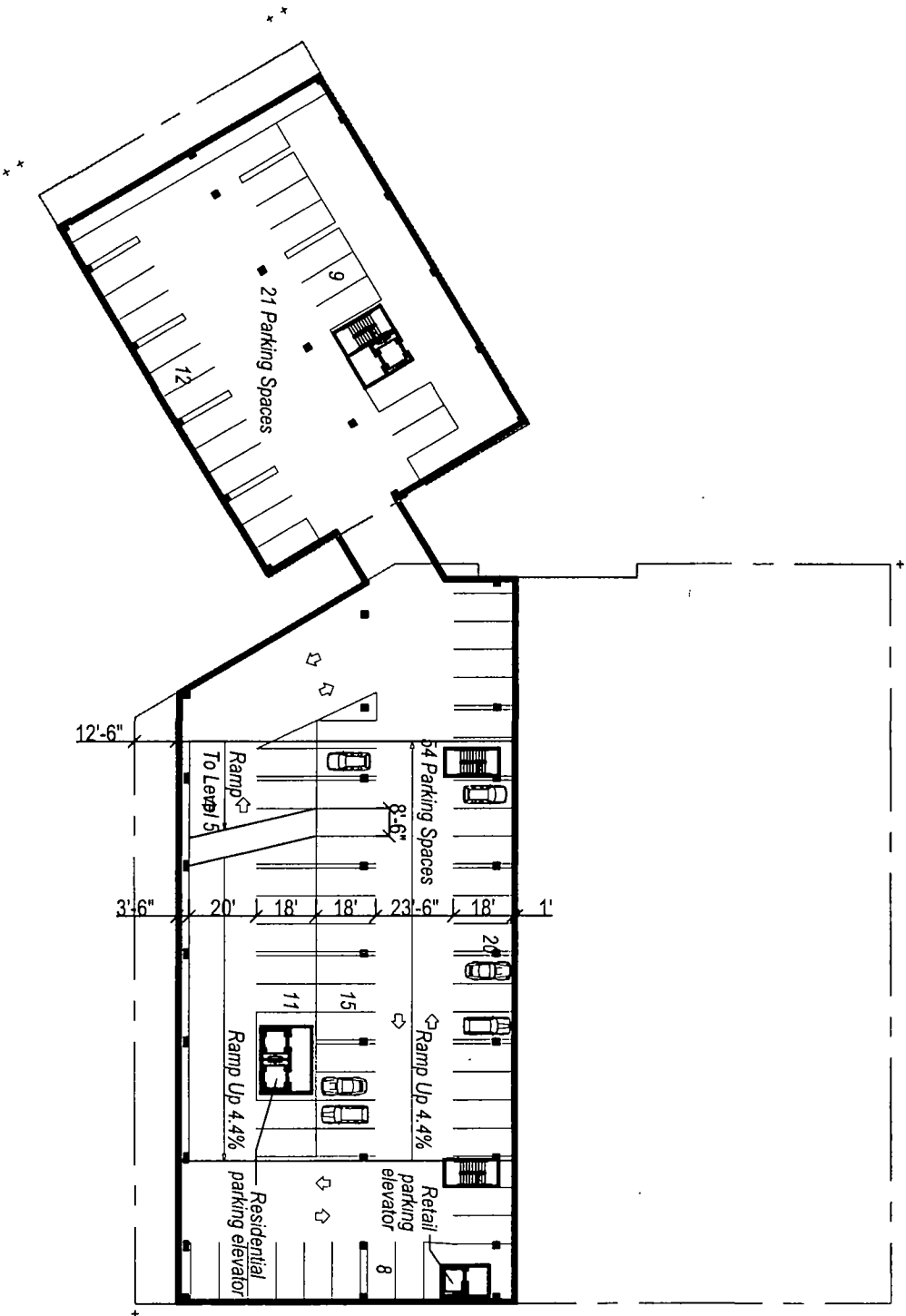

 LEVEL 4 PARKING PLAN - SUB-AREA A

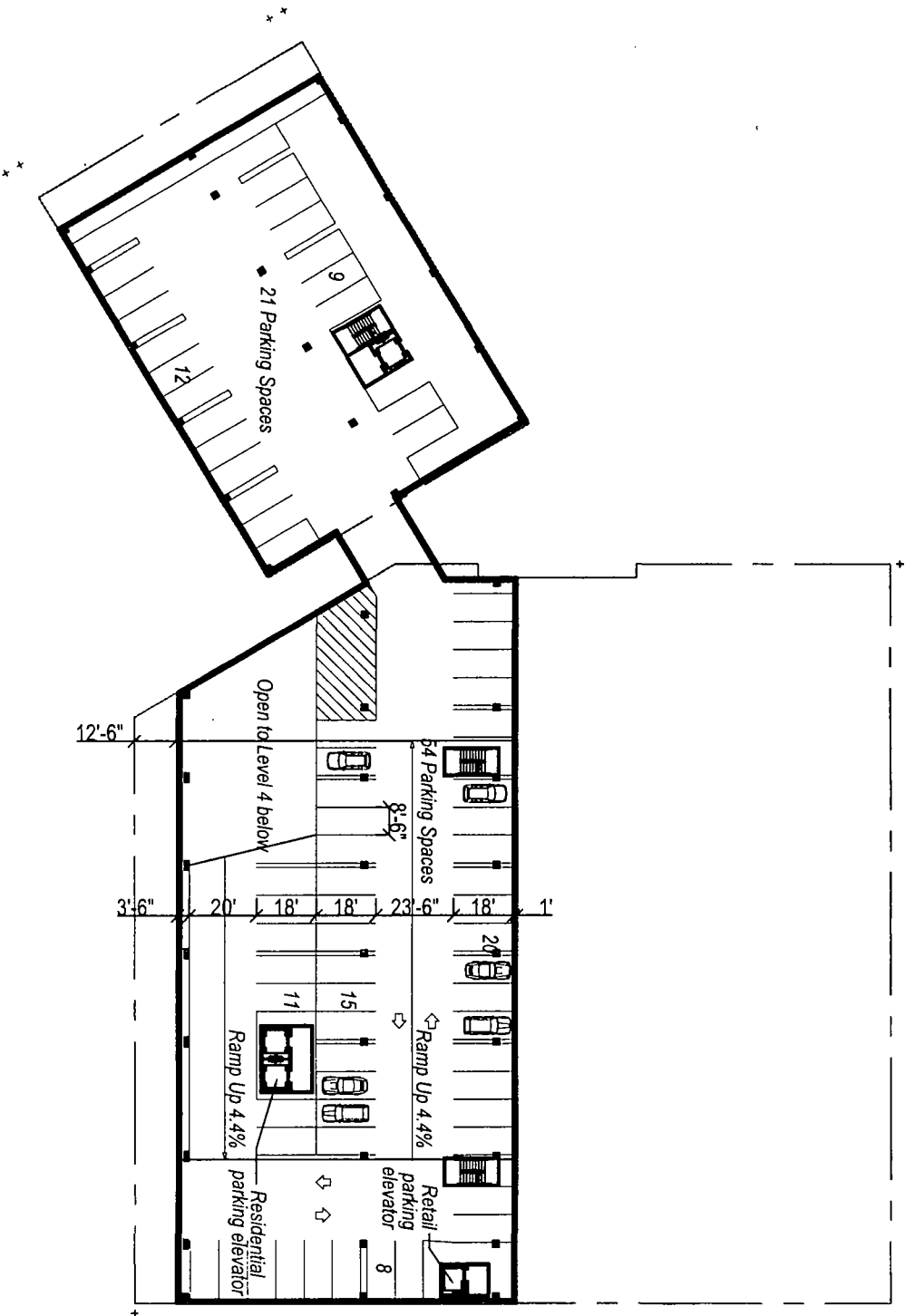

 LEVEL 5 PARKING PLAN - SUB-AREA A

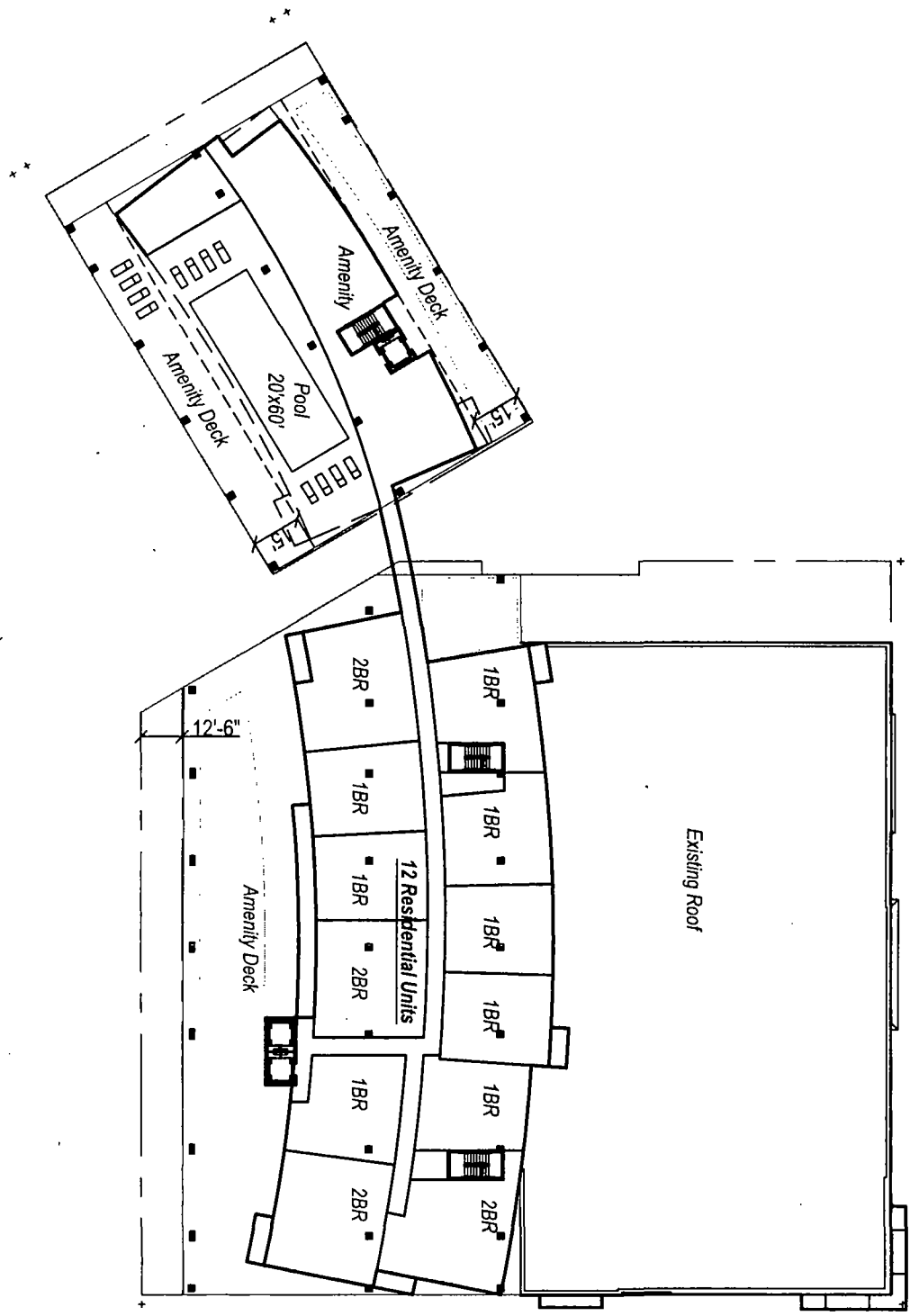

 LEVEL 6 - AMENITY DECK / RESIDENTIAL FLOOR PLAN - SUB-AREA A

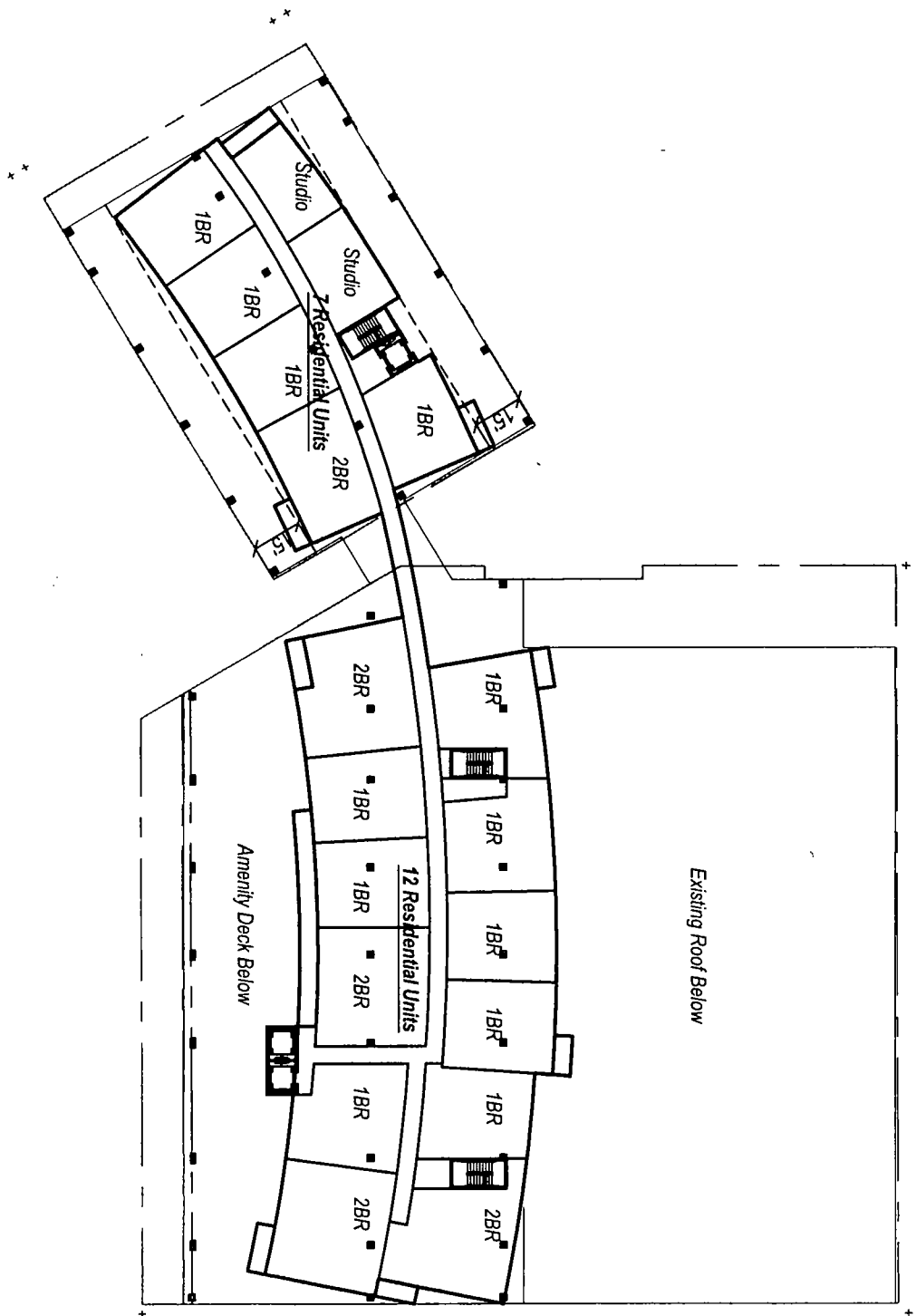

 TYPICAL RESIDENTIAL TOWER FLOOR PLAN - SUB-AREA A

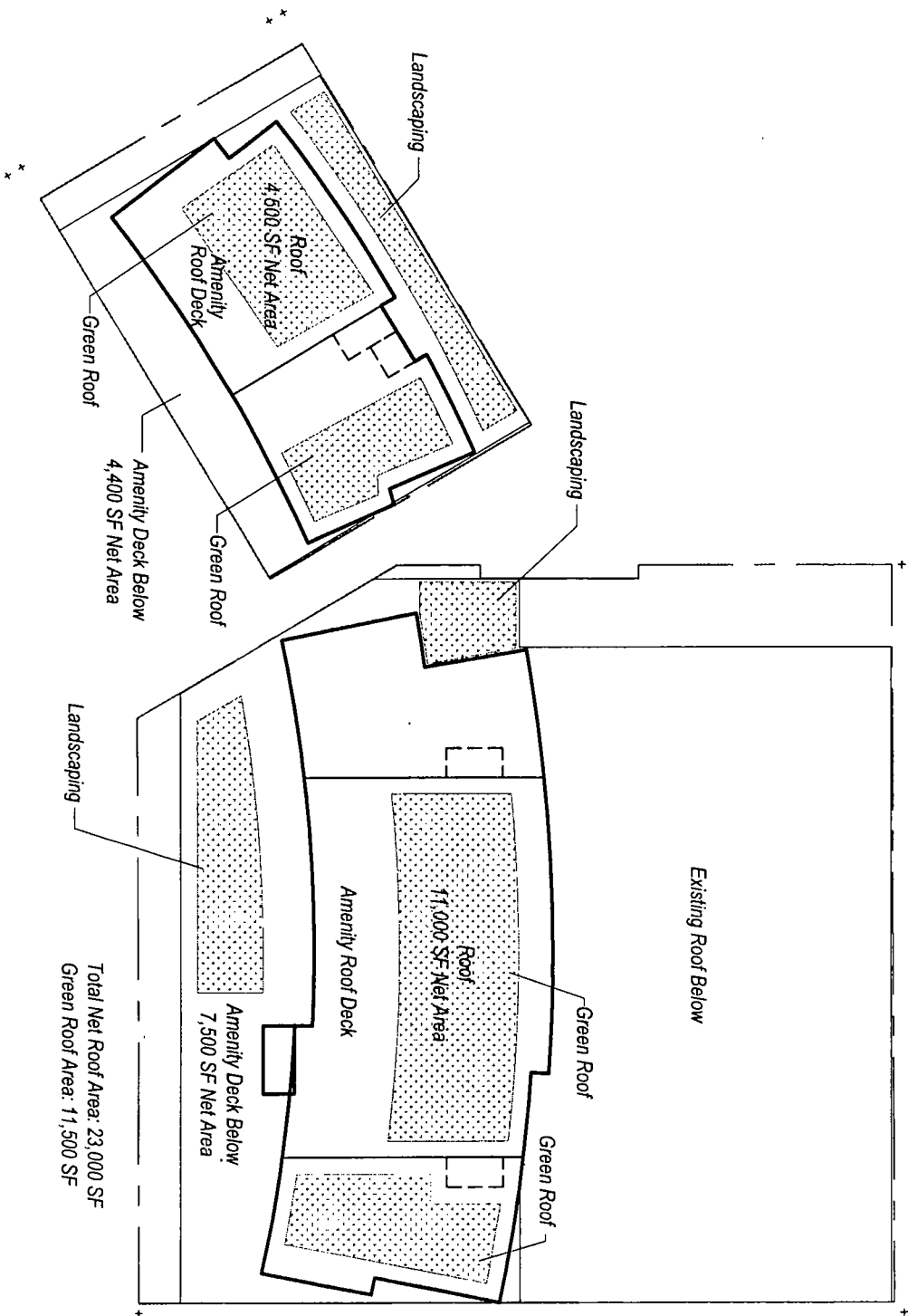

 GREEN ROOF PLAN - SUB-AREA A

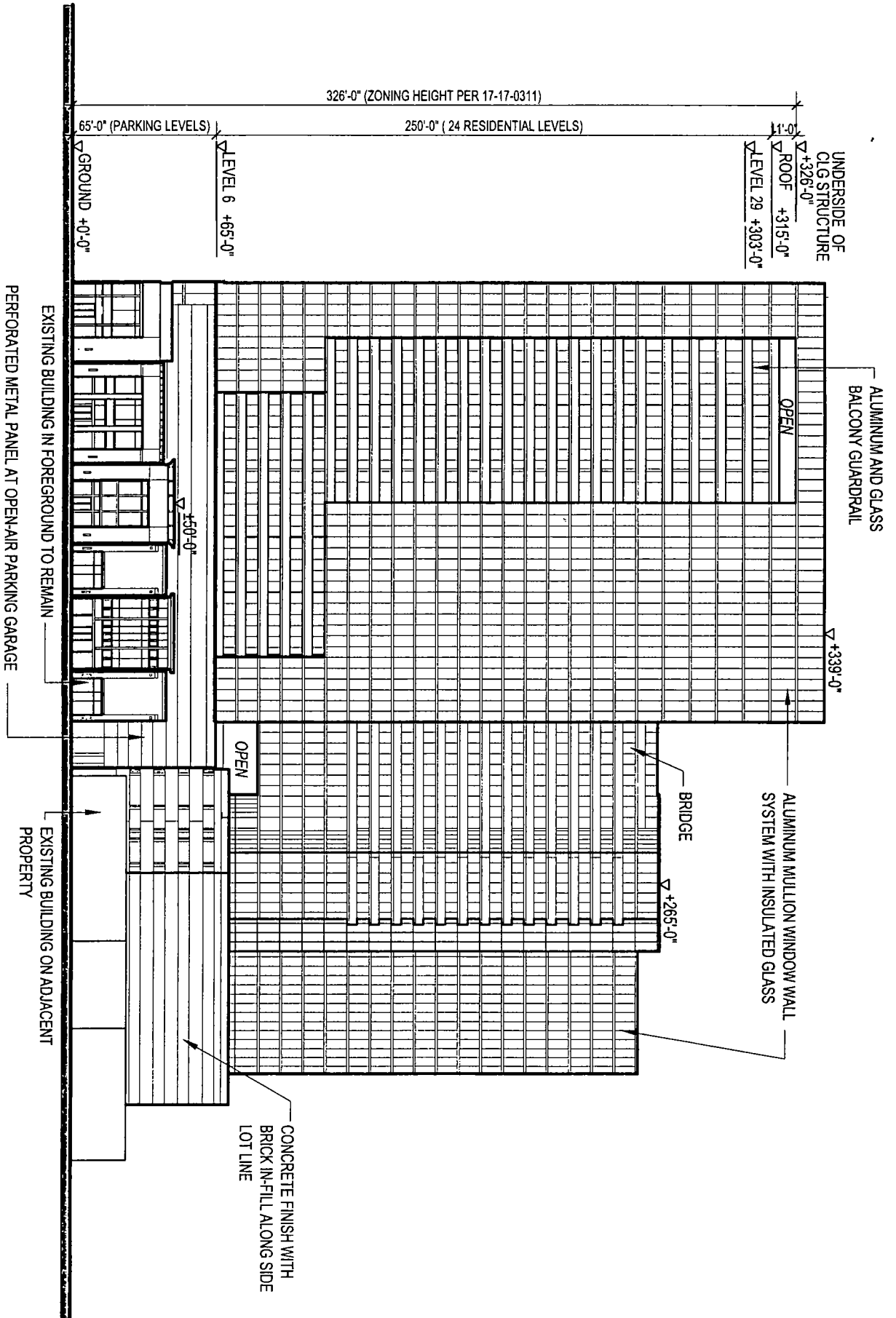

 NORTH BUILDING ELEVATION - WEED STREET - SUB-AREA A

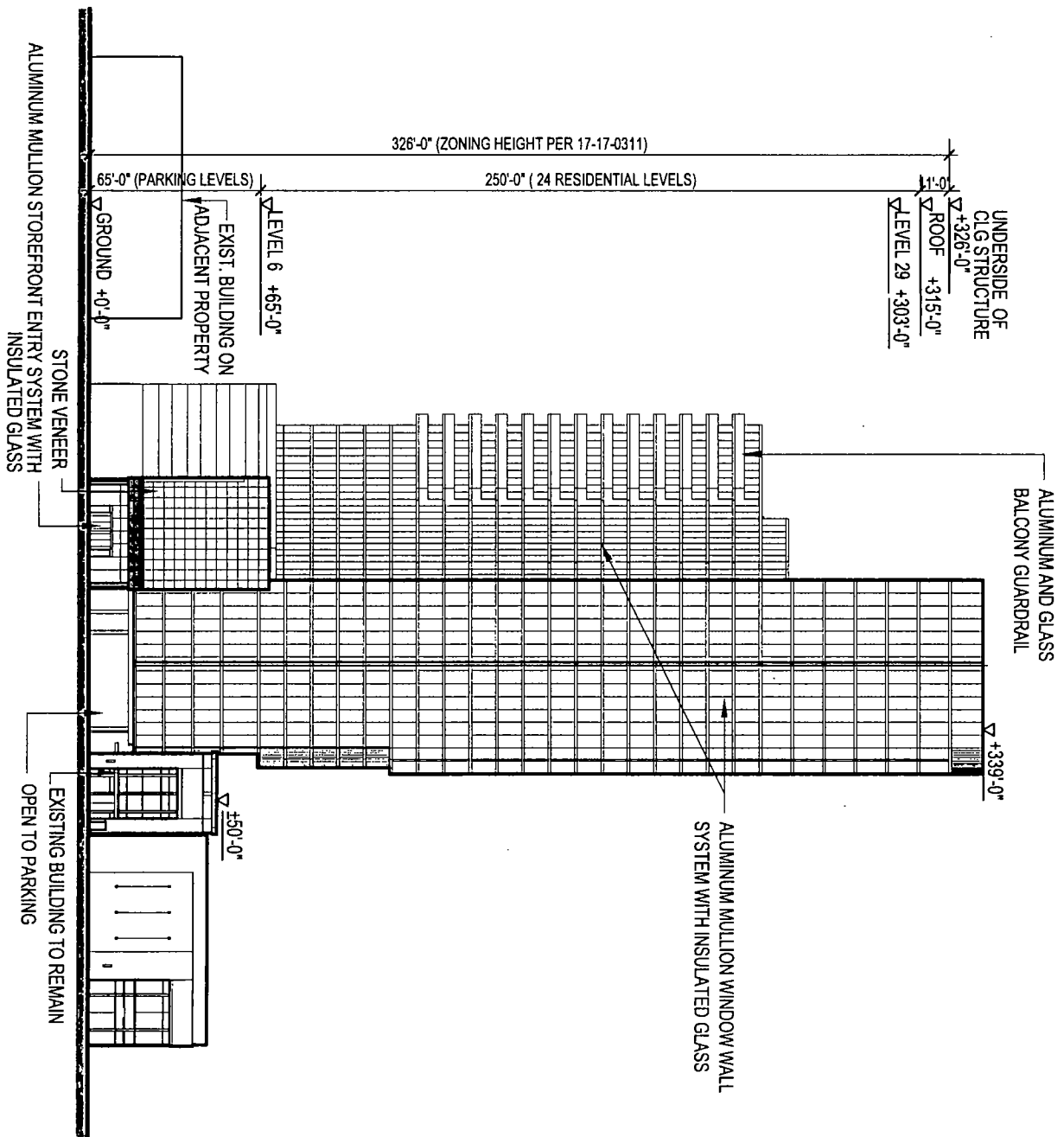

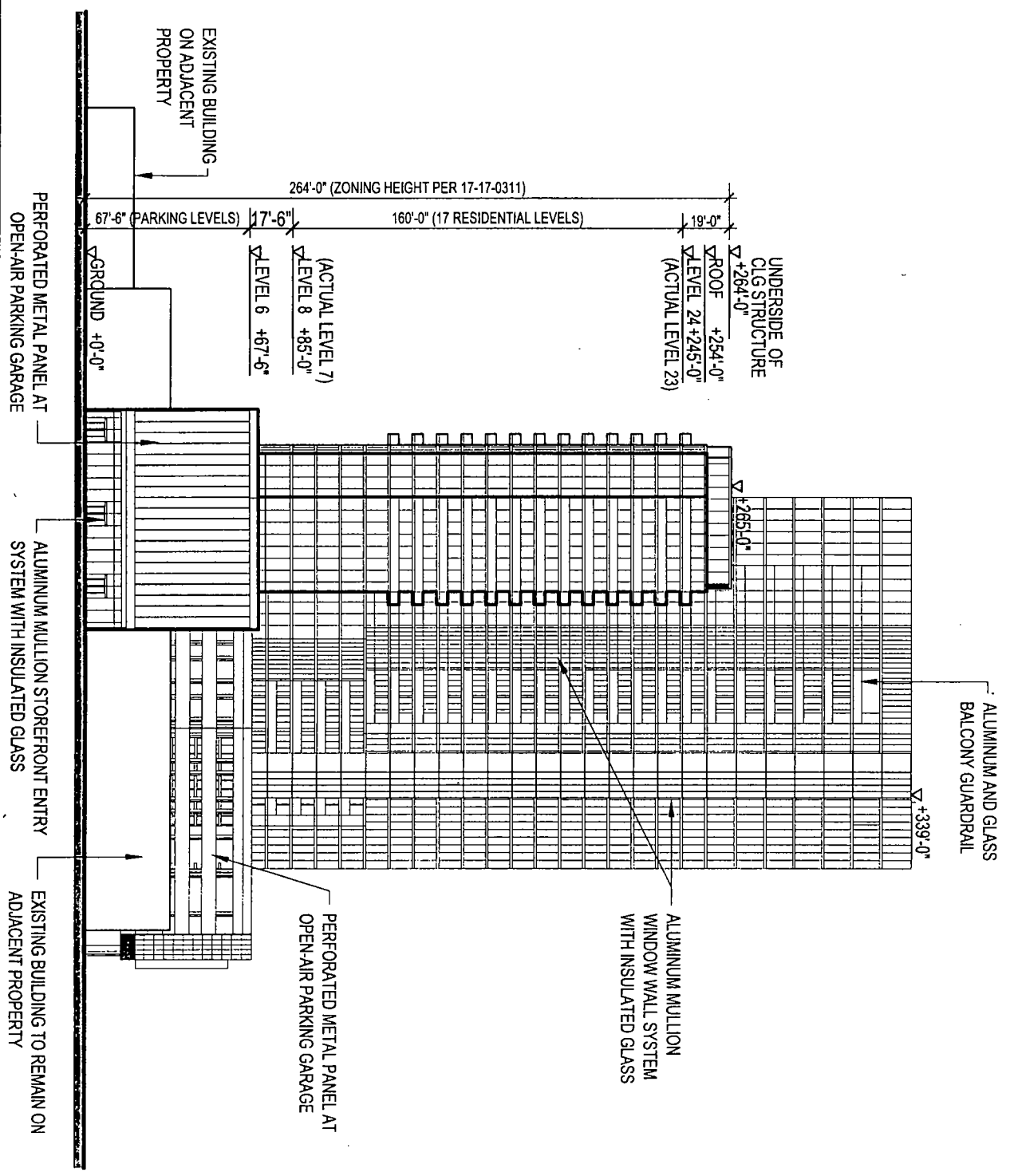

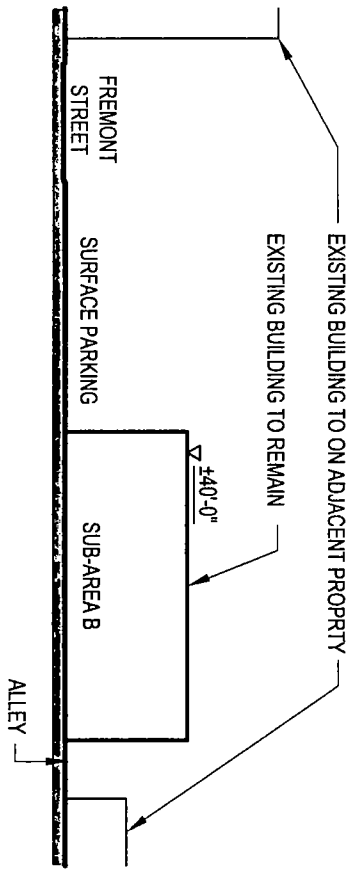

 WEST BUILDING ELEVATION - KINGSBURY STREET - SUB-AREA A



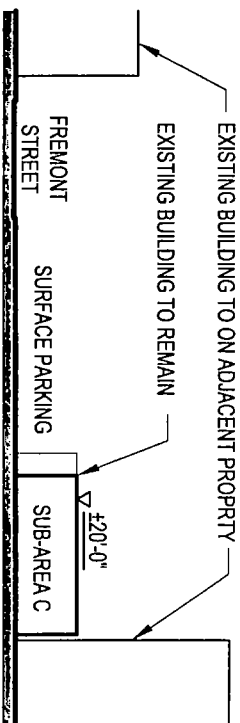

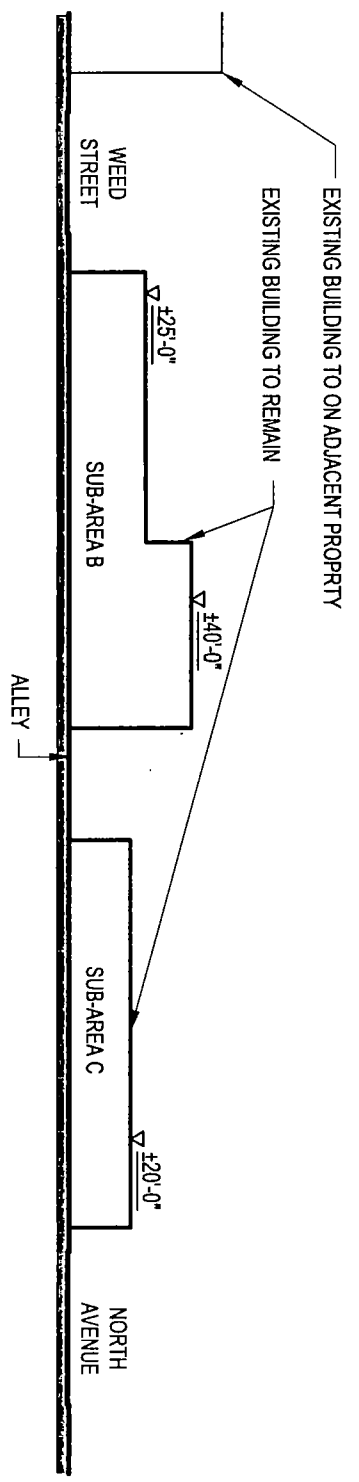

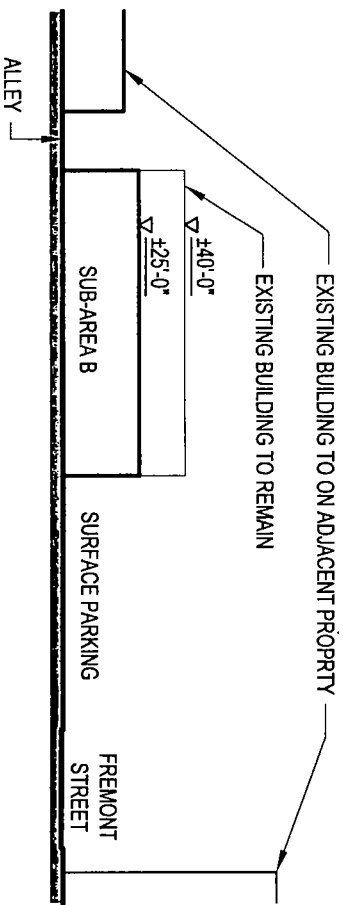

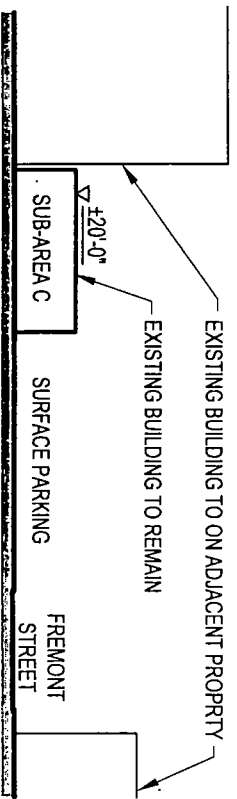

SOUTH BUILDING ELEVATION - SUB-AREA B



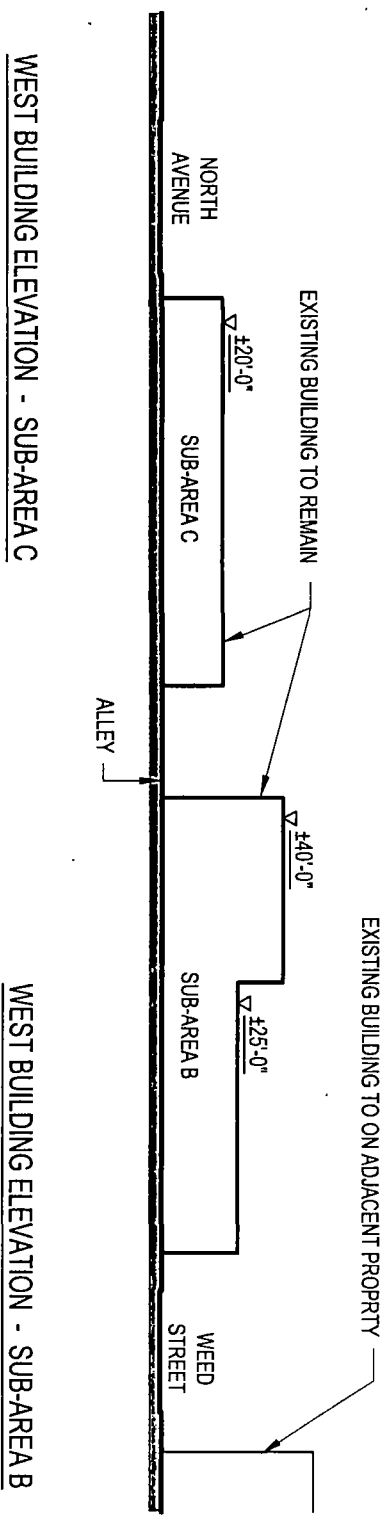
SOUTH BUILDING ELEVATION - SUB-AREA C
