**ORDINANCE**

***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

**SECTION 1.** Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the C1-2 Neighborhood Commercial District symbols and indications as shown on Map No.1-G in the area bounded by

the alley next south of and parallel to West Lake Street; North Aberdeen Street; the alley next north of and parallel to West Randolph Street; North May Street; a line 53.37 feet north of and parallel to the alley next north of and parallel to West Randolph Street; and a line 118.59 feet west of and parallel to North Aberdeen Street,

to those of a DX-5 Downtown Mixed-Use District and a corresponding use district is hereby established in the area above described.

**SECTION 2.** Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the DX-5 Downtown Mixed-Use District and Residential Business Planned Development Number 1283 symbols and indications as shown on Map No. 1-G in the area bounded by

West Lake Street; a line 125.85 feet east of and parallel to North Aberdeen Street; a line 228.55 feet south of and parallel to West Lake Street; North Aberdeen Street; the alley next north of and parallel to West Randolph Street; North May Street; a line 53.37 feet north of and parallel to the alley next north of and parallel to West Randolph Street; a line 118.59 feet west of and parallel to North Aberdeen Street; the alley next south of and parallel to West Lake Street; and North Aberdeen Street,

to those of a Residential-Business Planned Development Number 1283, as Amended which is hereby established in the area above described, subject to such use and bulk regulations as are set forth in this Plan of Development herewith attached and made a part and to no others.

**SECTION 3.** This ordinance shall be in force and effect from and after its passage and due publication.

**RESIDENTIAL-BUSINESS PLANNED DEVELOPMENT No. 1283  
AS AMENDED  
PLAN OF DEVELOPMENT STATEMENTS**

1. The area delineated herein as Residential Planned Development No. 1283 as Amended (the “Planned Development”) consists of approximately fifty-four thousand, eight hundred and eighty one (54,881) square feet or 1.26 acres of property which is depicted on the attached Planned Development Boundary and Property Line Map (the ‘Property’) and is owned or controlled by the Applicant, “MCZ Urban, LLC”.
2. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors. All rights granted hereunder to the applicant shall inure to the benefit of the Applicant’s successors and assigns and, if different than the Applicant, the legal title holder and any ground lessors. Furthermore, pursuant to the requirement of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time of application for amendments, modifications or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under ownership or designated control. Single designated control is defined in Section 17-8-0400.
3. All applicable official reviews, approvals or permits are required to be by the Applicant or its successors, assigns or grantees. Any dedications or vacations of Streets or alleys or grants of easements or any adjustment of the right-of-way shall require a separate submittal to the Department of Transportation on behalf of the Applicant or its successors, assigns or grantees.

Any requests for grants of privilege, or any items encroaching on the public way, shall be in compliance with the Planned Development.

Ingress or egress shall be pursuant to the Planned Development and may be subject to the review and approval of the Department of Planning and Development and Transportation. Closure of all or any public street or alley during demolition or construction shall be subject to the review and approval of the CDOT.

All work proposed in the public way must be designed and constructed in accordance with Department of Transportation Construction Standards for work in the Public way and in compliance with the Municipal code of Chicago. Prior to the Issuance of any Part II approval, the submitted plans must be approved by CDOT.

4. This Plan of Development consists of seventeen (17) Statements: a Bulk Regulations and Data Table; an Existing Zoning Map; a Planned Development Boundary and Property Line Map, an Existing Land-Use Map, Vicinity Map, Site Plan/Ground Floor Plan, Green Roof Plans, Building Section, East Building Elevation, South Building Elevation, West Building Elevation and North Building Elevation prepared by Solomon Cordwell Buenz Architects and dated May 24, 2017 submitted herein. In any instance where a provision of this planned Development conflicts with the Chicago Building Code, the Building Code shall control. This Planned Development conforms to the intent and purpose of the Zoning Ordinance, and all requirements thereto, and satisfies the established criteria for approval as a Planned Development. In case of a conflict between the terms of this Planned Development ordinance and the Zoning Ordinance, this Planned Development ordinance shall control.
5. The following uses are allowed in the area delineated herein as a Residential-Business Planned Development No. 1283 as Amended:
  - Sub-Area A: offices; retail sales, general; eating and drinking establishments (all including taverns); residential dwelling units located above the ground floor; accessory uses and accessory off-street parking and loading,
  - Sub-Area B: offices; retail uses, general; eating and drinking establishments (all including Taverns); personal services; sports and recreation, participant; dwelling units located above the ground floor; accessory uses and accessory off-street parking and loading.
6. On-premise signs and temporary signs such as construction and marketing signs shall be permitted within the Planned Development, subject to the review and approval of the Department of Planning and Development. Off-premise signs are prohibited within the boundary of the Planned Development.
7. For purposes of height of any measurement, the definitions in the Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations established by the Federal Aviation Administration.
8. The maximum permitted floor area ratio (FAR) for the Property shall be in accordance with the attached Bulk Regulations and Data Table. For the purposes of FAR calculations, the definition in the Zoning Ordinance shall apply. The permitted FAR identified in the Bulk Regulations and Data Table has been determined using a net site area of 54,881 square feet and a base FAR of 5.0. The improvements to be constructed on the Property will be subject to the following

Neighborhoods Opportunity Bonus Calculation:

Pursuant to Section 17-4-1003-C, prior to the issuance of the first building permit for any building or buildings within the Planned Development, the Neighborhoods Opportunity Fund floor area bonus payment, as further described in Statement 8 and Section 16-14-010, shall be paid in full, however, if the Planned Development is to be constructed in phases, the bonus shall be paid on a pro rat basis as the first building permit for each subsequent building or phase of construction is issued.

The Applicant, its successors or assigns, shall contribute the amount of One Million Eight Hundred and Forty-Six Thousand Two Hundred Fifty Six Dollars (\$ 1,846,256.00) to the City of Chicago prior to the issuance of the Part II Approval as follows: One Million Four Hundred Seventy Seven Thousand and Four Dollars (\$1,477.004) into the Neighborhood Opportunity Fund and One Hundred Eighty Four Thousand Six Hundred Twenty Five and 75/100 Dollars (\$184,625.75) into each of the Citywide Adopt-a-Landmark and Local Impact Fund. The amount of bonus floor area and corresponding payment may be modified prior to issuance of a building permit in accordance with Section 17-4-1003-C of the Zoning Ordinance, provided that the total FAR does not exceed the maximum FAR set forth in this Planned Development. The funds contributed pursuant to this Statement 8 shall be utilized as set forth in Section 17-4-1004 (Neighborhood Opportunity Fund), 17-4-1005 (Local Impact Bonus) and 17-4-1006 (Citywide Adopt-a-Landmark) of the Chicago Zoning

Ordinance. The Applicant's obligations pursuant to this Statement 8 shall be fully satisfied upon payment of the amounts set forth herein.

9. The Applicant acknowledges and agrees that the rezoning of a property from C1-2 Neighborhood Commercial District to DX-5 Downtown Mixed-Use District and that this amendment to Residential-Business Planned Development Number 1283 triggers the 2015 requirements of Section 2-45-115 of the Municipal Code of Chicago (2015 ARO) with respect to the additional 235 units being added by this amendment. Pursuant to the ARO and the Affordable housing Profile Form attached hereto as Exhibit A, the Applicant agreed to provide 24 affordable housing units in addition to the 8 affordable housing units in the Residential Project for households earning up to 60% of the Chicago Primary Metropolitan Statistical Area median income (the "Affordable Units"). If the Applicant subsequently reduces (or increases) the number of housing in the PD, or elects to build a for-sale project instead, the Applicant shall update and resubmit the Affordable Housing Profile Form to DPD for review and approval; DPD may adjust the requirements and number of required Affordable Units without amending the PD. Prior to the issuance of any building permits for any residential building in the PD, including, without limitation, excavation or foundation permits, the Applicant must make the required cash payment and/or execute and record an affordable housing agreement in accordance with Section 2-45-115(L). The terms of the affordable housing agreement and any amendments thereto are incorporated herein by this reference. The Applicant acknowledges and agrees that the affordable housing agreement will be recorded against the PD, or the applicable portion thereof, and will constitute a lien against such property. The Commissioner of DPD may enforce remedies for any breach of this Statement 9, including any breach of any affordable housing agreement, and enter into settlement agreements with respect to any such breach, subject to the approval of the Corporation Council, without amending the PD.
10. Upon review and determination, Part II Review, pursuant to section 17-13-0610, a Part II Review fee shall be assessed by the Department of Planning and Development. The fee, as determined by staff at the time, is final and binding on the Applicant and must be paid to the Department of Revenue prior to the issuance of any Part II Approval.

11. The Site Plan and Landscape Plans shall be in substantial conformance with the Landscape Ordinance and any other corresponding regulations and guidelines. Final landscape plan and approval will be by the Department of Planning and Development. Any interim reviews associated with site plan review or Part II Reviews, are conditional until final Part II Approval.
12. The terms and conditions of development under this Planned Development ordinance may be modified administratively, pursuant to Section 17-13-0611-A, by the Zoning Administrator upon the application for such modification by the Applicant, its successors and assigns and, if different than the Applicant, the legal titleholders and any ground lessors.
13. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enables and maximizes universal access throughout the Property. Plans for all buildings and improvements on the Property shall be reviewed and approved by the Mayor's Office for People with Disabilities to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.
14. The Applicant shall comply with Rules and Regulations for the Maintenance of Stock-Piles Promulgated by the Commissioner of Street and Sanitation, Fleet and the Facility Management and buildings of the Environment and the Commissioner of Buildings, under Section 13-32- 125 of the Municipal Code of Chicago or any other provision of the Municipal Code of Chicago.
15. The Applicant acknowledges that is in the public interest to design, construct, renovate and maintain all buildings in a manner that provides healthier indoor environments, reduces operating costs and conserves energy and natural resources. The project will be in substantial compliance with the current City of Chicago Sustainable Development policy set forth by the DPD. The proposed buildings shall provide vegetated ("Green") roofs totaling a minimum of 50 % of the net roof areas or 22,203 square feet and obtain Building Certification.
16. The Plans are hereby approved in their entirety and no further approvals shall be required under this Planned Development or the Zoning Ordinance for the improvements undertaken in accordance with the Plans, other than Part II approvals (per Section 17-13-010 of the Zoning Ordinance). Applicant and DPD, at either party's request may continue to evolve the design of the building elevations or materials

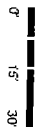
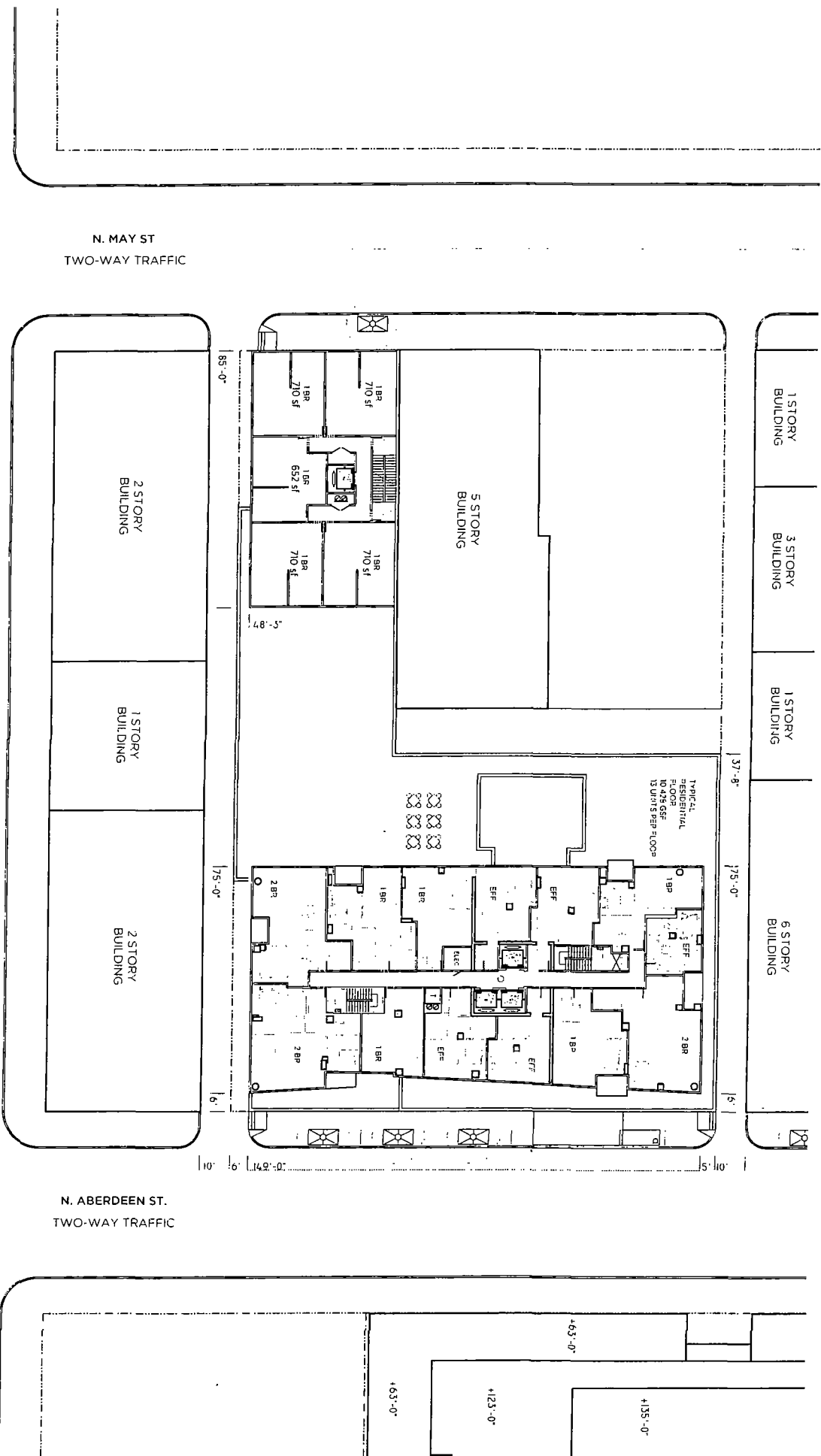
**RESIDENTIAL FLOOR PLAN**

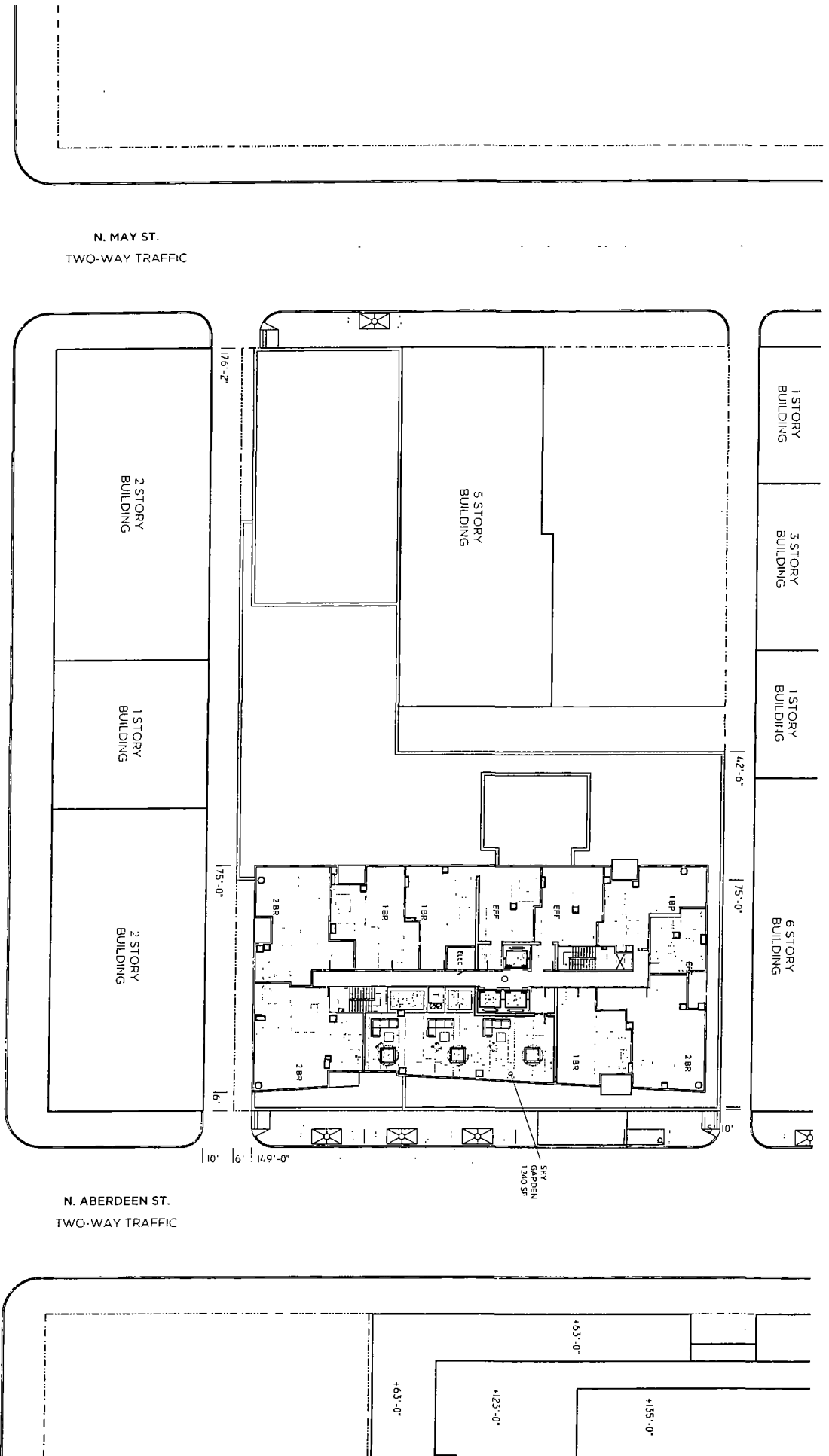

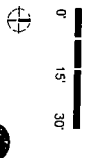
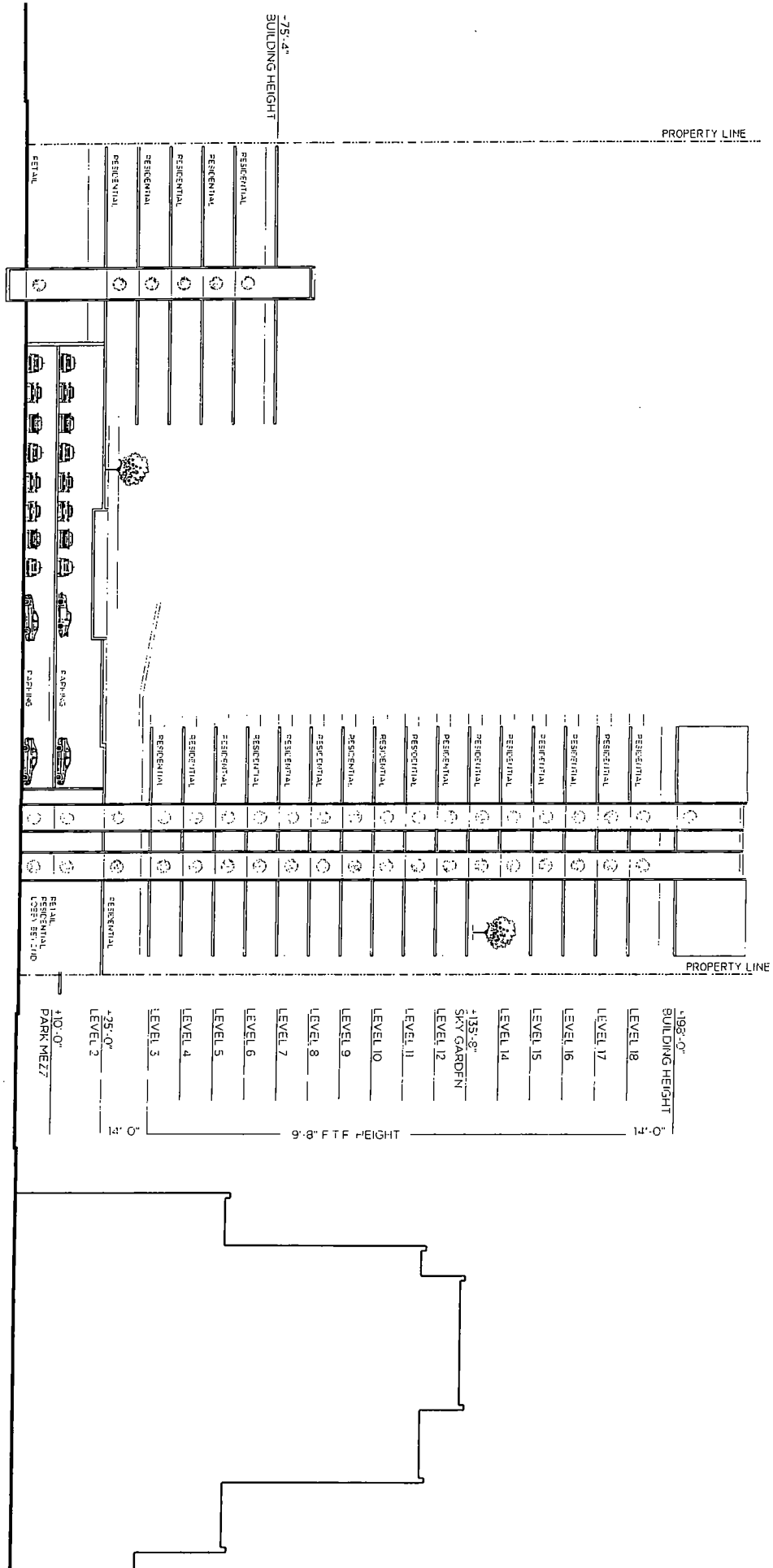
# SKY GARDEN FLOOR PLAN
