Be It Ordained by the City Council of the City of Chicago:

Permission and authority are hereby given and granted to ARGO TEA upon the terms and subject to the conditions of this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent to its premises located at 140 S. Dearborn St.. Said sidewalk cafe area #1 shall be sixteen point six seven (16.67) feet in length and five point two five (5.25) feet in width, area #2 shall be fifteen (15) feet in length and six point eight three (6.83) feet in width for a total of one hundred eighty-nine point nine seven (189.97) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along Adams. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Sunday through Saturday 8:00am until 11:00pm
Compensation: \$600.00
SEATING CAPACITY: 18

Sidewalk Cafe Permit and approved plan must be posted at all times.


* Sidewalk Cafes shall not operate earlier than 8:00 AM, nor later than 11:00 PM.

This grant of privilege #1095533 for a sidewalk cafe shall be subject to the provisions of Section 10-28-900 through 10-28-995 of the Municipal Code of Chicago and the directions of the Commissioner of Department of Business Affairs and Consumer Protection, the Commissioner of Streets and Sanitation, and the Commissioner of Transportation.

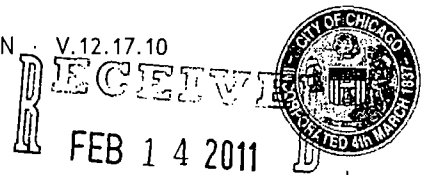
