the alley next north of and parallel to West George Street; a line 227.5 feet west of and parallel to North Mildred Avenue; West George Street; a line 277.50 feet west of and parallel to North Mildred Avenue;

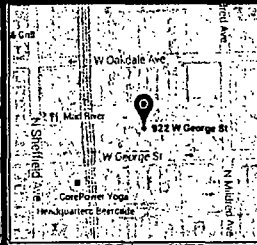
to those of the RM-5 Residential Multi-Unit District and a corresponding use district is hereby established in the area above described.

Remedies at law for a false statement of material fact may include incarceration and an award to the City of treble damages.


