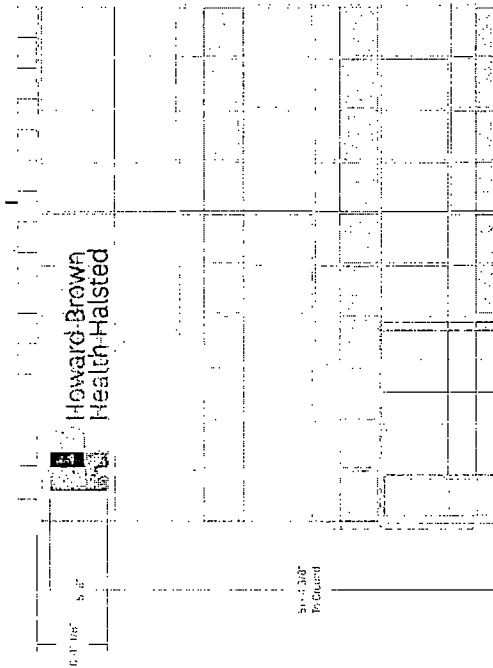

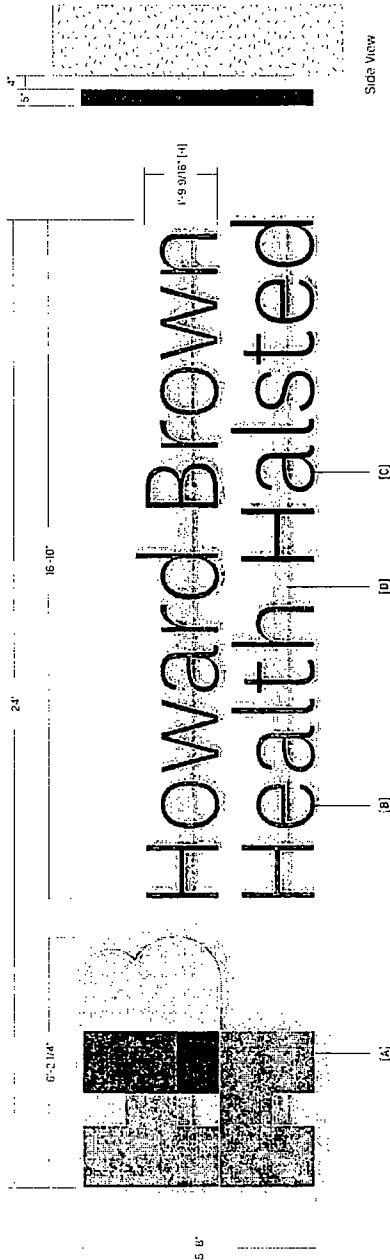

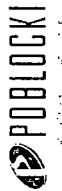
Proposed Day View - 3/32" = 1'

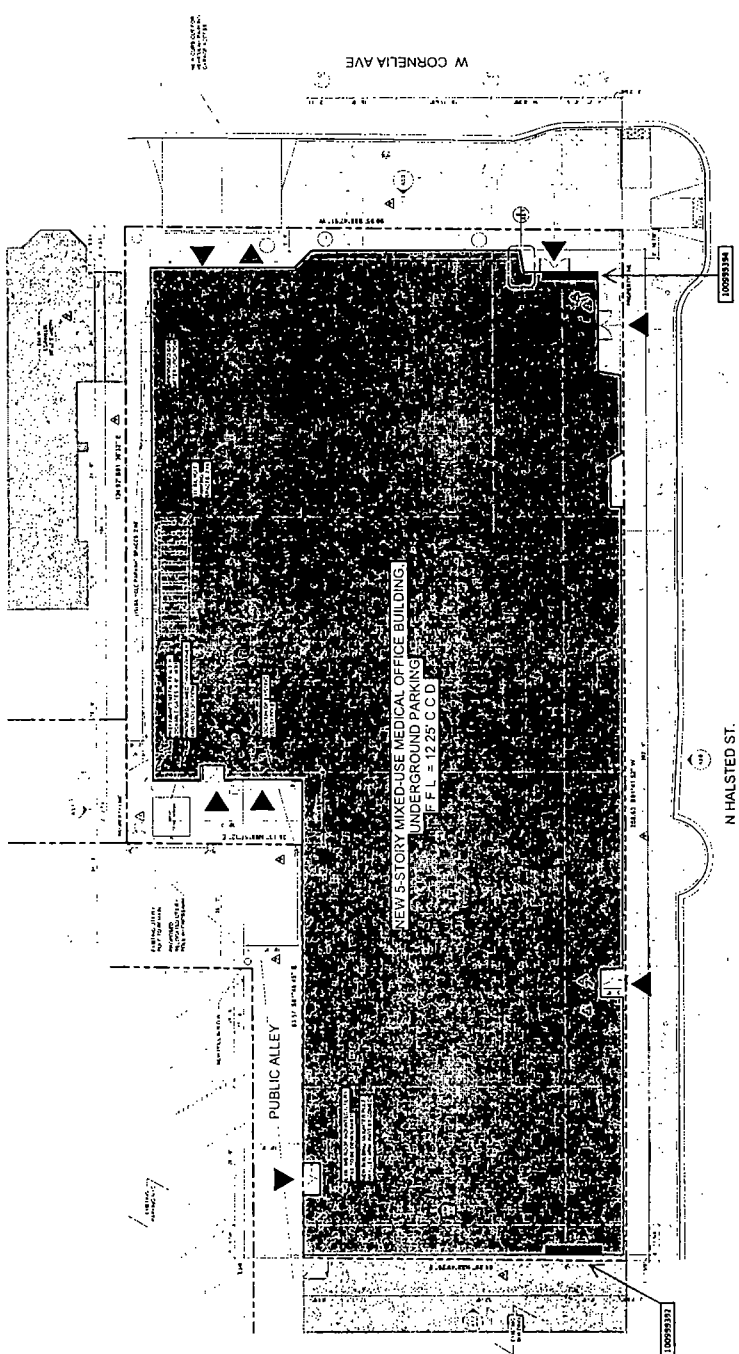
