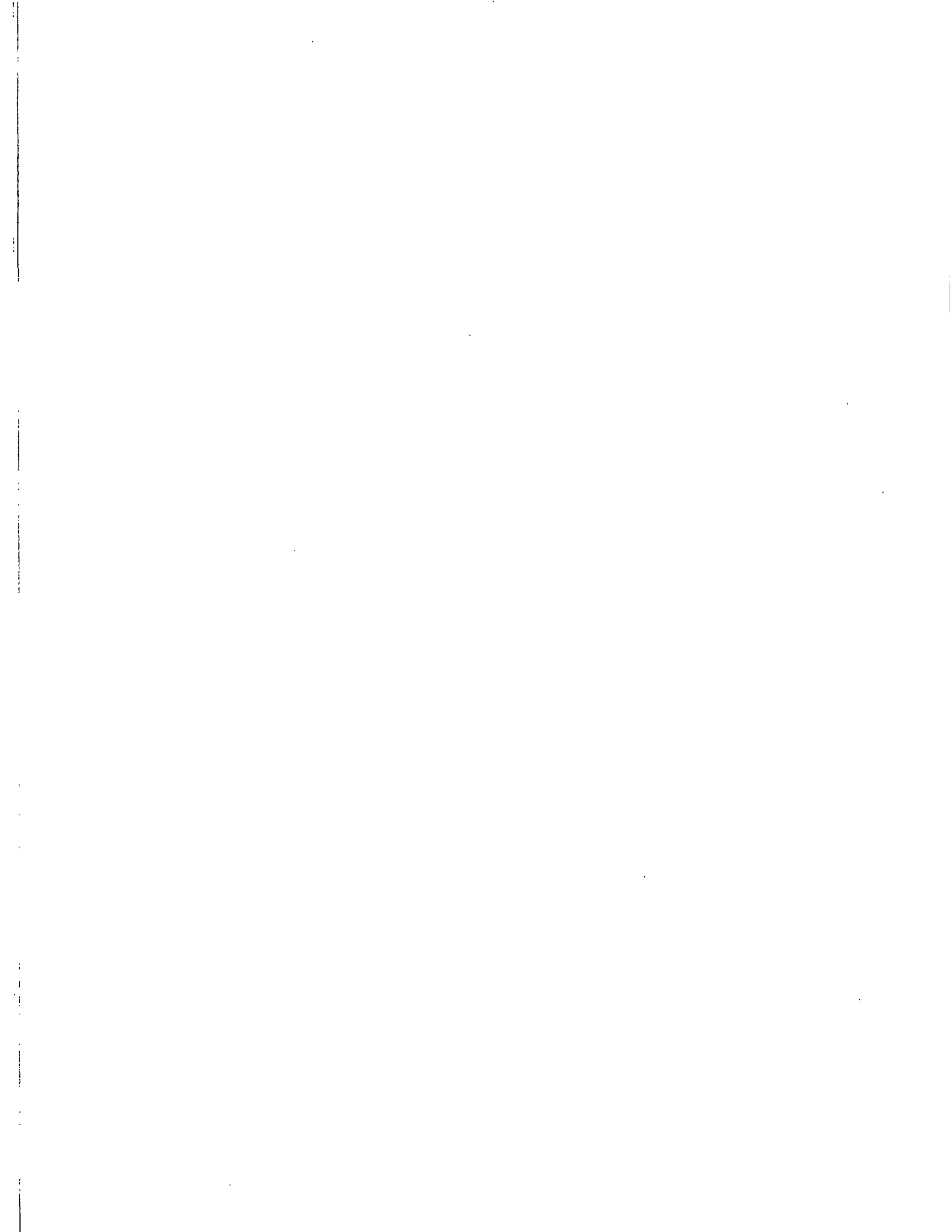


The undersigned, Nicholas Ftikas, being first duly sworn on oath, deposes and says the following:
