BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3, Residential Single-Unit (Detached House) District symbols as shown on Map No. 13-H in the area bounded by:

West Winona Street; a line 141.33 feet West of and parallel to North Leavitt Street; the public alley next South of and parallel to West Winona Street; a line 171.33 feet West of and parallel to North Leavitt Street.

To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and approval.
