BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

The alley next West of and parallel to South Lituanica Avenue; a line 25 feet South of and parallel to West 31st Place; South Lituanica Avenue; a line 75 feet South of and parallel to West 31st Place

to those of an RM6 Residential Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and due publication.

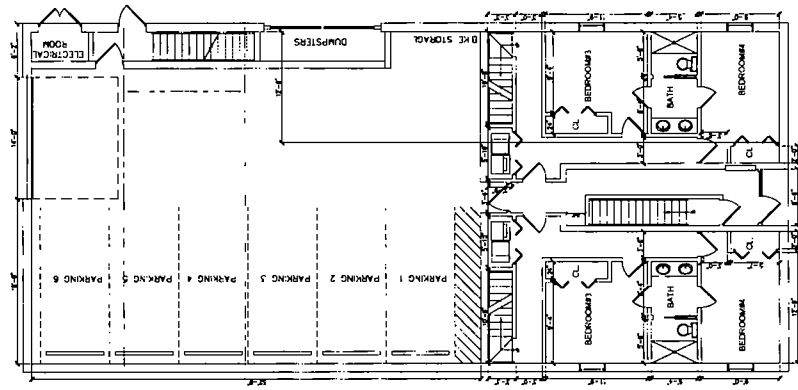




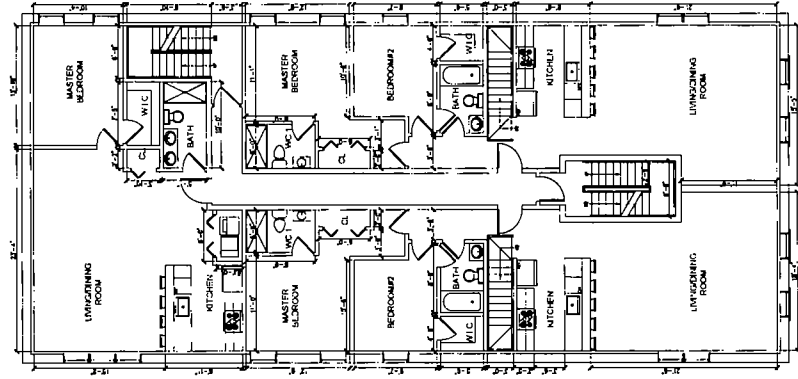
① 1ST FLOOR LEVEL- EXISTING

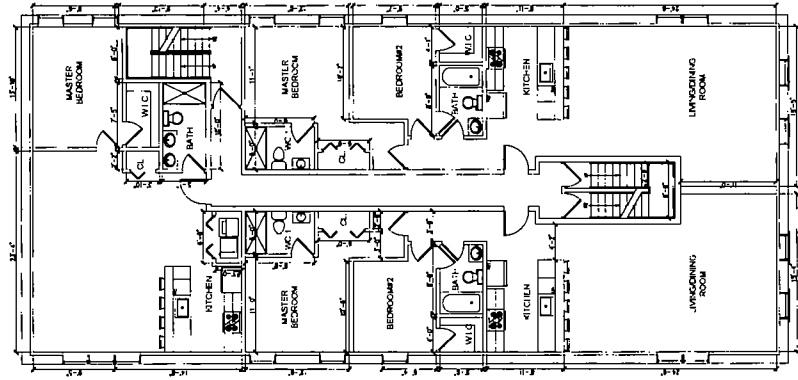

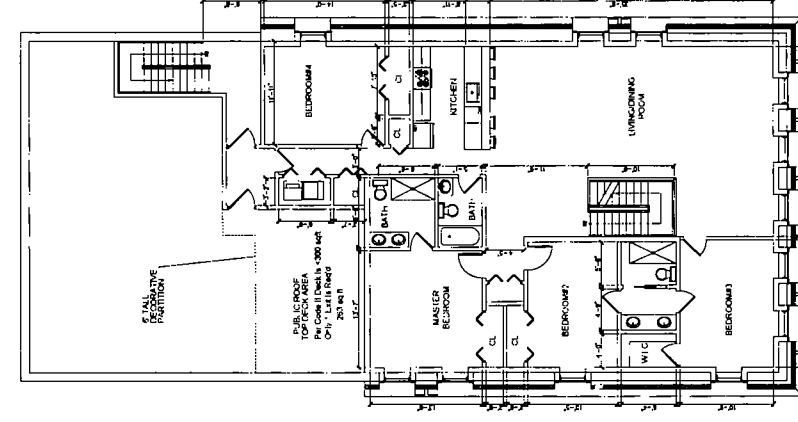

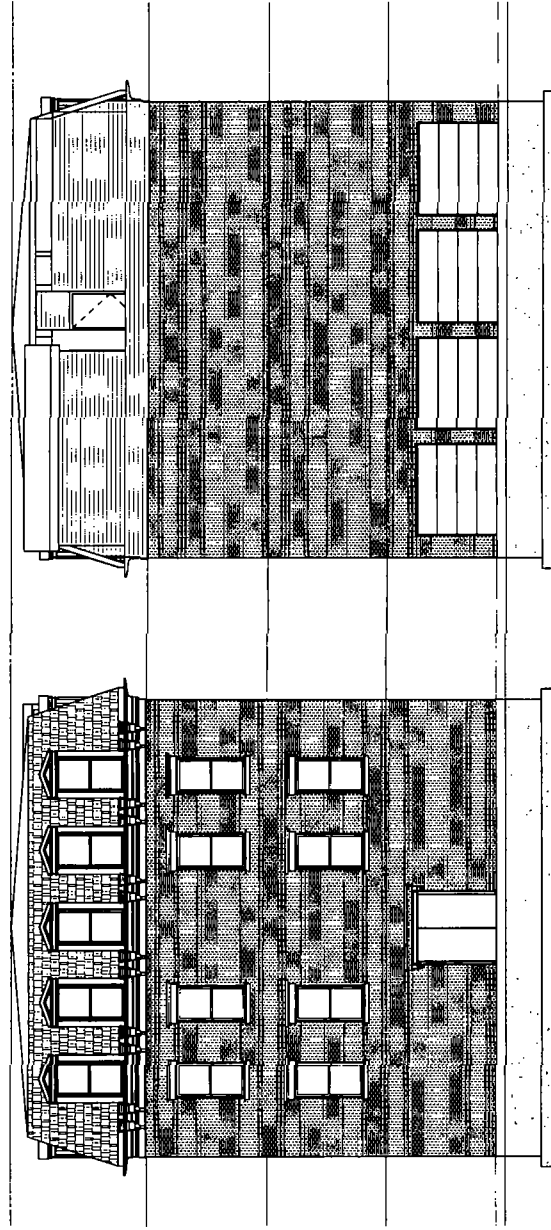
