WILLIAM JONES COLLEGE PREPARATORY HIGH SCHOOL

Acct. No. 302602 - 27 Permit No. 1095333

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to WILLIAM JONES COLLEGE PREPARATORY HIGH SCHOOL, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use fourteen (14) Caisson(s) under the public right-of-way adjacent to its premises known as 700 S. State St...

Said Caisson(s) at S. State measure(s):

One (1) at one (1) foot in length, and twenty-one point two four (21.24) feet in width for a total of twenty-one point two four (21.24) square feet.

Said Caisson(s) at S. State measure(s):

One (1) at one (1) foot in length, and twenty-four point three five (24.35) feet in width for a total of twenty-four point three five (24.35) square feet.

Said Caisson(s) at S. State measure(s):

One (1) at one (1) foot in length, and twenty-one point two four (21.24) feet in width for a total of twenty-one point two four (21.24) square feet.

Said Caisson(s) at S. State measure(s):

Two (2) at one (1) foot in length, and eighteen point three three (18.33) feet in width for a total of thirty-six point six six (36.66) square feet.

Said Caisson(s) at S. State measure(s):

One (1) at one (1) foot in length, and fifteen point six two (15.62) feet in width for a total of fifteen point six two (15.62) square feet.

Said Caisson(s) at S. State measure(s):

One (1) at one (1) foot in length, and ten point eight one (10.81) feet in width for a total of ten point eight one (10.81) square feet.

Said Caisson(s) at S. State measure(s):

One (1) at one (1) foot in length, and thirteen point one two (13.12) feet in width for a total of thirteen point one two (13.12) square feeL

Said Caisson(s) at S. State measure(s):

One (1) at one (1) foot in length, and thirteen point one one (13.11) feet in width for a total of thirteen point one one (13.11) square feet.

Said Caisson(s) at S. State measure(s):

Two (2) at one (1) foot in length, and twenty-four point three four (24.34) feet in width for a total of forty-eight point six eight (48.68) square feet.

Said Caisson(s) at S. State measure(s):

One (1) at one (1) foot in length, and twenty-seven point six three (27.63) feet in width for a total of twenty-seven point six three (27.63) square feet.

Said Caisson(s) at S. State measure(s):

One (1) at one (1) foot in length, and fifteen point six (15.6) feet in width for a total of fifteen point six (15.6) square feet.

Said Caisson(s) at S. State measure(s):

One (1) at one (1) foot in length, and eight point six nine (8.69) feet in width for a total of eight point six nine (8.69) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1095333 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.
