SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the RS-3 Residential Single-Unit (Detached House)

District symbols and indications as shown on Map No.1-H in the area bounded by

West Huron Street; a line 168 feet east of and parallel to North Paulina Street; the alley next south of and parallel to West Huron Street; and a line 144 feet east of and parallel to North Paulina Street,

to those of a RM-5 Residential Multi-Unit District and a corresponding use district is hereby established in the area above described.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.
