SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Residential/Commercial Planned Development 1006 District symbols and indications as shown on Map No. 3-F in the area bounded by

West Elm Street; North Cleveland Avenue; West Oak Street; North Cambridge Avenue,

to those of a DR-3 Downtown Residential District.

SECTION 2. This ordinance takes effect after its passage and due publication.








In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about July 20, 2022, the undersigned will file an application for a change in zoning from Residential/Commercial Planned Development 1006 to DR-3 Downtown Residential District, on behalf of Parkside Associates, LLC, an Illinois limited liability company for the property located at 501-521 West Elm Street; 500-520 West Hobbie Street; 501-521 West Hobbie Street; 500-520 West Oak Street; 1001-1135 North Cambridge Avenue; 1000-1134 North Cleveland Avenue and described as follows:

West Elm Street; North Cleveland Avenue; West Oak Street; North Cambridge Avenue.

PD 1006 is an existing planned development located on 8 contiguous blocks. The purpose of the amendment is to remove two of the blocks from the planned development. Those blocks are referred to as Block 6 and Block 8 in the planned development and are bounded by West Elm Street, North Cleveland Avenue, West Oak Street and North Cambridge Avenue. The remaining blocks in PD 1006 are developed, except from a portion of Blocks 1 and 7. The undeveloped portions of Blocks 1 and 7 will be designated as new subareas for future residential development.
