West Cermak Rd; the Alley next west of and parallel to South Pulaski Rd; The Alley next south of and parallel to West Cermak Rd; and a line 186 feet west of and parallel to south Pulaski Rd.


to those of a **B-1-1** Neighborhood Shopping District.

Plat of Survey


