## **ORDINANCE**

***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

***SECTION 1.*** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS-3 Residential Single-Unit (Detached House) District and C2-2 Motor Vehicle-Related Commercial District symbols and indications as shown on Map No.1-H in the area bounded by

West Ohio Street; North Paulina Street; a line 72 feet south of and parallel to West Ohio Street; and the alley next west of and parallel to North Paulina Street,

to those of a B2-2 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area above described.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage and due publication.



13. Applicant will establish a new zoning lot on the north 48 feet which will contain four dwelling units, one below the second floor. The building will contain an open Stairwell and a four-story enclosed elevator and a fifth level enclosed roof access stairway. Four outdoor parking spaces will be provided. The existing building height will not change except for the access stairwell, which will be 56.4 feet in height measured from grade. The footprint of the existing building and the height will not change. The east, north and west set back are currently 0 feet and will remain 0 feet. The south set back will be 16 feet.

The south 24 feet will be improved with a new two-story single family home 30 feet in height with a two-car detached garage. The north and south set backs will be three feet. The east front set back will be 5.3 feet. The rear west set back will be 32 feet 6 inches.

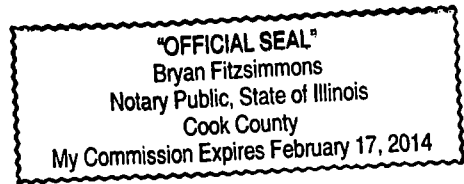
