**AMENDMENTS TO CHAPTER 10-28 OF THE MUNICIPAL CODE OF CHICAGO**

An ordinance amending Chapter 10-28 of the Municipal Code of Chicago concerning the operation of an Indoor Retail Market regarding a sidewalk cafe selling alcoholic beverages must be validly licensed under the code for such sales; the retail food establishment serving the alcoholic beverage must maintain its liquor liability (dramshop) insurance when serving the alcoholic beverages; and the alcoholic beverages must be served in plastic cups which shall clearly identify the retail food establishment from which each alcoholic beverage was purchased.
