**ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1: Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all the DX-16 Downtown Mixed-Use District symbols and indications as shown on Map No. 1-E in an area bounded by:

A line 166.30 feet north of and parallel to East Lake Street; North Michigan Avenue; East Lake Street; North Garland Court

to the designation of Residential Business Planned Development No. \_\_\_\_\_ which is hereby established in the area above described, subject to such use and bulk regulations as are set forth in the Plan of Development herewith attached and made a part thereof and to no others.

SECTION 2: This Ordinance shall be in force and effect from after its passage and due publication.

RESIDENTIAL BUSINESS PLANNED DEVELOPMENT NO. \_\_\_\_\_  
PLAN OF DEVELOPMENT STATEMENTS

1. The area delineated herein as Residential Business Planned Development No. \_\_\_\_\_ consists of approximately 21,706 square feet of property which is depicted on the attached Planned Development Boundary and Property Line Map (“Property”) and is owned or controlled by the Applicant, 200 North Michigan Owner LLC.
2. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors. All rights granted hereunder to the Applicant shall inure to the benefit of the Applicant’s successors and assigns and, if different than the Applicant, the legal title holder and any ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time applications for amendments, modifications or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under single ownership or under single designated control. Single designated control is defined in Section 17-8-0400 of the Zoning Ordinance.
3. All applicable official reviews, approvals or permits are required to be obtained by the Applicant or its successors, assignees, or grantees. Any dedication or vacation of streets or alleys, or grants of easements, or adjustments of right-of-way, shall require a separate submittal to the Department of Transportation on behalf of the Applicant or its successors, assignees, or grantees and approval by the City Council.

Any requests for grants of privilege, or any items encroaching on the public way, shall be in compliance with the Plans.

Ingress or egress shall be pursuant to the Plans and may be subject to the review and approval of the Departments of Housing and Economic Development and Transportation.

Closure of all or any public street or alley during demolition or construction shall be subject to the review and approval of the Department of Transportation.

All work proposed in the public way must be designed and constructed in accordance with the Department of Transportation Construction Standards for Work in the Public Way and in compliance with the Municipal Code of the City of Chicago. Prior to the issuance of any Part II approval, the submitted plans must be approved by the Department of Transportation.

4. This Plan of Development consists of these seventeen (17) Statements; a Bulk Regulations and Data Table; an FAR Bonus Calculation Worksheet; an Existing Zoning Map; a General Land Use Map; a Planned Development Boundary and Property Line Map; an Existing Site Plan; a Site Plan; a Lower Level 1 Plan; Level 3 Parking Plan; Level 4 Parking Plan; Level 5 Parking Plan; Level 5.5 Parking Plan; a Landscape and Green Roof Plan; East, South, West and North Building Elevations; Garland Street/West Podium Elevation; Exhibits depicting bonus for Parking Concealed by Occupiable Spaces; Exhibit depicting bonus for Upper Level Setback prepared by bKL Architecture LLC dated December 19, 2013. Full-size copies of the Site Plan, Landscape Plan and Building Elevations are on file with the Department of Housing and Economic Development. In any instance where a provision of this Planned Development conflicts with the Chicago Building Code, the Building Code shall control. This Planned

Development conforms to the intent and purpose of the Zoning Ordinance, and all requirements thereto, and satisfies the established criteria for approval as a Planned Development. In case of a conflict between the terms of this Planned Development Ordinance and the Zoning Ordinance, this Planned Development Ordinance shall control.

5. The following uses shall be allowed within the area herein delineated as Residential Business Planned Development: all uses permitted in the DX-16 Downtown Mixed-Use District Residential Use Group and Commercial Use Group (except Bed and Breakfast, Hotel/Motel, Non-Accessory Parking, Residential Storage Warehouse, and the Vehicle Sales and Service Use Category), related and accessory uses, and accessory parking.
6. On-Premise signs and temporary signs, such as construction and marketing signs, shall be permitted within the Planned Development, subject to the review and approval of the Department of Housing and Economic Development. Off-Premise signs are prohibited within the boundary of the Planned Development.
7. For purposes of height measurement, the definitions in the Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations, if any, established by the Federal Aviation Administration.
8. The maximum permitted Floor Area Ratio ("FAR") for the site shall be in accordance with the attached Bulk Regulations and Data Table. For the purposes of FAR calculations and measurements, the definitions in the Zoning Ordinance shall apply. The permitted FAR identified in the Bulk Regulations and Data Table has been determined using a Net Site Area of 21,706 square feet.

The required three (3) 10' x 25' loading spaces may be located in Lower North Michigan Avenue subject to a Grant of Privilege approved by the City Council.

9. Upon review and determination, "Part II Review", pursuant to Section 17-13-0610 of the Zoning Ordinance, a Part II Review Fee shall be assessed by the Department of Housing and Economic Development. The fee, as determined by staff at the time, is final and binding on the Applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval.
10. The Site and Landscape Plans shall be in substantial conformance with the Landscape Ordinance and any other corresponding regulations and guidelines. Final landscape plan review and approval will be by the Department of Housing and Economic Development. Any interim reviews associated with site plan review or Part II reviews, are conditional until final Part II approval.
11. The Applicant shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioners of the Departments of Streets and Sanitation, Environment and Buildings, under Section 13-32-125 of the Municipal Code, or any other provision of that Code.

The terms and conditions of development under this Planned Development ordinance may be modified administratively, pursuant to Section 17-13-0611-A of the Zoning Ordinance by the Zoning Administrator upon the application for such a modification by the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors.
13. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enable and maximizes universal access throughout the Property. Plans for all buildings and improvements on the Property shall be reviewed and approved by the Mayor's Office for People with Disabilities to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote accessibility.
14. The Applicant acknowledges that it is in the public interest to design, construct, renovate and maintain all buildings in a manner that provides healthier indoor environments, reduces operating costs and conserves energy and natural resources. The project will be LEED certified and will provide an approximately 9,537 square foot green roof to cover at least 50% of the net roof area of the building. "Net roof area" is defined as total roof area minus any required perimeter setbacks, roof top structures, and roof-mounted equipment.
15. The Applicant commits to provide and fully-fund the following infrastructure improvements prior to issuance of the final occupancy certificate for the project:

The funding and provision of all infrastructure improvements detailed in this Statement 15: A) will be the responsibility of the Applicant, B) will be subject to review and installation scheduling by the Department of Transportation, and C) must be in accordance with the Department of Transportation Construction Standards for Work in the Public Way in compliance with the Municipal Code of the City of Chicago.

16. Pursuant to Section 17-4-1004-B of the Zoning Ordinance, the Applicant has requested an increase in the floor area ratio for the Property, as set forth in the bonus worksheet required under Section 17-4-1003-D and attached hereto as an exhibit. Any developer of a building receiving an affordable housing floor area bonus (“Eligible Building”) must either provide on-site affordable housing units or make a cash payment to the City’s Affordable Housing Opportunity Fund. The Applicant has elected to make a cash payment in lieu of providing on-site affordable housing units. In accordance with the formulas set forth in Section 17-4-1004-C and the Bonus Worksheet, the Applicant acknowledges and agrees that it must make a cash payment in the amount of \$1,291,931.20 (“Cash Payment”). The Applicant must make the required Cash Payment before the issuance of any building permits for the Eligible Building, including, without limitation, excavation or foundation permits, and must comply with all applicable

affordable housing standards and requirements set forth in Section 17-4-1004, the terms of which are incorporated herein by this reference.

17. Unless construction of the new improvements contemplated in this Planned Development has commenced within four (4) years following adoption of this Planned Development, and unless completion is thereafter diligently pursued, then this Planned Development shall expire and the zoning of the property shall automatically revert to the DX-16 Downtown Mixed-Use District classification.








GENERAL LAND-USE MAP




EXISTING SITE PLAN


SITE PLAN


LOWER LEVEL 1 PLAN






LEVEL 3 PARKING PLAN


LEVEL 4 PARKING PLAN


LEVEL 5 PARKING PLAN


LEVEL 5.5 PARKING PLAN






EAST BUILDING ELEVATION


SOUTH BUILDING ELEVATION




WEST BUILDING ELEVATION




NORTH BUILDING ELEVATION




GARLAND STREET / WEST PODIUM ELEVATION

LEVEL 2 PLAN DIAGRAM





EAST ELEVATION




SOUTH ELEVATION



Pursuant to the provisions of the Chicago Zoning Ordinance, Title 17 of the Municipal Code of Chicago, the Department of Housing and Economic Development hereby submits this report and recommendation on a proposed Residential Business Planned Development for your review and recommendation to the Chicago City Council. The application for this amendment to the Chicago Zoning Ordinance was introduced into the City Council on July 24, 2013. Notice of the public hearing was published in the Chicago Sun-Times on December 4, 2013. The applicant was separately notified of this public hearing.

The applicant, 200 North Michigan Owner, LLC, proposes the construction of a 42-story (476 feet) mixed-use building with 402 residential units, approximately 24,900 square feet of retail space, and 125 accessory parking spaces. This application is a mandatory planned development because the residential building would be higher than 440 feet and would contain more than 400 dwelling units of multi-family housing in a DX-16 Downtown Mixed-Use District.

The application seeks three Floor Area Bonuses to increase the site's maximum Floor Area Ratio (FAR) from 16.00 to 21.63. The bonuses would consist of 1.44 FAR for upper-level setbacks, 1.79 FAR for parking concealed by occupiable space, and 2.40 FAR for a contribution of \$1,291,931.20 to the Affordable Housing Opportunity Fund.

**SITE AND AREA DESCRIPTION**

The approximately 0.50-acre site lies in the Loop Community Area. The site is bounded by Upper and Lower North Michigan Avenue on the east, East Lake Street on the south, North Garland Court on the west, and the landmark Carbide and Carbon Building (Hard Rock Hotel) on the north. The site currently contains an older 6-story commercial building that contained retail uses on the lower two floors and offices on the upper floors. The building is largely vacant. The site is within neither the Lake Michigan and Chicago Lakefront

Protection District, nor a Tax Increment Finance (TIF) district, nor an Industrial Corridor, nor a Chicago Landmark District.

As stated above, the remainder of the block is occupied by the Carbide and Carbon Building (Hard Rock Hotel). The site lies in the densely built-up mixed-use East Loop area. Development in the immediate area consists overwhelmingly of tall (20+ stories) buildings constructed between the late 19th Century and the 1970's. Uses include offices, residences, hotels, and ground-floor retail. On the institutional side, Harold Washington College of the Chicago City Colleges lies a block to the east and the Chicago Cultural Center (former Chicago Public Library) lies a block to the south. The Main Branch of the Chicago River is two blocks north and Grant Park/Millennium Park is a block south.

Numerous CTA bus lines on N. Michigan Avenue, E. Wacker Place, and E. Lake Street serve the site. CTA transit service is located on the Loop Elevated (Green, Pink, Orange, Brown, and Purple Lines) at the State/Lake station, on the State Street subway (Red Line) at the Lake Street station, and the Dearborn Street subway (Blue Line) at the Clark/Lake station. The Millennium terminal station for Metra's Electric Line and the South Shore Line is a block to the south.

### **PROJECT DESCRIPTION**

The project would consist of 402 residential units, approximately 24,900 square feet of retail space, and 125 accessory parking spaces. The 402 residential units would consist of 130 efficiency units and 272 1-, 2-, and 3-bedroom units, ranging in size from 524 square-foot efficiencies to 1,645 square-foot 3-bedroom units.

A 5-story base would be topped with 37 stories of tower for a total of 42 stories. The base would contain 8 parking spaces and loading docks in the basement, the retail space and the residential lobby on the ground and second floors, and further parking on the third, fourth, and fifth floors. The base would extend to the property line on all four sides except for the ground floor along E. Lake Street, where it would be set back 3' to 4.5' from the property line.

Floors six and seven, at the start of the tower, would be set back 7.25' from E. Lake Street and 42.75' from the north property line. The sixth floor would contain the residential amenity spaces and the seventh floor would be the lowest residential floor. The eighth floor and above would be residential with the tower continuing to be set back 7.25' from E. Lake Street and an increased setback from the north property line (70.75').

Open space would consist of terraces in the sixth, amenity, floor setbacks and the eighth-floor setback, semi-recessed balconies for eight of the twelve units on each of the typical residential floors, and a root-top pool deck.

In addition to the 2.40 FAR bonus for a \$1,291,631.20 contribution to the Affordable Housing Opportunity Fund, the project is seeking on-site FAR bonuses for upper-level

setbacks and parking concealed by occupiable space. A 1.44 FAR bonus would be derived from the 28' setback for the 25 floors above the seventh floor on the tower's north side. A 1.79 FAR bonus would come from the use of retail space fronting on N. Michigan Avenue and E. Lake Street to conceal parking space on the ground and second floors.

## **DESIGN**

Ground-floor retail spaces would have pedestrian entrances on both N. Michigan Avenue and E. Lake Street. A separate entrance on N. Michigan Avenue would lead to the second-floor retail space. The retail facades on N. Michigan Avenue, E. Lake Street, and N. Garland Court would be metal and vision glass storefronts. Along N. Michigan Avenue, a 15-foot deep space would separate the third to fifth floor parking from the façade. This space would extend all the way from the floor of the second floor, be fronted with vision glass, and be decorated. The south and west facades of the three parking floors would be a combination of two colors of spandrel glass.

All four elevations of the tower would be clad with a mix of vision and spandrel glass. The balconies would have glass railings.

## **ACCESS and CIRCULATION**

The pedestrian entries for the retail spaces on both the ground and second floors would be from the sidewalks on N. Michigan Avenue and E. Lake Street. The entrance for the residential lobby would be on recessed porte-cochere on N. Garland Court.

Access for parking would be from Lower Michigan Avenue. For the basement parking, cars could drive in directly from Lower Michigan Avenue. For the upper-level parking, cars would ascend an internal ramp to the third floor. Loading docks would be located at the basement level under Michigan Avenue.

## **LANDSCAPING and SUSTAINABILITY**

The building would be LEED certified. It would have a green roof on at least 50% of the net roof area (approximately 9,500 square feet), much of that in landscaping on the sixth-floor amenity terrace.

Four raised planters and four parkway trees would be installed along E. Lake Street. The existing concrete planters sitting on N. Michigan Avenue would be relocated to N. Wabash Avenue and replaced by five raised planters with landscaping, but not trees, because Upper Michigan Avenue is on structure. There is no sidewalk on the east side of the narrow N. Garland Court, so no parkway trees would be installed.

## **RECOMMENDATION**

The Department of Housing and Economic Development has concluded that the proposed Residential Business Planned Development would be appropriate for the site and that the project meets the review criteria for planned developments set forth in the Zoning Ordinance (Section 17-13-0900).

1. The project complies with the Standards and Guidelines for Planned Developments in the Zoning Ordinance (Section 17-8-0900).
  - a. Compliance with Zoning. The proposed Planned Development conforms to the standards and requirements of the DX-16 Downtown Mixed-Use District. The application proposes to increase the maximum Floor Area Ratio (F.A.R.) from 16.00 to 21.63 with three Floor Area Bonuses. The bonuses would consist of 1.44 FAR for upper level setbacks, 1.79 FAR for parking concealed by occupiable space, and 2.40 FAR for a payment of \$1,291,931.20 to the Affordable Housing Opportunity Fund. The approximately 0.50-acre site in a DX-16 district, after a 15% Minimum Lot Area reduction for payment to the Affordable Housing Opportunity Fund and a discretionary 40% increase in allowable residential units, supports the proposed 402 residential units in a mix of 272 standard units and 130 efficiency units. All the uses proposed by the application are permitted in a DX-16 district. There is no maximum building height in a DX-16 district.
  - b. Approved Plans. The proposed mix of residential and business uses conforms to the Central Area Action Plan approved by the Chicago Plan Commission in 2009.
  - c. Transportation, Traffic Circulation and Parking. The proposed project is located in a densely developed mixed-use area. Most activities are within walking distance. The site is served by numerous CTA bus lines, and the site lies within two blocks of stations for two commuter rail lines and six of the CTA's eight transit lines. A seventh CTA transit line lies within four blocks. In view of this proximity to transit and the small average unit size (less than 800 square feet), the required parking is low, 125 spaces for the 402 residential units and no parking for the retail use. All the parking that is provided, as well as the loading access, is located on Lower Michigan Avenue.
  - d. Pedestrian Orientation. The building has been designed to provide active uses along all three street frontages. The residential entry & lobby is located on N. Garland Court. The frontages on E. Lake Street and N. Michigan Avenue feature two stories of glass-fronted retail space. Furthermore, along N. Michigan Avenue, the parking on levels three through five is screened from the street by a 15-foot deep, glass-fronted decorative space. Parkway trees in raised planters will enhance the pedestrian experience along E. Lake Street and new landscaped raised planters will enhance the pedestrian environment along N. Michigan Avenue. The only curb cuts will be on Lower Michigan Avenue and N. Garland Court.

2. The proposed development is compatible with the character of the surrounding area in terms of uses, density, and building scale.

The proposed Planned Development would fit well with the surrounding area. The neighboring blocks contain many buildings of a similar height. The proposed 21.63 F.A.R. is comparable to much of the existing development. The placement of the tower close to E. Lake Street with an approximately 70-foot setback from the Carbide and Carbon Building allows a clear view of that landmark from the south and provides light and open space for both buildings. Residential high-rise and ground floor retail uses are common in the area.

3. The public infrastructure facilities and city services will be adequate to serve the proposed development at the time of occupancy.

The proposed site plan and a traffic study for the Planned Development have been reviewed by the Chicago Department of Transportation and all requested changes have been made. Copies of this application have been circulated to other City departments and agencies and all comments, which have been received, are addressed in the revised application.

Based on the foregoing, it is the recommendation of the Department of Housing and Economic Development that the revised application for an Residential Business Planned Development be approved and that the recommendation to the City Council Committee on Zoning, Landmarks, and Building Standards be: "As Revised, Passage Recommended."
