ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the District B3-3 Community Shopping District symbols and indications as shown on Map No. 10-D in the area bounded by

East 43rd Street; South Berkeley Avenue; the east west public alley south of and parallel to East 43rd Street; the north south public alley west of and parallel to South Berkeley Avenue;

to those of a B2-3 Neighborhood Mixed-Use District.

SECTION 2. This ordinance takes effect after its passage and approval.
