a line 200.40 feet northwesterly of the west line of North Greenview Avenue as measured along the northeasterly line of North Clybourn Avenue; the public alley next northeast of North Clybourn Avenue; a line 250.44 feet northwesterly of the west line of North Greenview Avenue as measured along the northeasterly line of North Clybourn Avenue; North Clybourn Avenue

to those of a B1-2 Neighborhood Shopping District which is hereby established in the area described above.

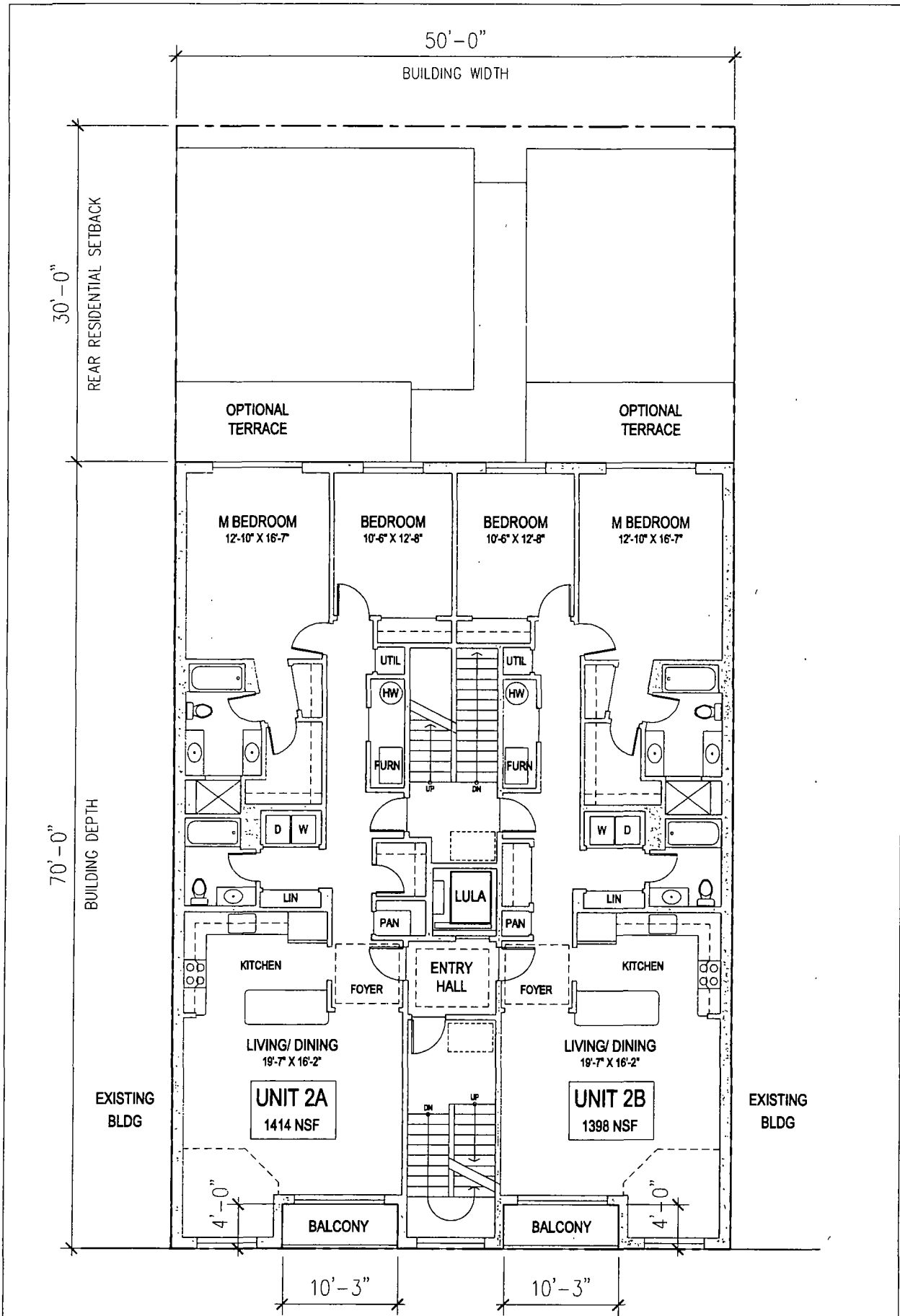

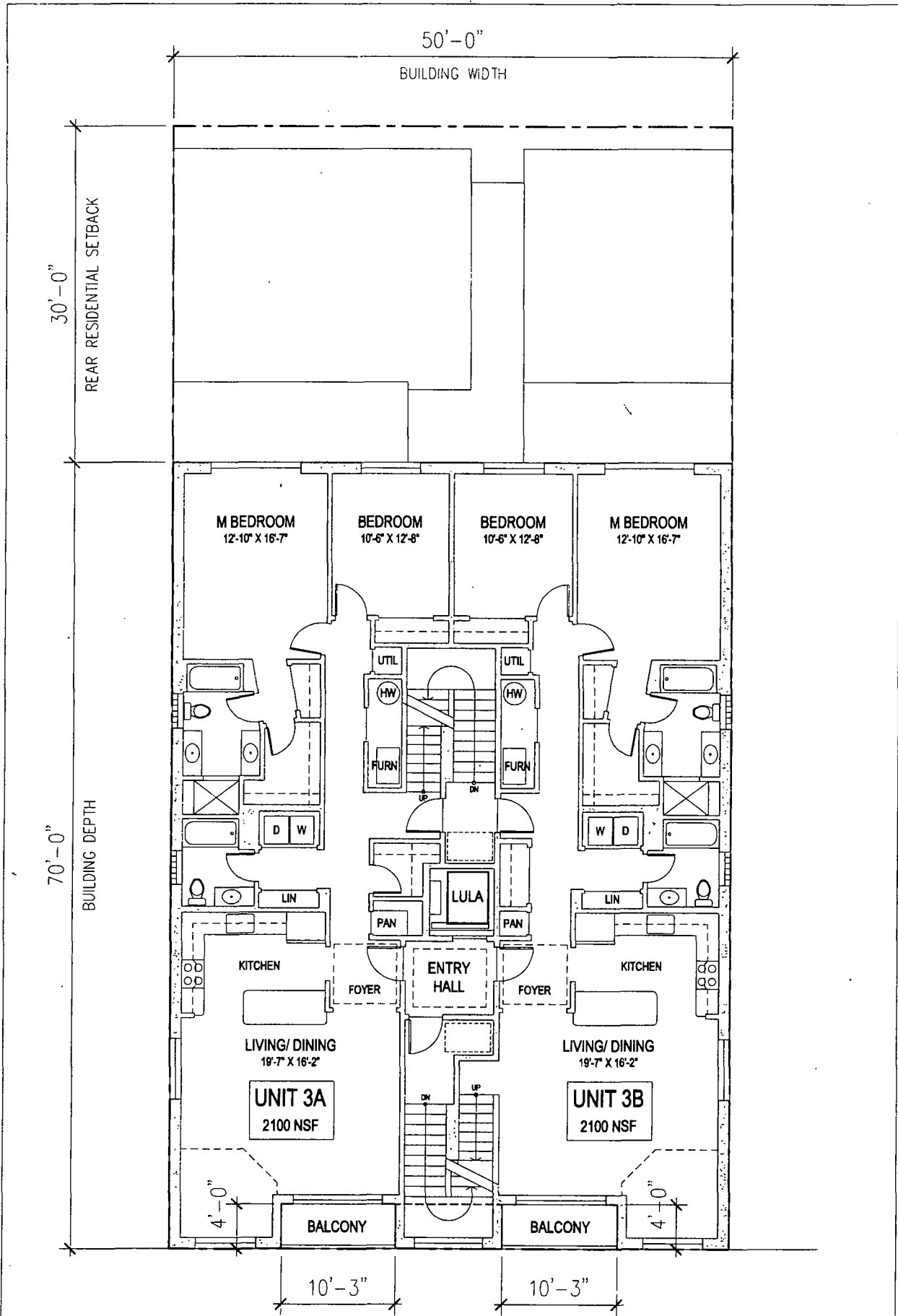

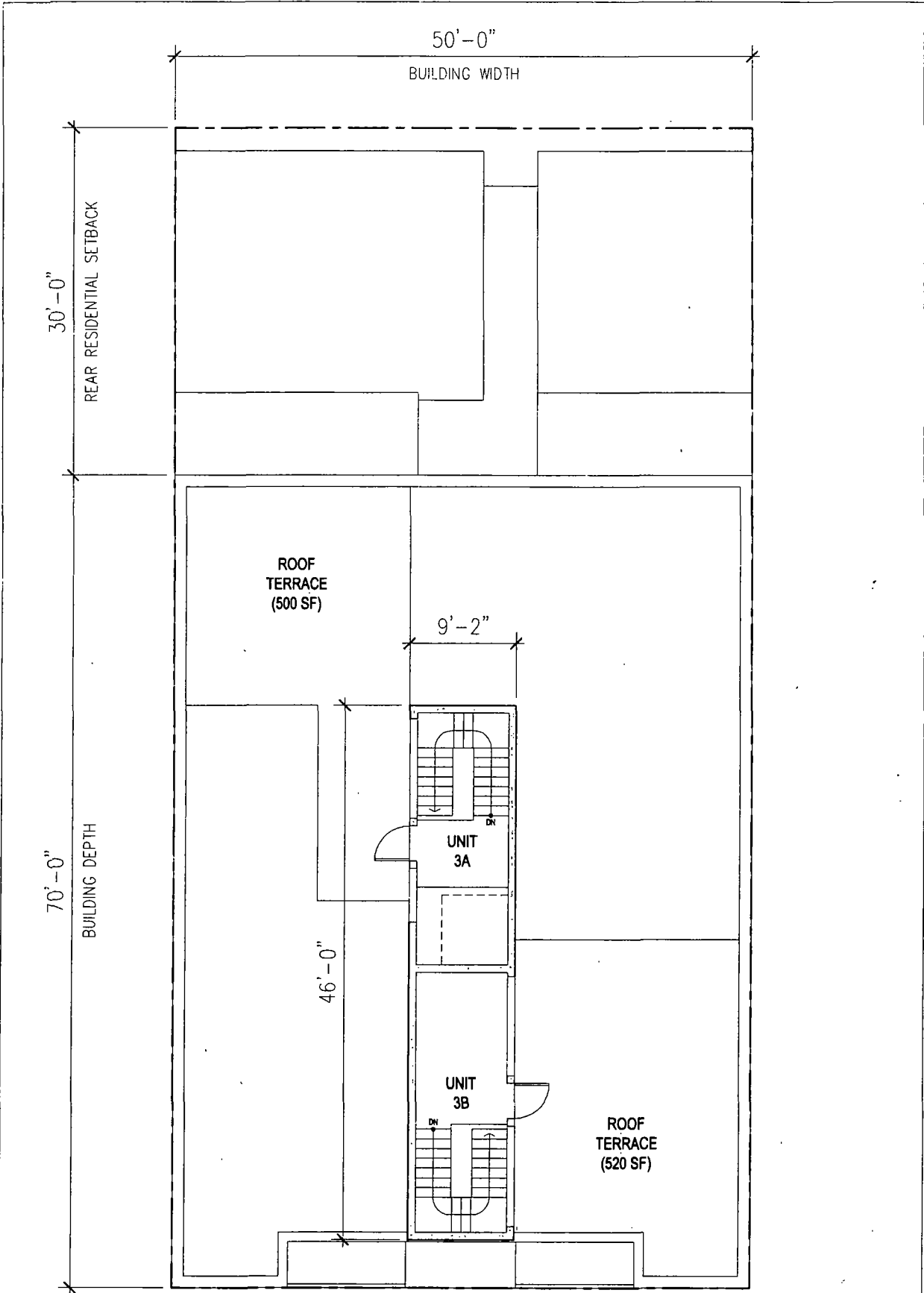
