BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

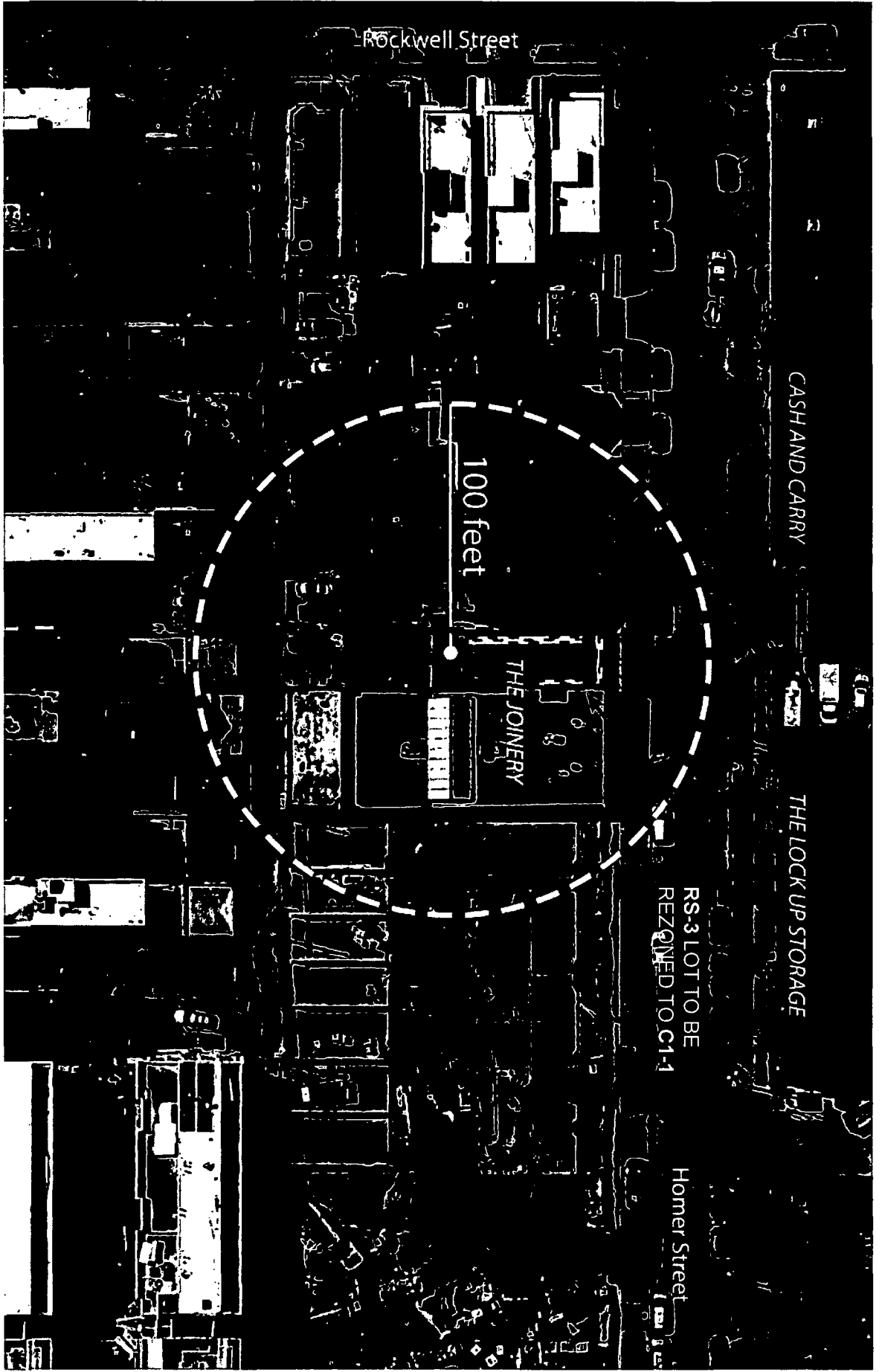
SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 5-1 in the area bounded by

The public alley south of and parallel to West Homer Street; a line 215.50 feet east of and parallel to North Rockwell Street; West Homer Street; a line 239.50 feet east of and parallel to North Rockwell Street

to those of a C1-1 Neighborhood Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

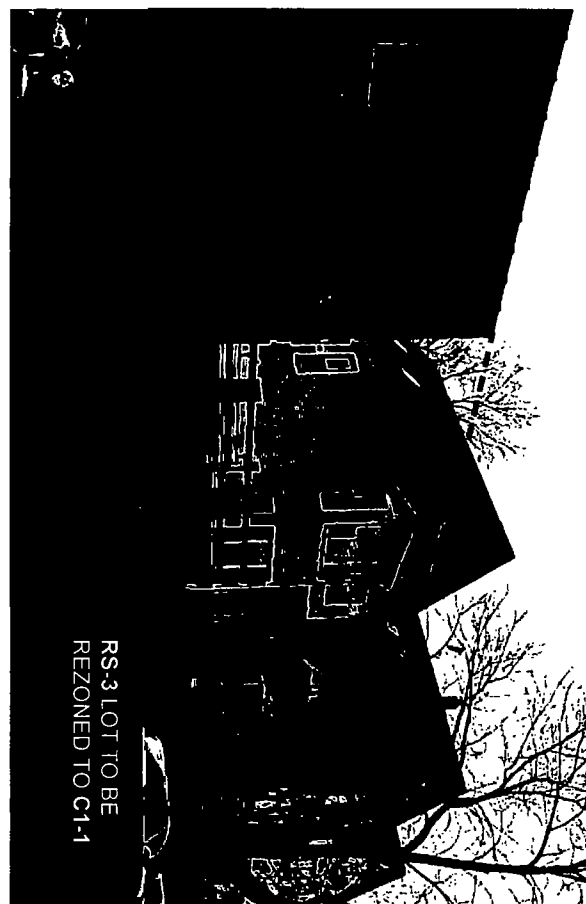

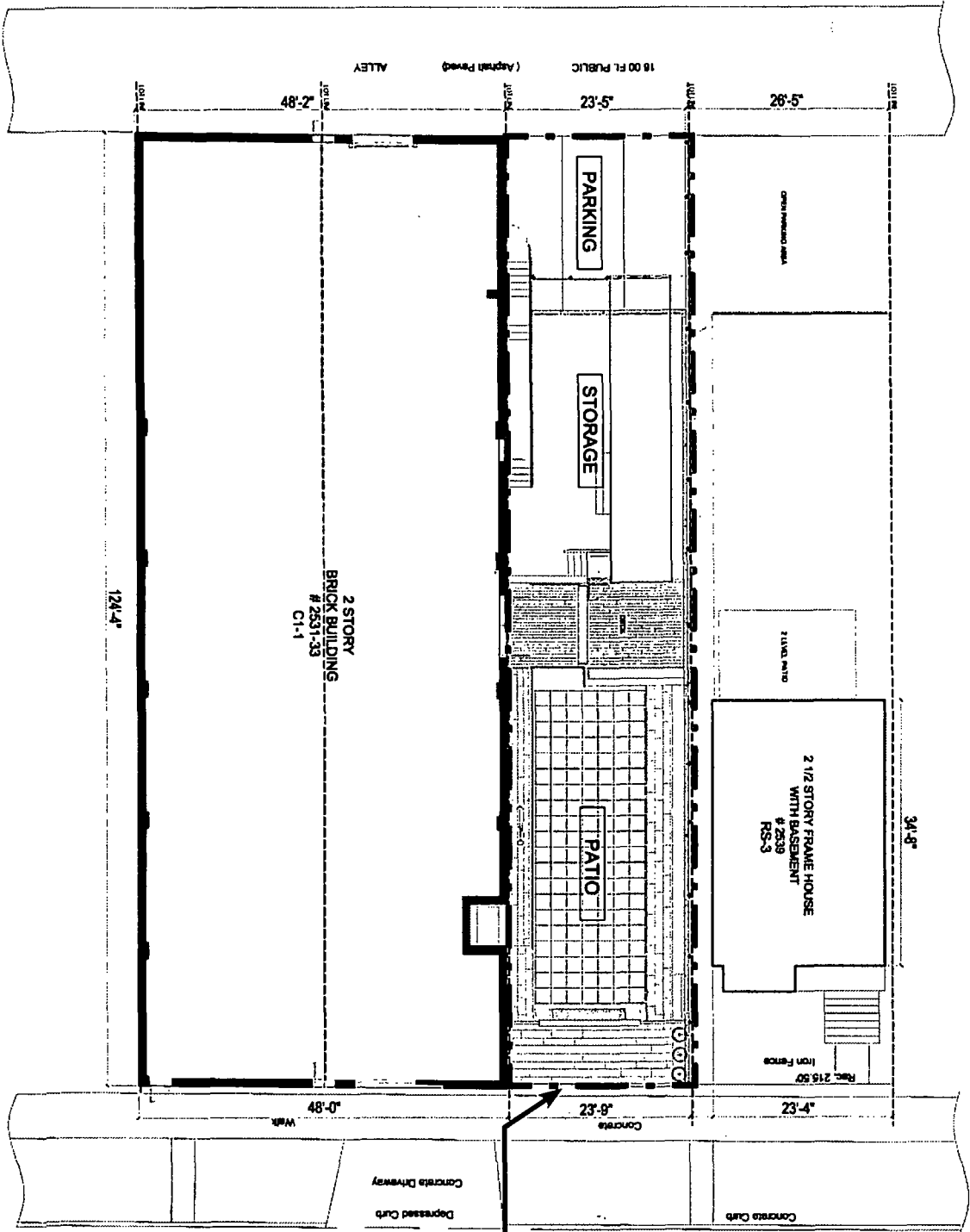

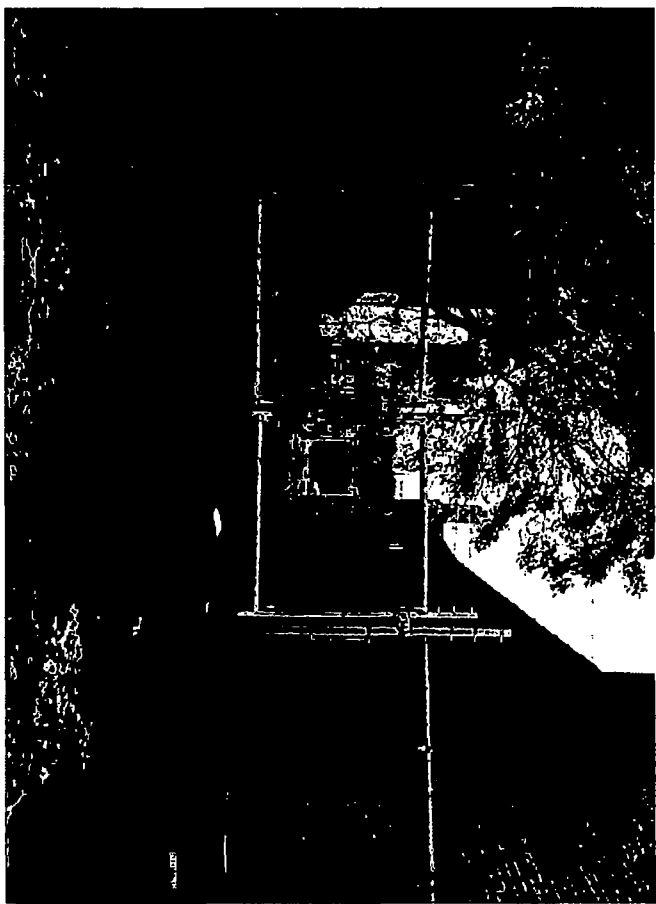

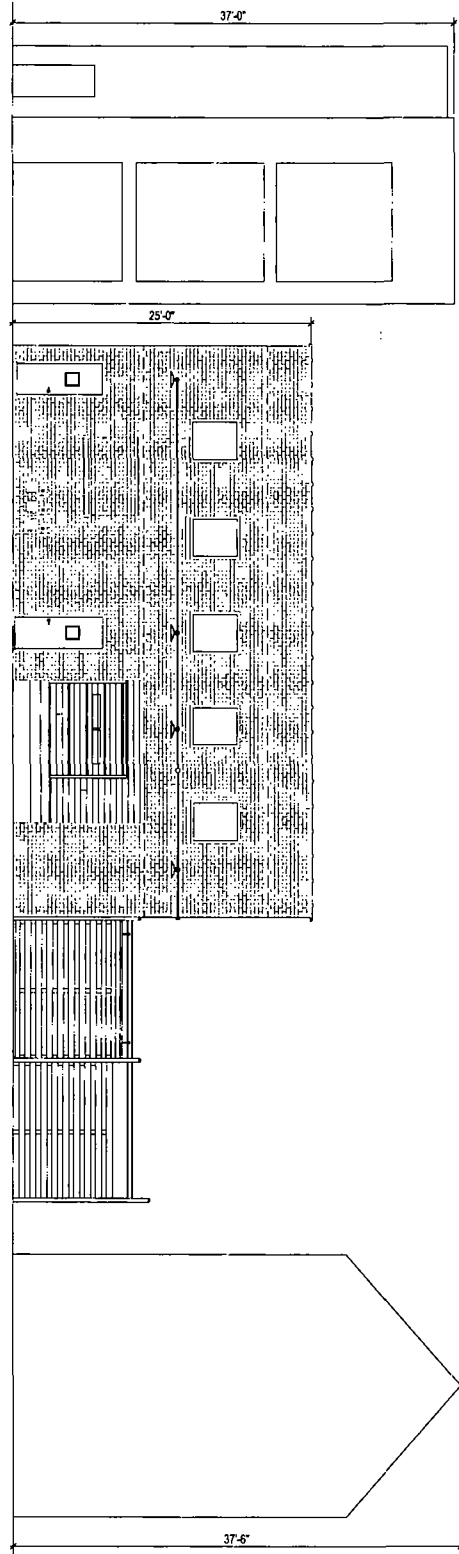




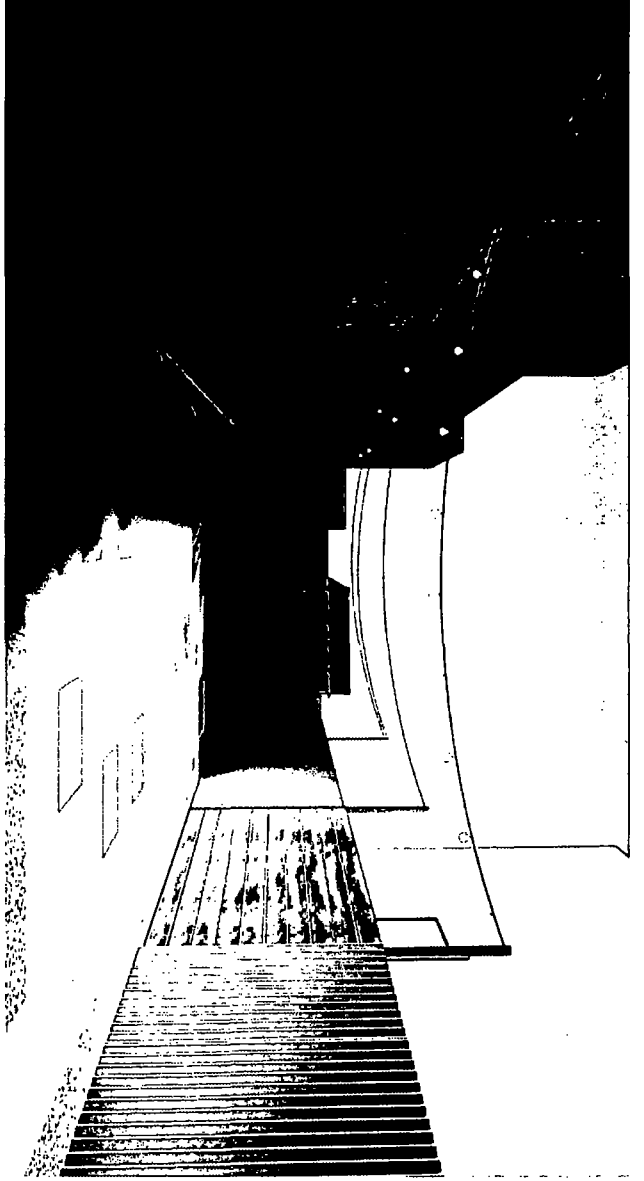


2 PROPOSED FRONT ELEVATION

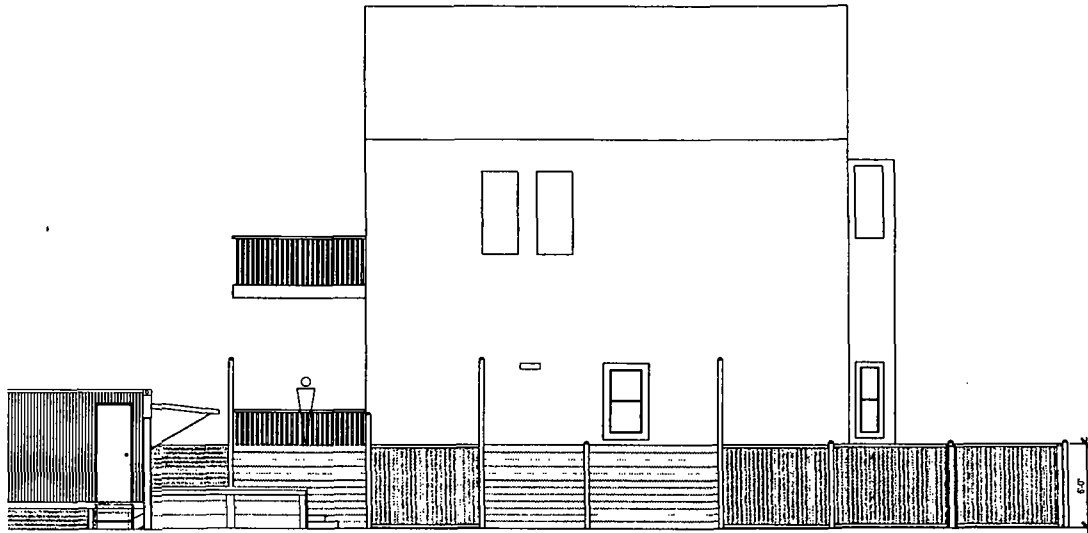

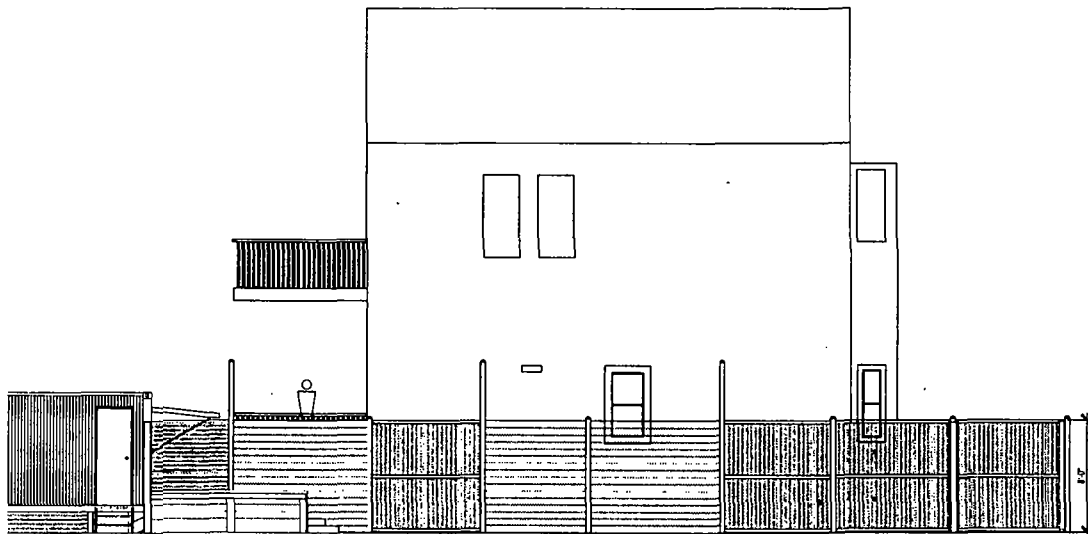

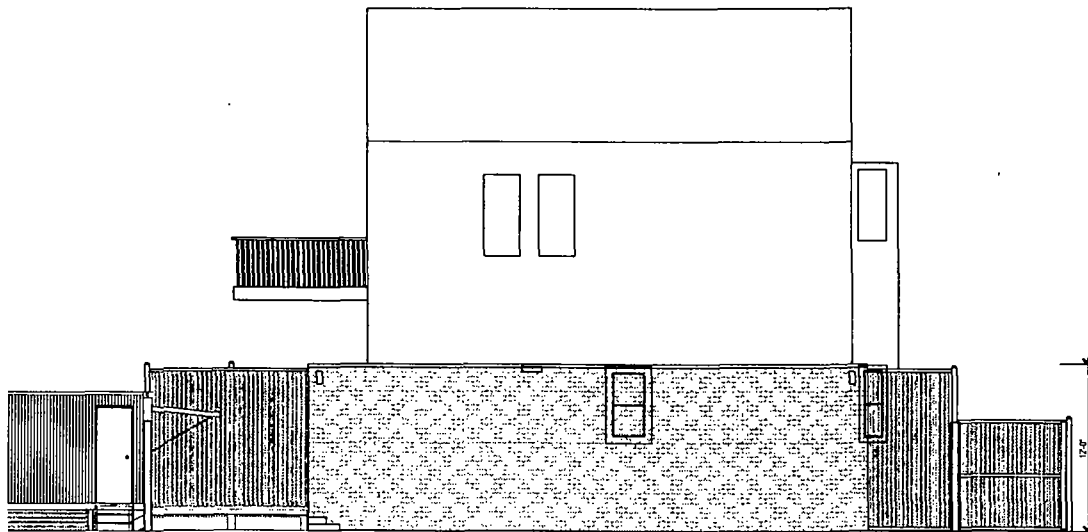
