## ORDINANCE

**WHEREAS**, the City of Chicago (the "City") is a home rule unit of government by virtue of the provisions of the Constitution of the State of Illinois of 1970 and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, on December 5, 1985, the City commenced a demolition case against the owner of the property located at 1733-35 N. Francisco, as legally described on Exhibit A attached hereto (the "Demolition Parcel"); and

**WHEREAS**, the court case proceeded as follows:

- on July 16, 1986, the Circuit Court of Cook County issued a decree in favor of the City to demolish the building on the Demolition Parcel;
- on October 16, 1986, the City demolished the building;
- on December 9, 1986, the City filed a lien in the amount of \$7,330.00 against the Demolition Parcel for the cost of demolishing the building;
- on December 30, 1986, the Circuit Court entered judgment in favor of the City in the amount of \$7,330;
- on December 5, 1989, the City recorded a Lis Pendens Notice of Foreclosure of the demolition lien in the county's property records;
- on August 22, 1991, the Circuit Court entered judgment in favor of the City to foreclose the lien;
- on December 3, 1991, the Sheriff of Cook County held a public sale of the Demolition Parcel and, without receiving other bids, issued a Certificate of Sale to the City;
- on July 31, 1992, the City acquired title to the Demolition Parcel through a Sheriff's Deed, recorded on October 1, 1992, as document number 92731061; and

**WHEREAS**, on May 1, 1989, while the City's case was pending, Japheth Mills, the owner of the property located to the immediate south of the Demolition Parcel, as legally described on Exhibit A (the "Mills Parcel"), and Taurino Miranda, the owner of the property located to the immediate north of the Demolition Parcel, as legally described on Exhibit A (the "Miranda Parcel"), obtained an Estimate of Cost of Redemption from the Cook County Clerk for the delinquent taxes on the Demolition Parcel; and

**WHEREAS**, in October 1989, Mr. Mills and Mr. Miranda filed an application with the county to split the PIN for the Demolition Parcel and combine the north half of the PIN with the Miranda Parcel and the south half of the PIN with the Mills Parcel; and

**WHEREAS**, at the time the City commenced demolition proceedings in 1985, the Property Identification Number ("PIN") for the Demolition Parcel was 13-26-322-005, and the PINs for the Miranda Parcel and the Mills Parcel were 13-26-322-004 and 13-26-322-006, respectively; and

**WHEREAS**, in September 1992, before the Sheriff's Deed to the City for the Demolition Parcel was recorded, Mr. Mills purchased the delinquent taxes at the 1991 Tax Scavenger Sale (though DPD found no record of a tax deed); and

**WHEREAS**, as a result of the PIN division, the original PIN for the Demolition Parcel (13-26-322-005) was eliminated and replaced with two new PINs representing two larger parcels; and

**WHEREAS**, as shown in the chart below, one of the new parcels includes the Miranda Parcel and the north half of the Demolition Parcel (as legally described in Exhibit B, the "Enlarged Miranda Parcel"), and the other new parcel includes the Mills Parcel and the south half of the Demolition Parcel (as legally described in Exhibit B, the "Enlarged Mills Parcel"); and

**WHEREAS**, Taurino and Sophia Miranda purchased the Miranda Parcel in 1986, but have been paying taxes on the Enlarged Miranda Parcel since at least 2002 (which is as far back as the county's on-line historical tax records go); and

**WHEREAS**, Sara Mills purchased the Enlarged Mills Parcel from her father, Japheth Mills, in 2007, and has been paying taxes on the property since acquisition; and

**WHEREAS**, both the Mirandas (together with their heirs, successors and assigns, the "North Property Owner") and Ms. Mills (together with her heirs, successors and assigns, the "South Property Owner") have enclosed and maintained their portions of the Demolition Parcel; and

**WHEREAS**, it appears the City was unaware of the combination of the Demolition Parcel with the neighboring parcels and made no attempt to undo the PIN division, remove the fence or other encroachments on the Demolition Parcel, or otherwise assert ownership of the Demolition Parcel; and

**WHEREAS**, although the City filed a tax abatement letter for the Demolition Parcel on July 6, 1998, the letter only identified PIN 13-36-322-036 (the new PIN for the Enlarged Mills Parcel, which includes only the south half of the Demolition Parcel), and despite the abatement letter the county has taxed PIN 13-36-322-036 since Ms. Mills acquired the property in 2007; and

**WHEREAS**, given the long history of private tax payments and maintenance of the Demolition Parcel, the City's Department of Planning and Development ("DPD") desires to convey the Demolition Parcel, as divided, to the neighboring property owners for \$1.00 per half; now, therefore,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** The foregoing recitals are hereby adopted as the findings of the City Council.

**SECTION 2.** The Mayor or the Mayor's proxy is authorized to execute, and the City Clerk or the Deputy City Clerk is authorized to attest, a quitclaim deed conveying the north half of the

Demolition Parcel (the portion included in the Enlarged Miranda Parcel or PIN 13-36-322-037) to the North Property Owner for \$1.00, and a quitclaim deed conveying the south half of the Demolition Parcel (the portion included in the Enlarged Mills Parcel or PIN 13-36-322-036) to the South Property Owner for \$1.00.

**SECTION 3.** The Commissioner of DPD (the "Commissioner"), or a designee of the Commissioner, is each hereby authorized, with the approval of the City's Corporation Counsel as to form and legality, to negotiate, execute and deliver such documents as may be necessary or appropriate to carry out and comply with the provisions of this ordinance, with such changes, deletions and insertions as shall be approved by the Commissioner or the Commissioner's designee. Such documents may contain terms and provisions that the Commissioner or the Commissioner's designee deems appropriate, including indemnification, releases, affidavits and other documents as may be reasonably necessary to remove exceptions from title with respect to the Demolition Parcel or otherwise may be reasonably necessary or appropriate to consummate the transaction contemplated hereby.

**SECTION 4.** If any provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity of such provision shall not affect any of the other provisions of this ordinance.

**SECTION 5.** All ordinances, resolutions, motions or orders inconsistent with this ordinance are hereby repealed to the extent of such conflict.

**SECTION 6.** This ordinance shall take effect upon its passage and approval.

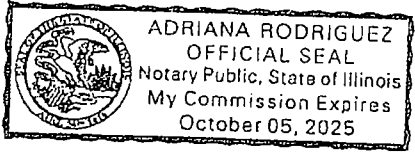
