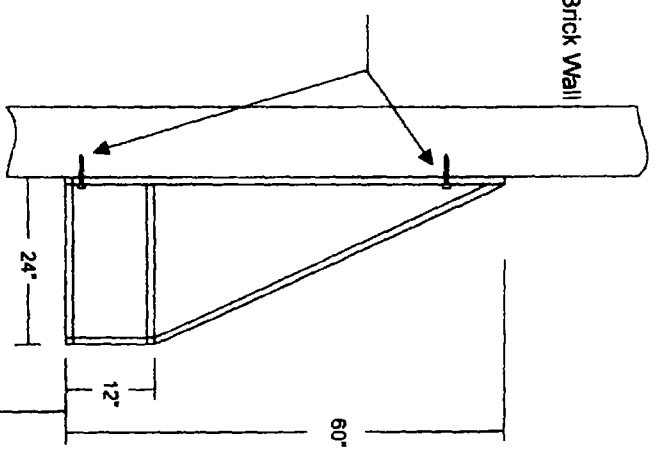

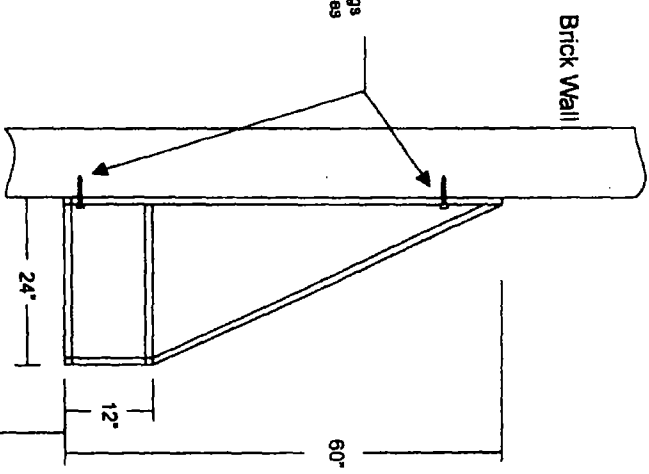


## CERTIFICATION
