



Grant of Privilege/Public Way Usage

ORDERED, that the Director of Business Affairs and Licensing, the Director of Revenue, and the City Comptroller are hereby authorized and directed to cancel the compensation fee in the amount of \$89,655.00 for a period of five years at a rate of \$17,931.00 per annum, for permit No. 1046185, for a grant of privilege for the use of the public way relating to the two (2) Sub Spaces to be used as the Theatre of Reconciliation, a kitchen used to feed the homeless, Sunday school classes, church meetings and storage space, said space on West Washington shall be ninety-one (91) feet in length and twelve (12) feet in width for a total of one thousand ninety two (1,092) square feet, and said space for North Clark Street shall be one hundred ninety-two (192) feet in length and twelve (12) feet in width a total of two thousand three hundred and four (2,304) square feet, charged to 1<sup>st</sup> United Methodist Church of Chicago Aid Society, for their premises located at 77 West Washington.
