ORDINANCE

WHEREAS, the City of Chicago (the "City") is a home rule unit of government by virtue of the provisions of the Constitution of the State of Illinois of 1970, and as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, pursuant to an ordinance adopted by the City Council of the City (the "City Council") on March 27, 2002 and published at pages 81231 through 81457, in the Journal of the Proceedings of the City Council (the "Journal") of such date, a certain redevelopment plan and project ("47th/King Plan") for the 47th/King Tax Increment Financing Redevelopment Project Area ("47th/King Area"), was approved pursuant to the Illinois Tax Increment Allocation Redevelopment Act, as amended (65 ILCS 5/11-74.4-1 et seq.) (the "Act"); and

WHEREAS, pursuant to an ordinance adopted by the City Council on March 27, 2002 and published at pages 81458 through 81465 in the Journal of such date, the 47th/King Area was designated as a redevelopment project area pursuant to the Act; and

WHEREAS, pursuant to an ordinance adopted by the City Council on March 27, 2002 and published at pages 81466 through 81472 in the Journal of such date, tax increment financing was adopted pursuant to the Act as a means of financing certain 47th/King Area redevelopment project costs (as defined in the Act) incurred pursuant to the 47th/King Plan; and

WHEREAS, the City is the owner of the vacant parcel of land commonly known as 4411 S. Vincennes Avenue, Chicago, Illinois 60653, which is located within the 47th/King Area and legally described on Exhibit A attached hereto (the "City Parcel"); and

WHEREAS, the appraised fair market value of the City Parcel is Twenty-Seven Thousand Five Hundred and 00/100 Dollars (\$27,500); and

WHEREAS, Bronzeville Manor Condominium Association, an Illinois not-for-profit corporation (the "Developer"), is the owner of the vacant parcel of land commonly known as 4359 S. Vincennes Avenue, Chicago, Illinois 60653, which is legally described on Exhibit B attached hereto (the "Developer Parcel"); and

WHEREAS, the appraised fair market value of the Developer Parcel is Twenty-Two Thousand and 00/100 Dollars (\$22,000); and

WHEREAS, the Developer has submitted a proposal to the Department of Housing and Economic Development (the "Department") to purchase the City Parcel in exchange for the Developer's conveying the Developer Parcel to the City and the Developer's paying the City the difference between the appraised fair market value of the City Parcel and the appraised fair market value of the Developer Parcel (i.e., Five Thousand Five Hundred and 00/100 Dollars (\$5,500) (the "Additional Compensation"); and

WHEREAS, the Developer intends to use the City Parcel to expand the Developer's adjacent parking lot, which is used by the owners and guests of the Developer's nearby

condominium building (the "Project"); and

WHEREAS, by Resolution No. 12-CDC-17 adopted on May 8, 2012, the Community Development Commission (the "Commission") recommended the City acquire the Developer Parcel; and

WHEREAS, by Resolution No. 12-CDC-18 adopted on May 8, 2012, the Commission authorized the Department to advertise its intention to enter into a negotiated sale with the Developer for the redevelopment of the City Parcel, approved the Department's request to advertise for alternative proposals, and approved the sale of the City Parcel to the Developer if no alternative proposals are received; and

WHEREAS, by Resolution No. 12-028-21, adopted by the Chicago Plan Commission (the "CPC") on May 24, 2012, the CPC recommended the sale of the City Parcel to the Developer; and

WHEREAS, public notices advertising the Department's intent to convey the City Parcel to the Developer appeared in the Chicago Sun-Times on June 1, 8 and 15, 2012; and

WHEREAS, no alternative proposals were received by the deadline indicated in the aforesaid notices; now therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The foregoing recitals are hereby adopted as the findings of the City Council.

SECTION 2. The sale of the City Parcel to the Developer in exchange for the Developer's conveying the Developer Parcel to the City and the Developer's paying the City the Additional Compensation is hereby approved. The sale of the City Parcel to the Developer is expressly conditioned upon the City's restricting the use of the City Parcel to a use not inconsistent with the 47th/King Plan, until the expiration of the 47th/King Plan.

SECTION 3. The Commissioner of the Department ("Commissioner") or a designee of the Commissioner is each hereby authorized, with the approval of the City's Corporation Counsel, to accept title to the Developer Parcel and to execute and deliver such other supporting documents as may be necessary or appropriate to accept such title.

SECTION 4. The Mayor or his proxy is authorized to execute, and the City Clerk or Deputy City Clerk is authorized to attest, a quitclaim deed conveying the City Parcel to the Developer, or to a land trust of which the Developer is the sole beneficiary, or to an entity of which the Developer is the sole owner and the controlling party, subject to those covenants, conditions and restrictions set forth in such deed, including such fencing and landscaping covenants as the Commissioner may reasonably require.

SECTION 5. If any provision of this ordinance shall be held to be invalid or

unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.

SECTION 6. All ordinances, resolutions, motions or orders in conflict with this ordinance are hereby repealed to the extent of such conflict.

SECTION 7. This ordinance shall take effect immediately upon its passage and approval.
