BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the M1-3, Limited Manufacturing/Business Park District symbols as shown on Map No. 1 - G in the area bounded by:

West Ohio Street; a line 92.71 feet East of and parallel to North Green Street; a line 70.91 feet southeast of the intersection of North Milwaukee avenue and North green Street (as measured along the North right of way of North Milwaukee Avenue and perpendicular thereto); North Milwaukee Avenue; North Green Street.

To those of a B3-3, Community Shopping District

SECTION 2. This Ordinance takes effect after its passage and approval.

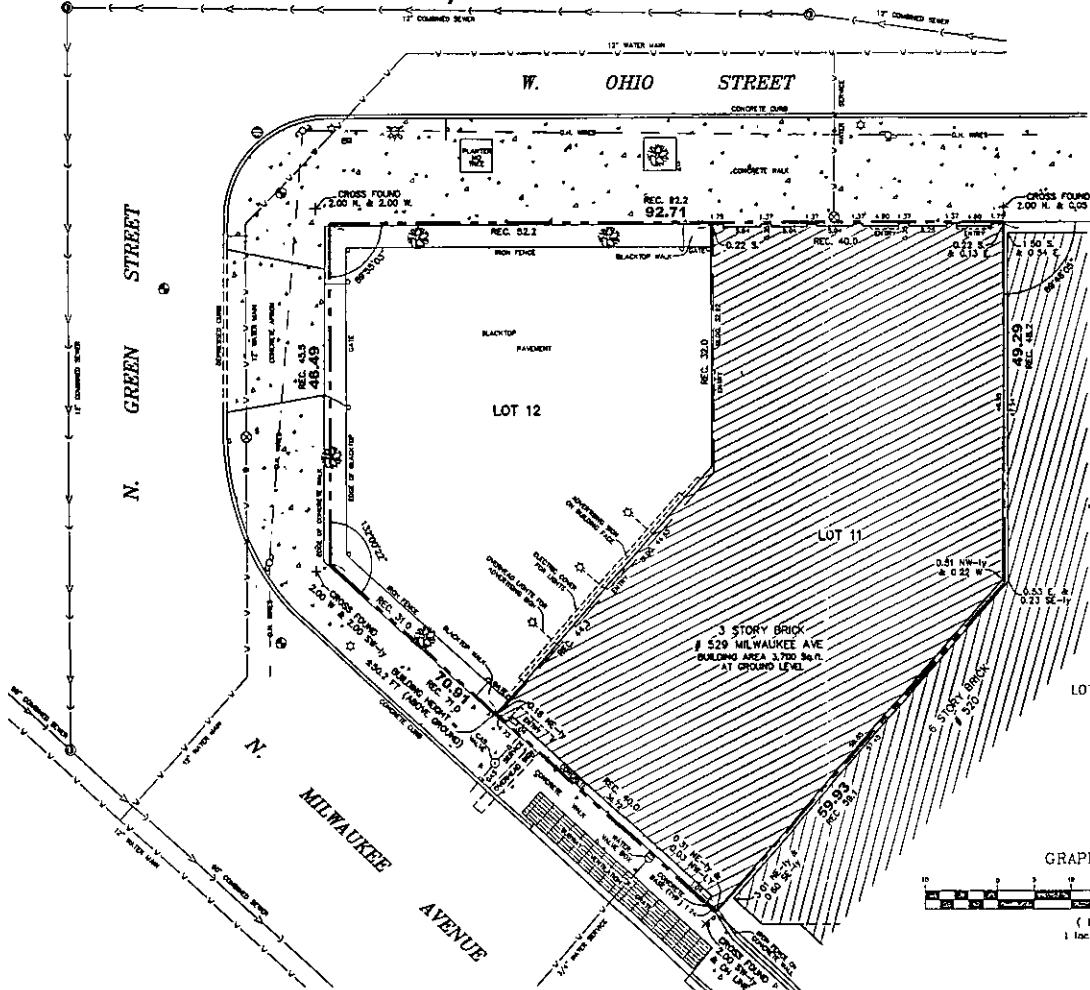

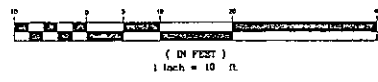
VICINITY MAP (NOT TO SCALE)

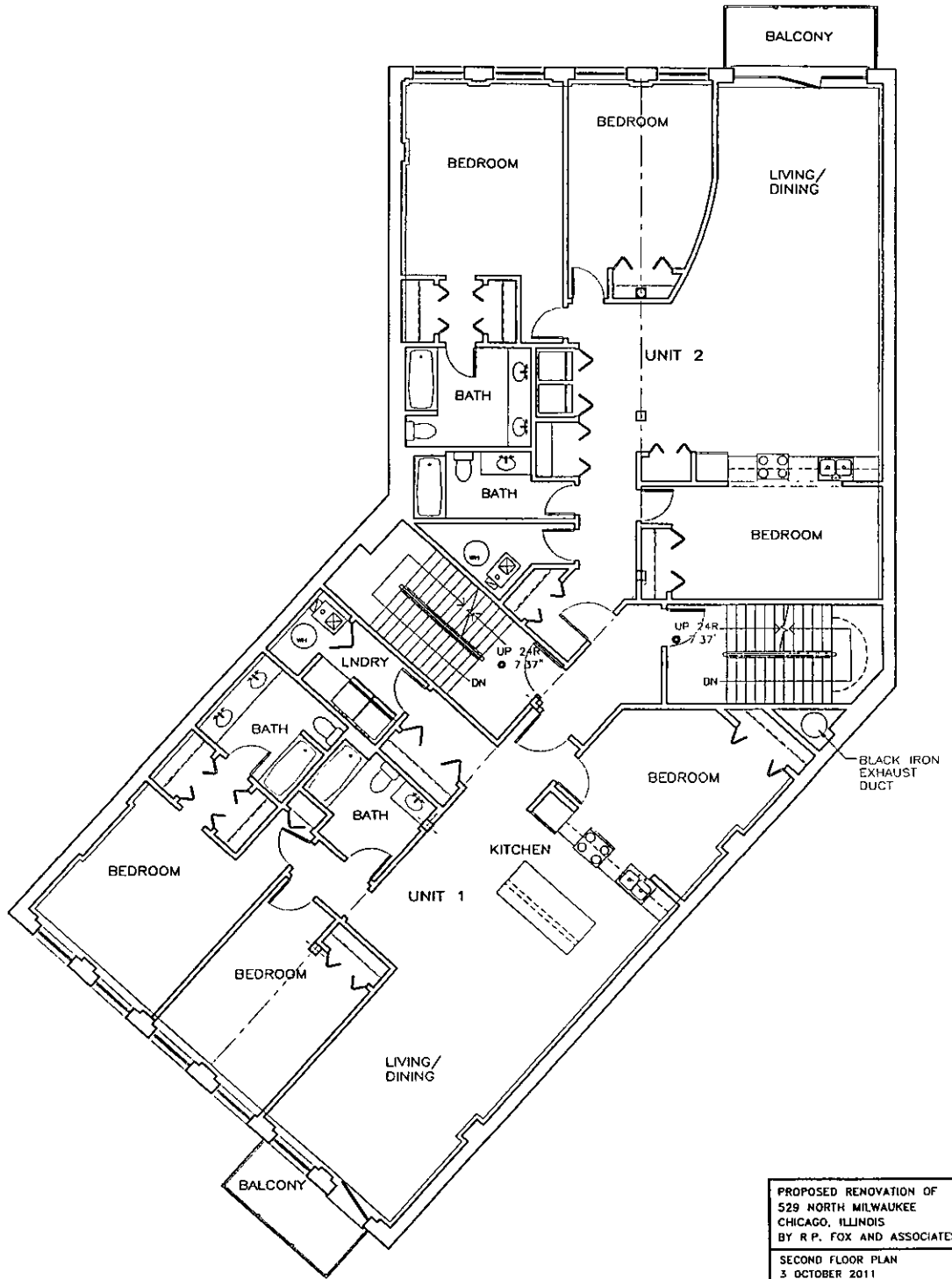

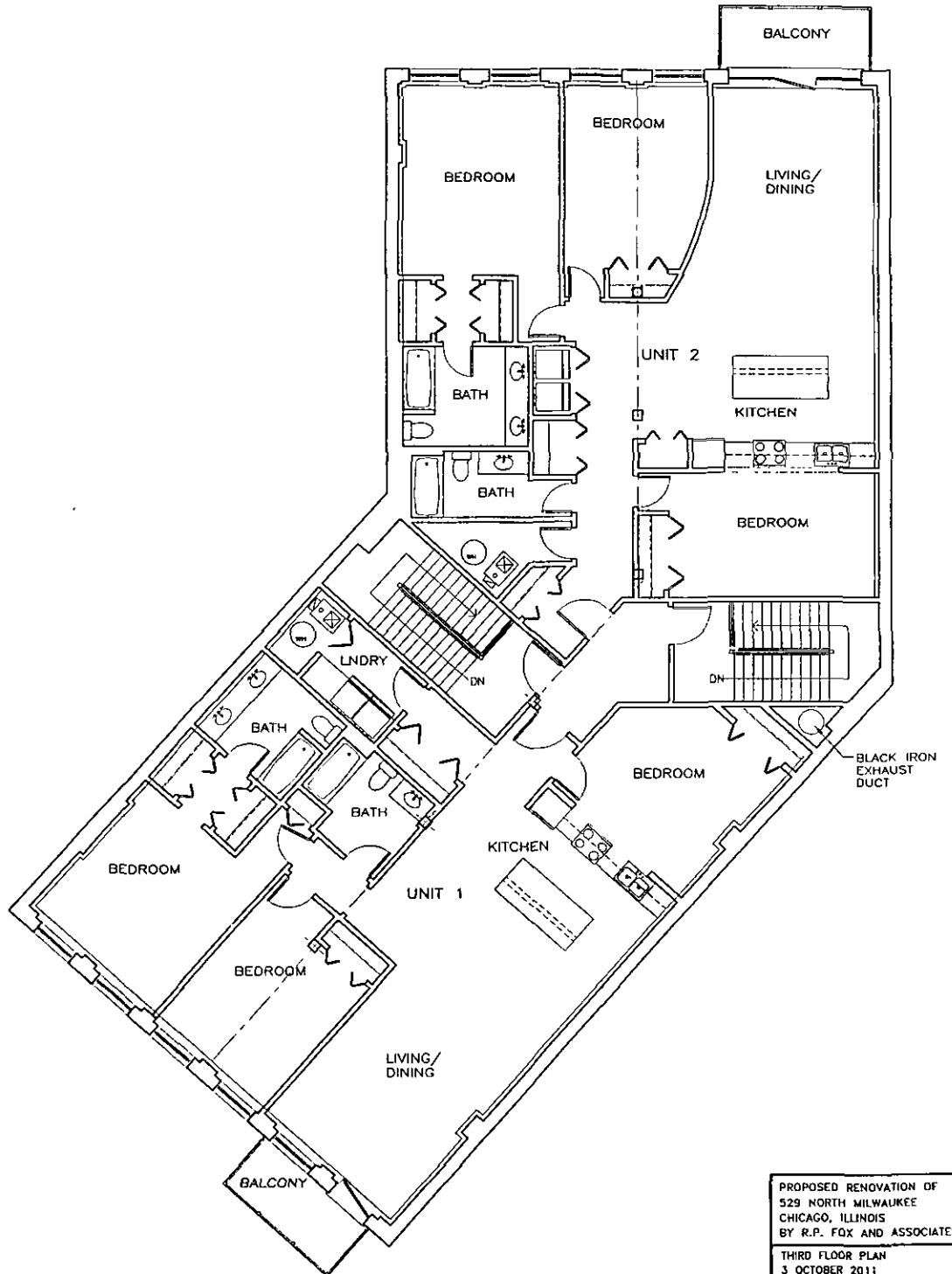

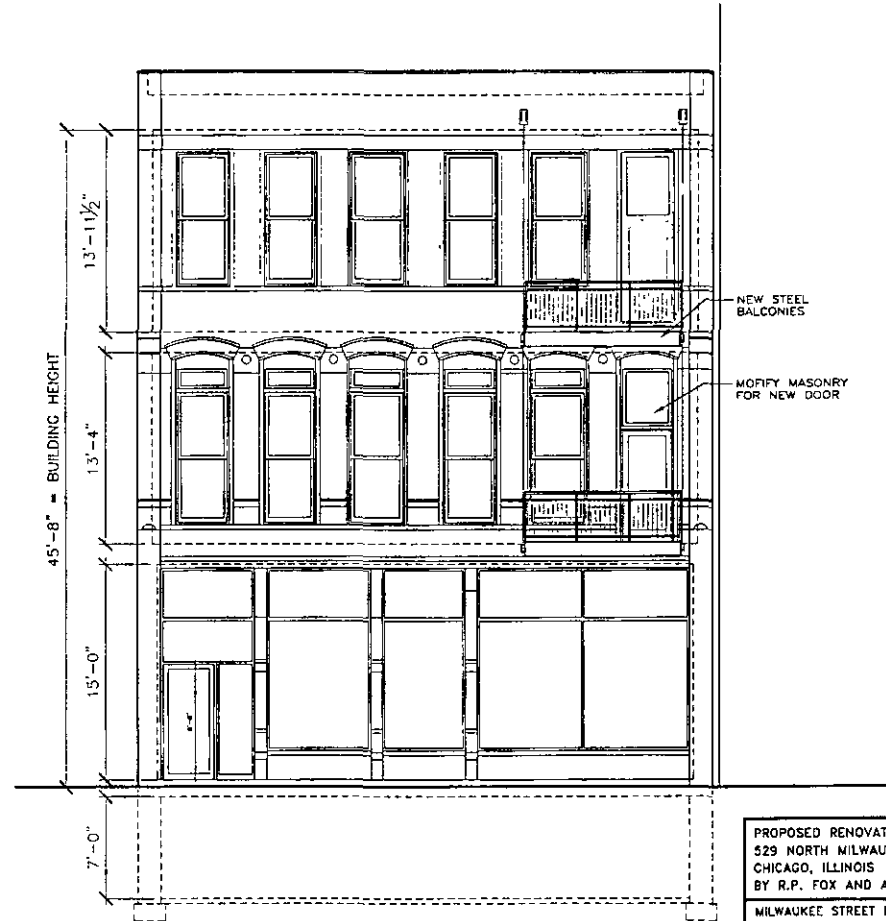

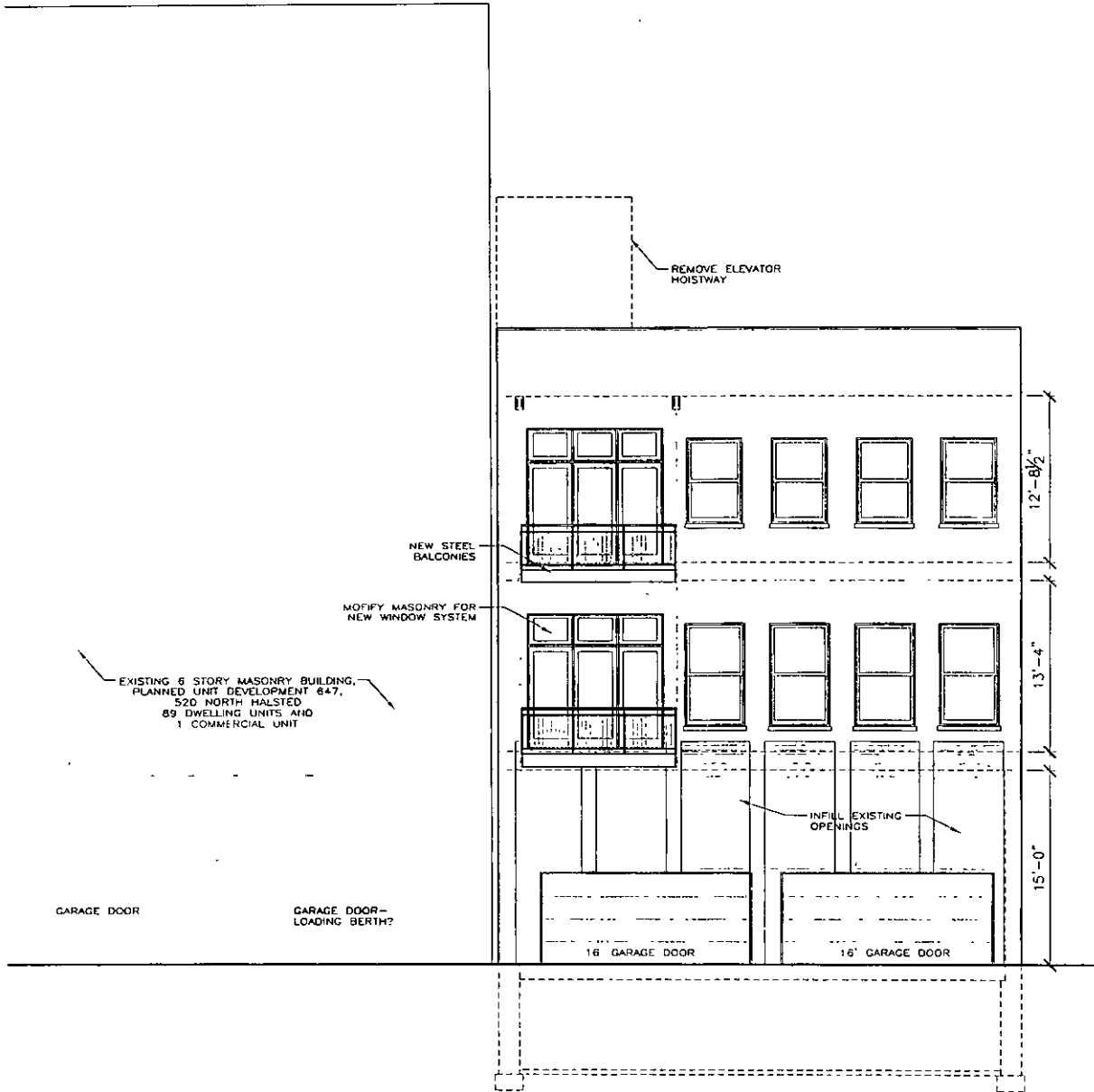
