ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B2-2 Neighborhood Mixed-Use District symbols and indications as shown on Map No. 13-1 in the area bounded by

A line 86.37 feet north of and parallel to West Catalpa Avenue; North Western Avenue; West Catalpa Avenue; the alley next west of and parallel to North Western Avenue;

SECTION 2: To those of a C2-2 Motor Vehicle-Related District

SECTION 3: This ordinance takes effect after its passage and approval;

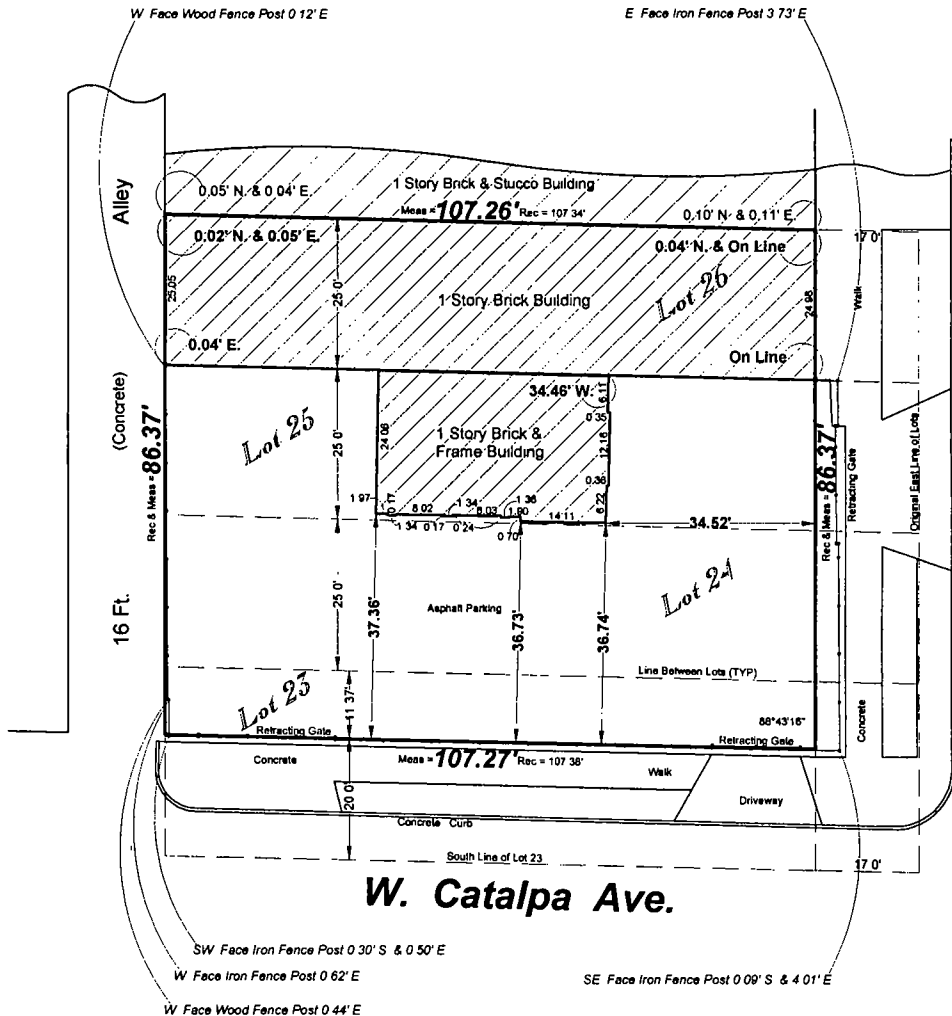
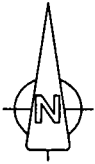


The owner of the property and the applicant for the zoning amendment is Sharon Gronsky and Lorraine Frazin, PO Box 622, Deerfield, IL 60615.





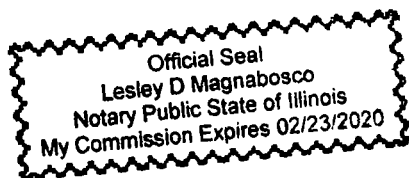
