Permission and authority are hereby given and granted to MAUDE'S upon the terms and subject to the conditions of this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent to its premises located at 840 W. Randolph St.. Said sidewalk cafe area #1 shall be seventeen point two five (17.25) feet in length and ten point five (10.5) feet in width for a total of one hundred eighty-one point one three (181.13) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along W. Randolph. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Sunday 11:00am until 11:00pm Monday through Saturday 8:00am until 11:00pm

Compensation: \$600.00

SEATING CAPACITY: 18

Sidewalk Cafe Permit and approved plan must be posted at all times.
