ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the C2-2 Motor Vehicle-Related Commercial District symbols and indications as shown on Map No. 7-I in the area bounded by

Beginning at a line 413.57 feet southeast of the intersection of West Logan Boulevard and North Milwaukee Avenue as measured along the northeast right-of-way line of North Milwaukee Avenue and perpendicular thereto; the alley next northeast of North Milwaukee Avenue; a line 460.61 feet southeast of the intersection of West Logan Boulevard and North Milwaukee Avenue as measured along the northeast right-of-way line of North Milwaukee Avenue and perpendicular thereto; and North Milwaukee Avenue (TOB),

to those of a B2-5 Neighborhood Mixed-Use District.

SECTION 3. This ordinance shall be in force and effect from and after its passage and due publication.

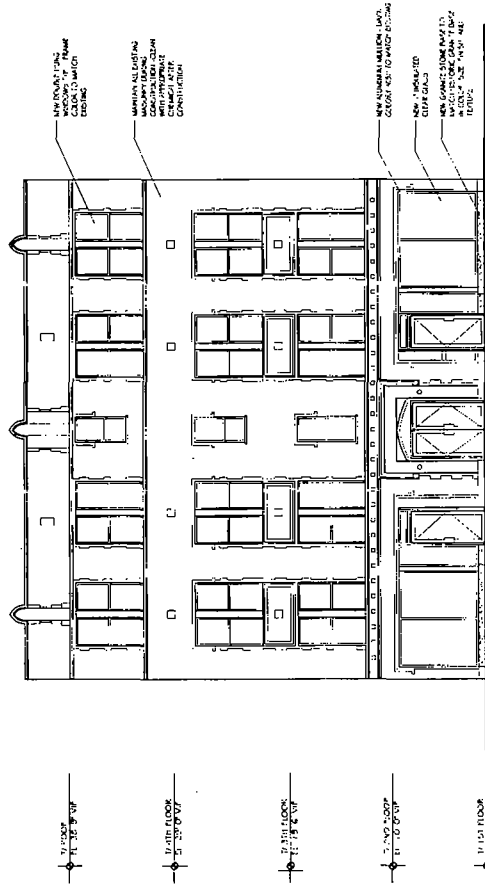


PROPOSED EAST ELEVATION

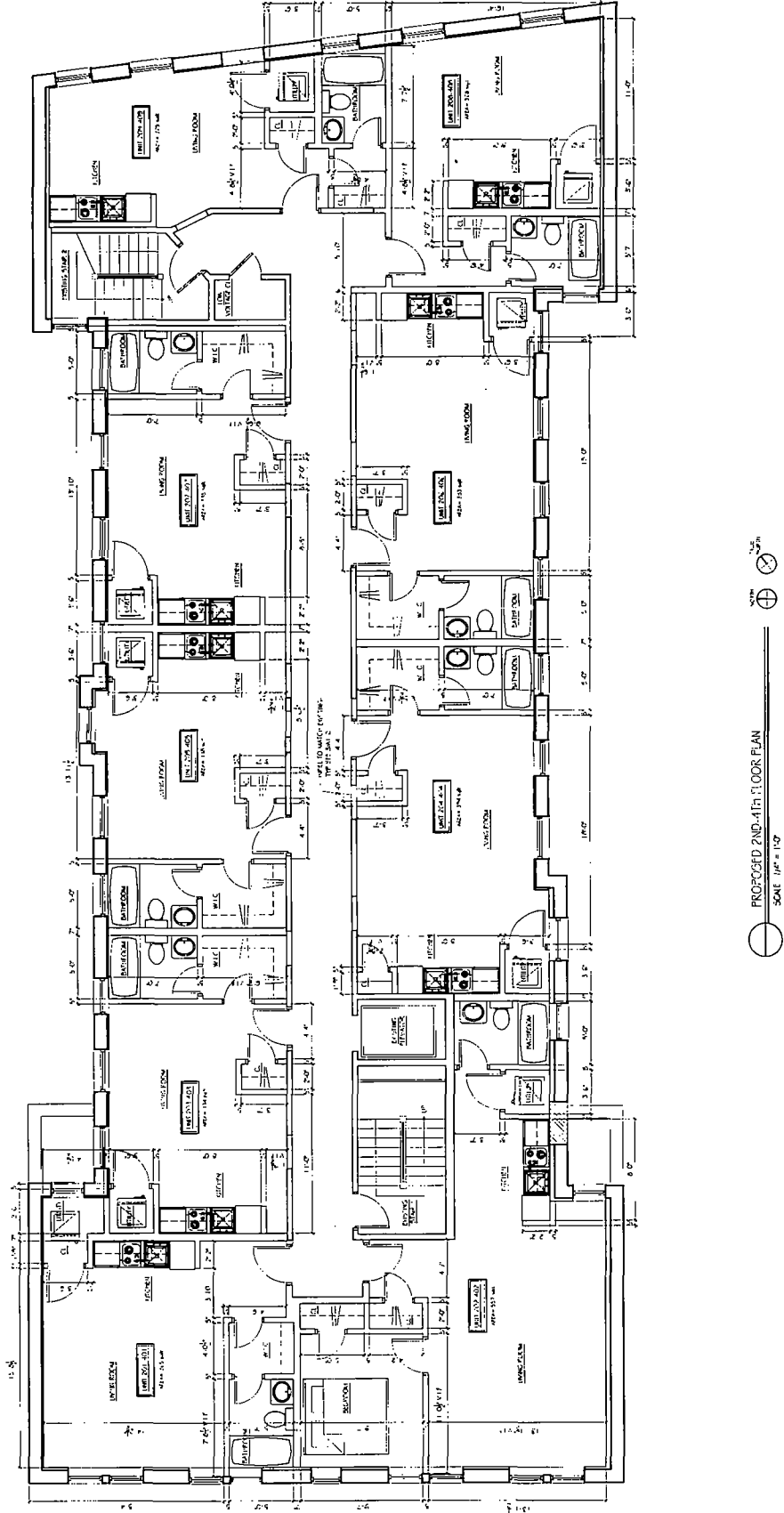

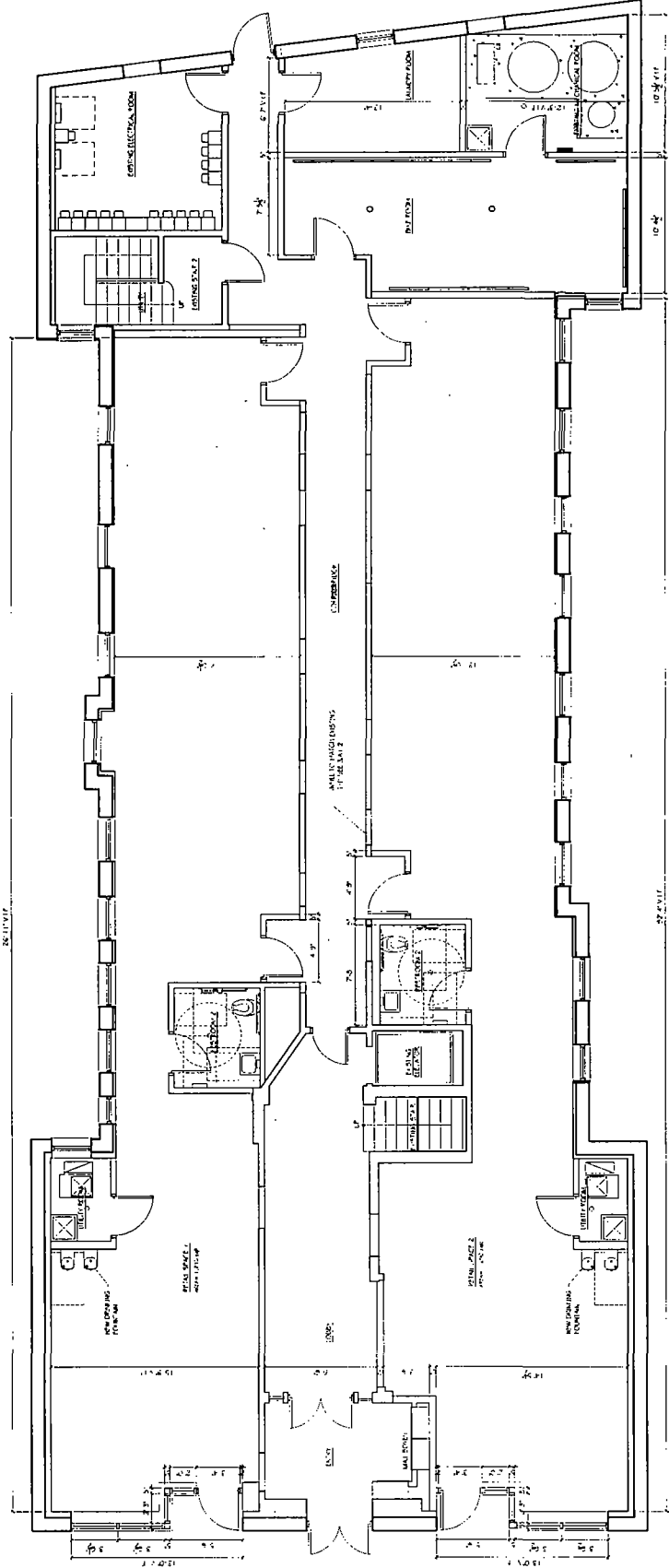
