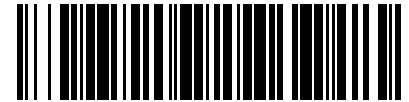

ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 6-G in the area bounded by

the second alley next southeast of and parallel to South Lyman Street;
South Gratten Avenue; a line 75 feet southeast of and parallel to the
second alley next southeast of and parallel to South Lyman Street;
and the alley next southwest of and parallel to South Gratten Avenue,

to those of a B2-3 Neighborhood Mixed-Use District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

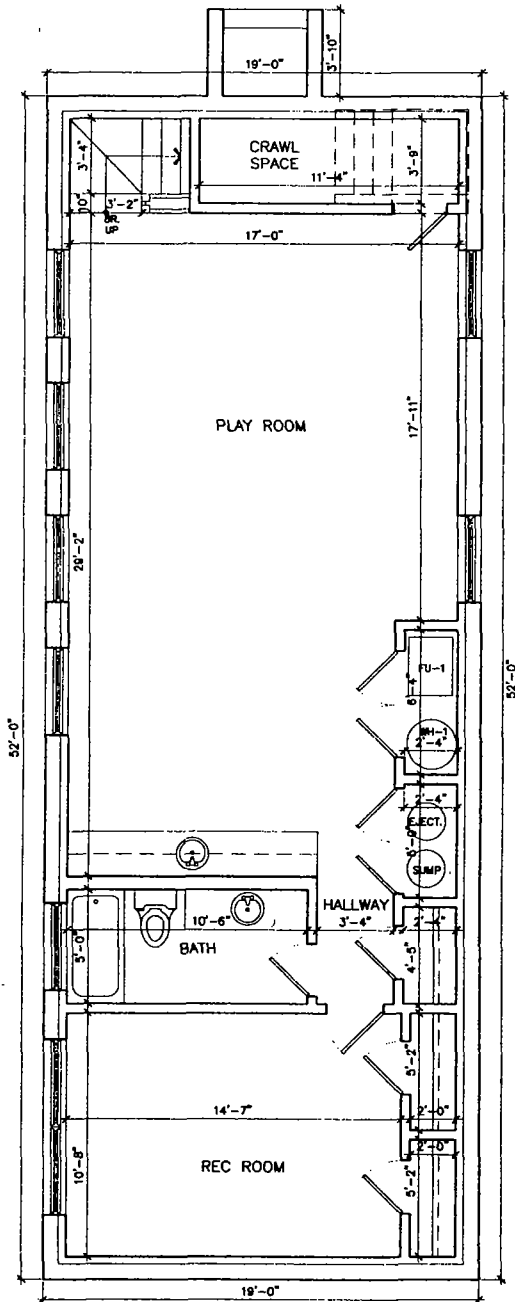

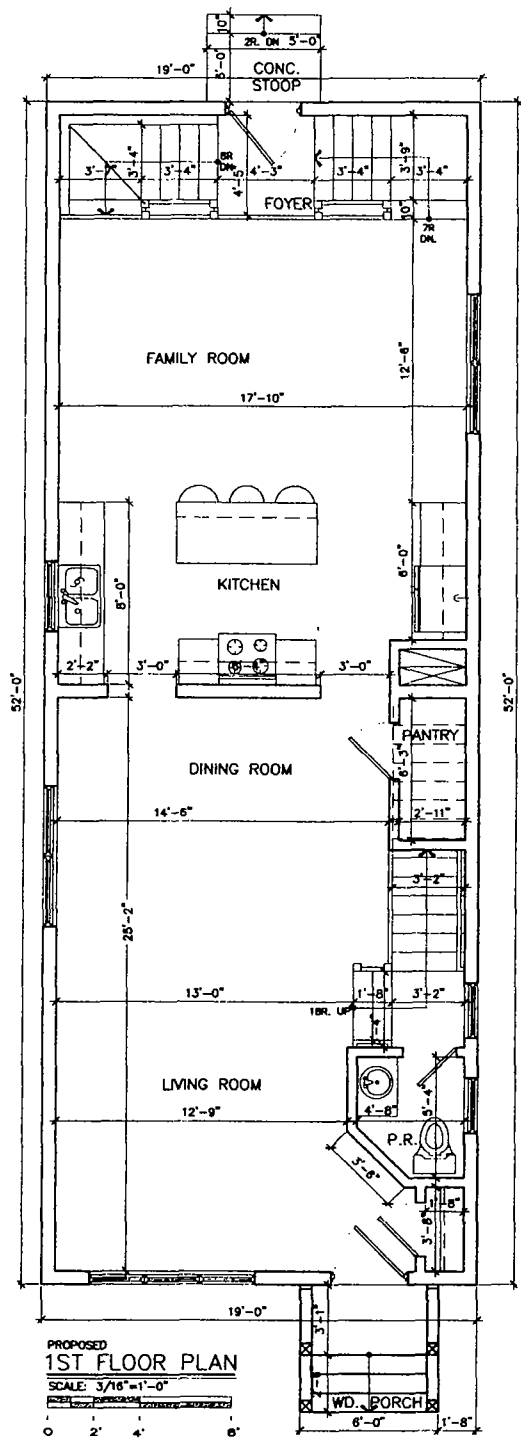
SITE PLAN

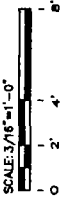


LEFT SIDE ELEVATION
