**WHEREAS,** The Honorable Francis J. Reilly has been called to eternal life by the wisdom of God at the age of 94; and

**WHEREAS,** The Chicago City Council has been informed of his passing by Alderman Edward M. Burke; and

**WHEREAS,** A resident of Western Springs, Francis J. Reilly was the loving husband of Rita, nee Burke; and

**WHEREAS,** The Honorable Francis J. Reilly was the much-adored father of Mary Ellen, Daniel, James, Patti and Kate and the grandfather of eleven to whom he imparted many of the fine and noble qualities that he possessed in abundance; and

**WHEREAS**, The Honorable Francis J. Reilly graduated from DePaul University where he went on to earn his law degree; and

**WHEREAS,** The Honorable Francis J. Reilly served his country during World War II in the United States Army as a member of the 82<sup>nd</sup> Airborne Division; and

**WHEREAS,** The Honorable Francis J. Reilly enjoyed a long and highly successful career as an attorney before becoming an Associate Judge of the Circuit Court of Cook County; and

**WHEREAS,** The Honorable Francis J. Reilly joined the law firm of Daley & Lynch in 1948 and worked with future Chicago Mayors Richard J. Daley and Richard M. Daley; and

**WHEREAS,** Following 33 years of distinguished service, the Honorable Francis J. Reilly left the firm of Daley, Reilly & George in 1981 when he was elevated to the bench; and

**WHEREAS,** The hard work, sacrifice and dedication of the Honorable Francis J. Reilly serve as an example to all; and

**WHEREAS,** His love of life and ability to live it to the fullest endeared the Honorable Francis J. Reilly to his family members, friends and all who knew him, and enabled him to enrich their lives in ways they will never forget; and

**WHEREAS,** The Honorable Francis J. Reilly will be dearly missed and fondly remembered by his many relatives, friends and admirers; and

**WHEREAS**, To his beloved family, the Honorable Francis J. Reilly imparts a legacy of faithfulness, service and dignity; now, therefore
