SECTION 1: Title 17 of the Municipal Code of Chicago, Chicago Zoning Ordinance, is amended by changing all the M1-1 Limited Manufacturing / Business Park District symbols and indications as shown on Map No. 12-K in the area described as follows:

the west right-of-way line of the Chicago and Western Indiana Railway;
South Archer Avenue;
South Knox Avenue;

to those of a M3-1 Heavy Industry District, which is hereby established in the area described.

SECTION 2: This ordinance shall take effect upon its passage and due publication.


