ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the M1-1 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 1-1 in the area bounded by

the alley next northeast of West Grand Avenue; a line 113.70 feet southeast of the intersection of North Washtenaw Avenue and West Grand Avenue as measured at the northeasterly right-of-way line of West Grand Avenue and perpendicular thereto; West Grand Avenue; and a line 89.70 feet southeast of the intersection of North Washtenaw Avenue and West Grand Avenue as measured at the northeasterly right-of-way line of West Grand Avenue and perpendicular thereto,

to those of a B2-2 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

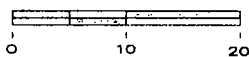

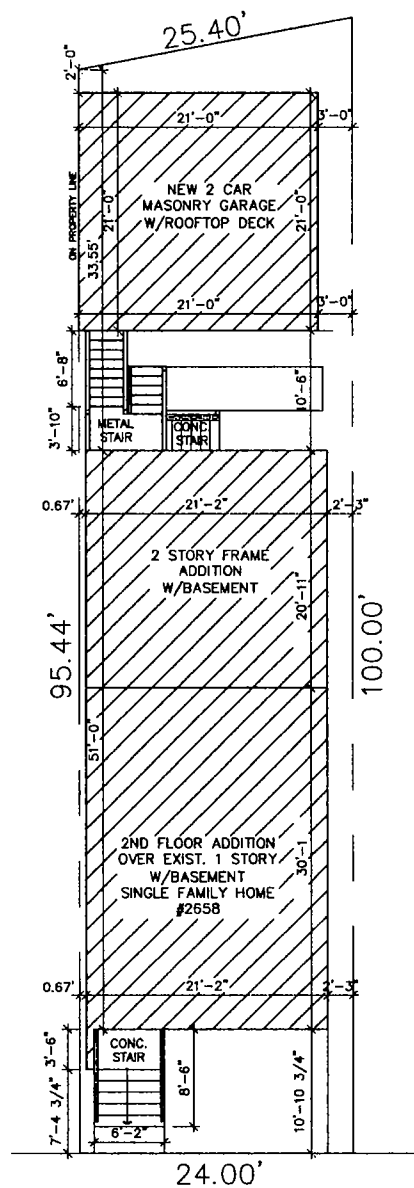

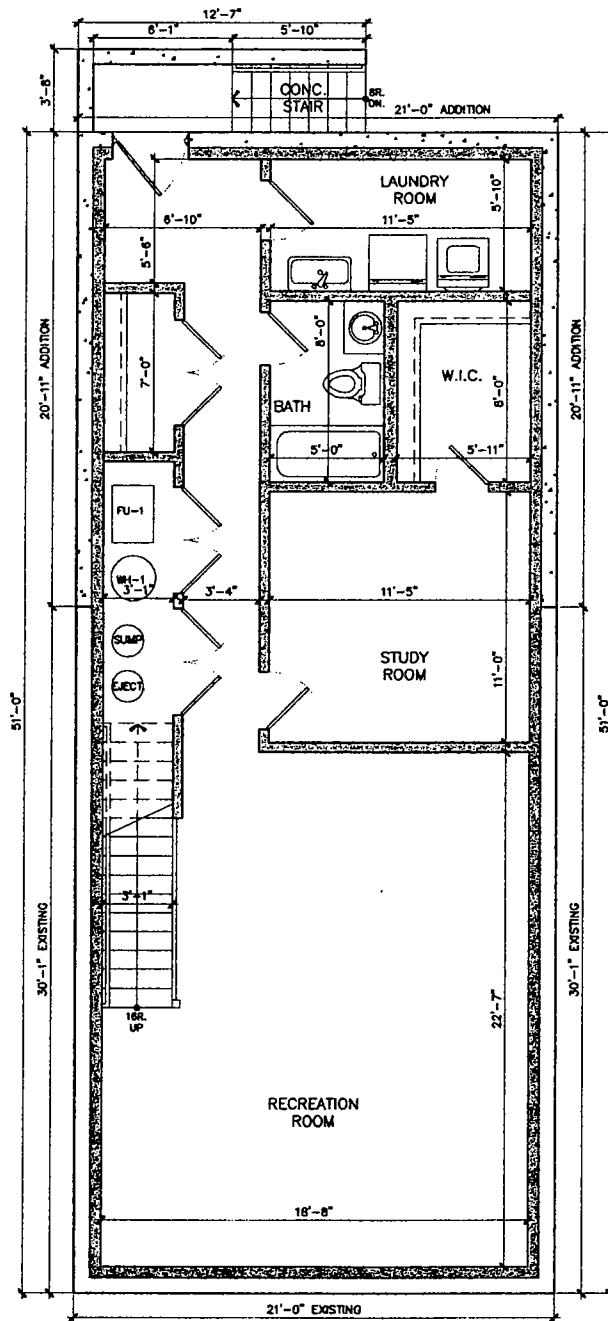

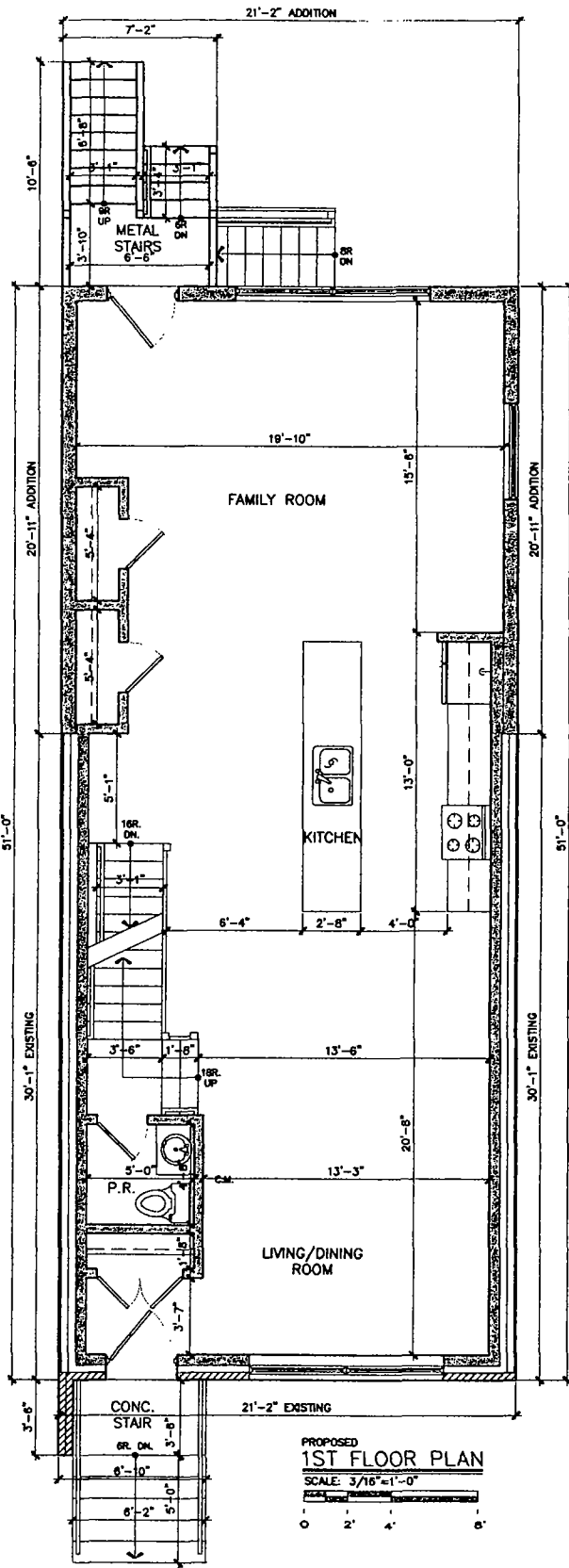

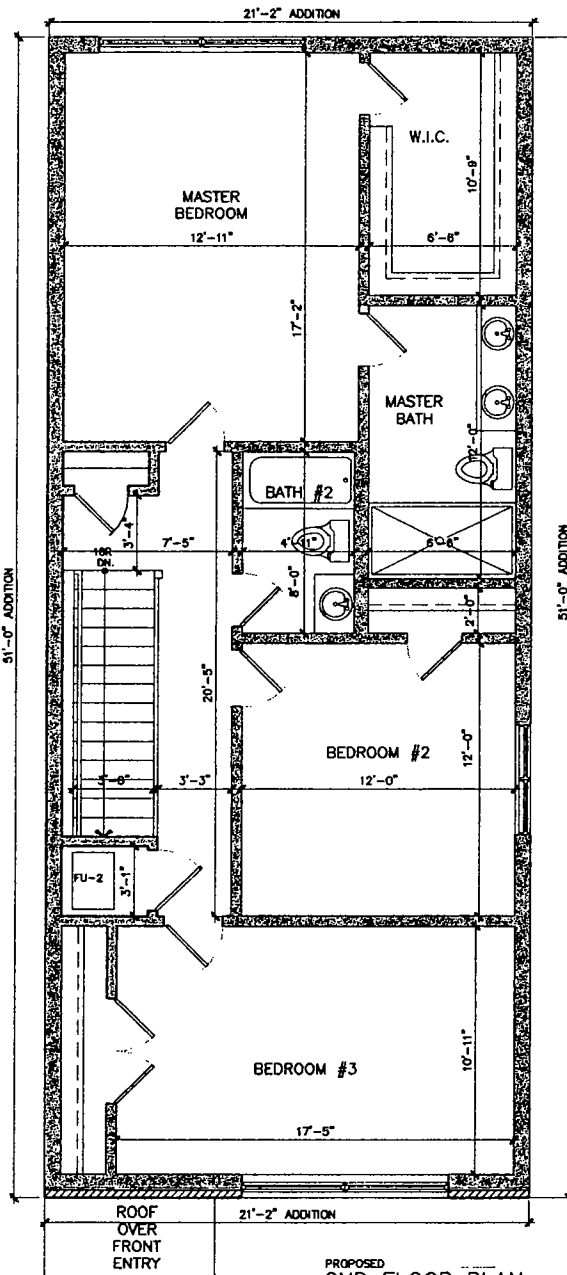
