ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the DX-3 Downtown Mixed-Use District symbols and indications as shown on Map No 1-G in the area bounded by:

A line 100.21 feet north of and parallel to West Washington Boulevard; North Peoria Street; West Washington Boulevard; the 16.00 foot public alley next west of North Peoria Street; a line beginning 90.32 feet north of and parallel to West Washington Boulevard running east 14.07 feet; a line 100.76 feet west of and parallel to North Peoria Street.

SECTION 2. To those of a DX-5 Downtown Mixed-Use District and an accompanying use district is hereby established in the area described above.

SECTION 3. This ordinance takes effect after its passage and due publication.



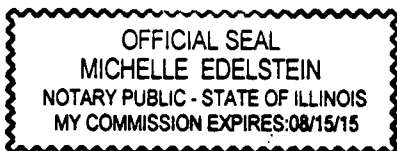
