ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 9-J

in the area bounded by:

A line 174 feet South of and parallel to West Roscoe Street; North Lawndale Avenue; a line 224 feet South of and parallel to West Roscoe Street; the public alley next West of and parallel to North Lawndale Avenue.

To those of an RM4.5, Residential Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and due publication.

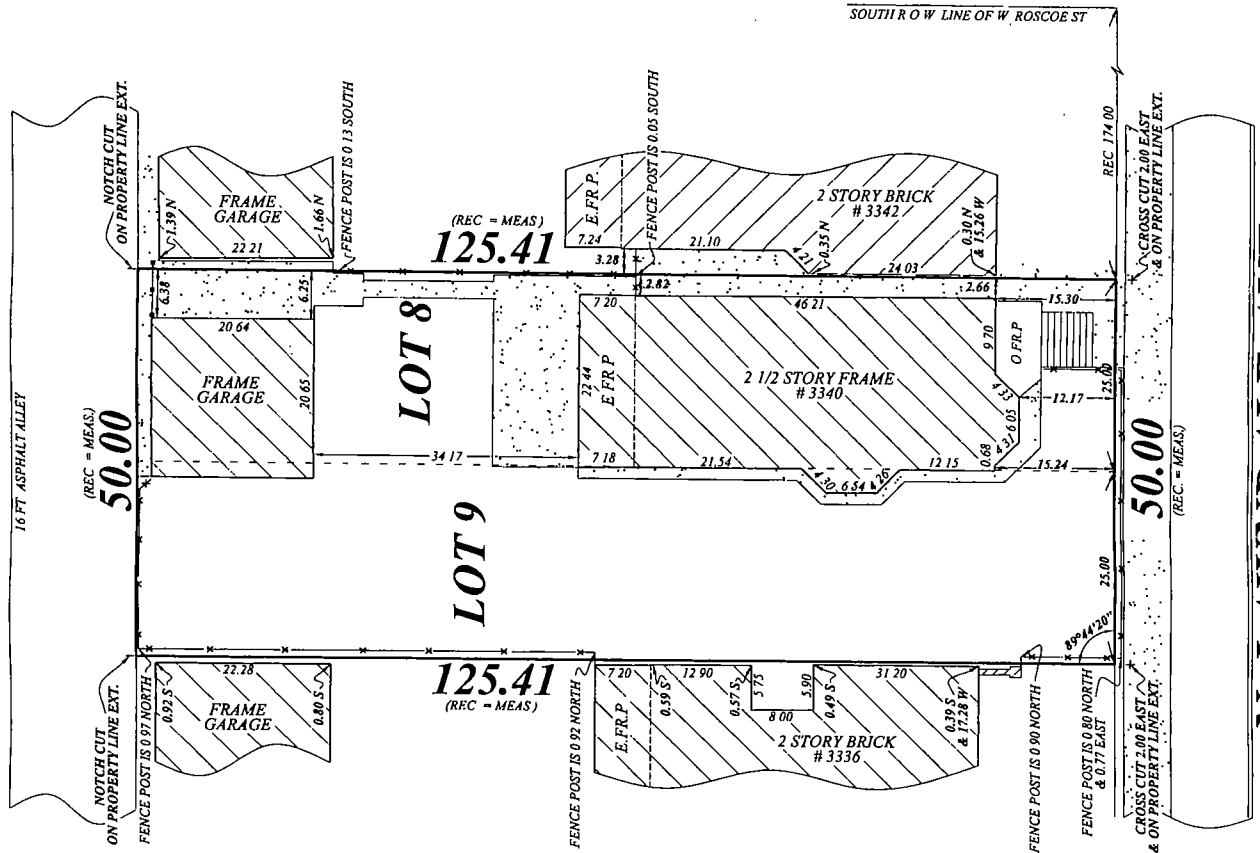
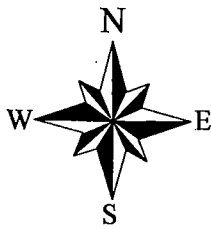
