AMEND STANDING ZONE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

Section 1. That an ordinance passed by the City Council on February 5, 1998 page 61991 of the Journal of Proceedings which reads, West Grand Avenue (north side) from a point 20 feet west of North Clark, to a point 75 feet west thereof—15 minute standing zone—unattended vehicles must have lights flashing—tow-away zone after 15 minutes—except 4:00p.m. to 6:00p.m. – Monday through Friday – tow-away zone (97-1492) in designated area, be and the same is hereby amended by striking there from, the following:

15 minute standing zone—unattended vehicles must have lights flashing—tow-away zone after 15 minutes—except 4:00p.m. to 6:00p.m. – Monday through Friday – tow-away zone and inserting in lieu thereof

Loading Zone- tow-away zone

Section 2. This ordinance shall take effect and be in force hereinafter its passage and publication.

Upper North Beaubien Court (west side) from a point 30 feet north of East Randolph Street, to a point 40 feet north thereof -- tow-away zone -- except for 15 minute standing zone -- 11:30 A.M. to 11:00 P.M.-- Saturday -- unattended vehicles must have lights flashing -- tow-away zone after 15 minutes (97-1628);

North Garland Court (west side) from a point 20 feet north of East Washington Street, to a point 70 feet north thereof -- no parking tow-away zone -- except for 15 minute standing zone -- unattended vehicles must have lights flashing -- tow-away zone after 15 minutes -- 7:00 A.M. to 7:00 P.M. -- Monday through Saturday (97-1678);
