32	E. Eastman Street; N. North Branch Street and W. Eastman Street; Two Way Stop Signs, Stopping W. Eastman Street for N. North Branch Street -- (14-1316719) [Or2014-394]
47	1801 W. Cuyler Avenue; W. Cuyler Avenue (eastbound) at N. Ravenswood Avenue (west leg - one way southbound) in front of 1801 W. Cuyler Avenue; Stop Sign [Or2015-9]
