## COMMERCIAL ORDINANCE

WHEREAS, the City of Chicago ("City") is a home rule unit of local government pursuant to Article VII, Section 6 (a) of the 1970 constitution of the State of Illinois and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the properties at 4665-4733 W. Irving Park Road, 3911-3985 N. Milwaukee Avenue, 3906-3920 N. Kilpatrick Avenue, and 3924-3940 N. Kilpatrick Avenue are owned by CSD Six Corners, LLC, an Illinois Limited Liability Company ("Developer"), and the properties at 4655-4663 W. Irving Park Road and 3942-3954 N. Kilpatrick Avenue are owned by Grossprops Associates LLC, an Illinois Limited Liability Company (non-participatory "Adjacent Owners"); and

WHEREAS, the Developer proposes to use the portion of the alleys to be vacated herein for use in a new retail development; and

WHEREAS, the City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent of the public use and the public interest to be subserved is such as to warrant the vacation of part of public alleys, described in the following ordinance; now therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

### SECTION 1.

#### **VACATION:**

THE PUBLIC ALLEY IN JACKSON'S ADDITION TO IRVING PARK, RECORDED DECEMBER 11, 1897 AS DOCUMENT NUMBER 2625769, BEING FURTHER DESCRIBED AS THE PUBLIC ALLEY LYING NORTHEASTERLY OF AND ADJOINING WITH THE NORTHEASTERLY LINE OF LOTS 1 THROUGH 15, AND LYING SOUTHERLY OF AND ADJOINING WITH THE SOUTHERLY LINES OF LOTS 18 THROUGH 25, ALL IN SAID JACKSON'S ADDITION TO IRVING PARK, BEING A SUBDIVISION OF PART OF THE NORTHWEST QUARTER OF SECTION 22, TOWNSHIP 40 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS CONTAINING 8,873 SQ. FT. (0.204 ACRES), MORE OR LESS as shaded and legally described by the words "HEREBY VACATED" on the plat hereto attached as Exhibit A, which drawing for greater clarity, is hereby made a part of this ordinance, be and the same (excepting out the portion for public use, described below) is hereby vacated and closed inasmuch as the same is no longer required for public use and the public interest will be subserved by such vacation.

## **PUBLIC WAY EASEMENT:**

THAT PART OF THE PUBLIC ALLEY LYING SOUTHERLY OF AND ADJOINING WITH THE SOUTHERLY LINES OF LOTS 18 THROUGH 23, (EXCEPT THAT PART THEREOF LYING WESTERLY OF A LINE, 127.00 FEET WESTERLY OF, AND PARALLEL WITH, THE WESTERLY LINE OF THE NORTH KILPATRICK AVENUE RIGHT-OF-WAY, SAID LINE ALSO BEING THE SOUTHERLY EXTENSION OF THE EASTERNLY LINE OF SAID LOT 18), ALL IN JACKSON'S ADDITION TO IRVING PARK, BEING A SUBDIVISION OF PART OF THE NORTHWEST QUARTER OF SECTION 22, TOWNSHIP 40 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED DECEMBER 11, 1897 AS DOCUMENT NUMBER 2625769, IN COOK COUNTY, ILLINOIS CONTAINING 2,032 SQ.FT. (0.047 ACRES), MORE OR LESS as shaded and legally described by the words "EASEMENT HEREBY GRANTED" on the plat hereto attached as Exhibit B, which drawing for greater clarity, is hereby made a part of this ordinance, be and the same is hereby vacated and but inasmuch as the same is still required for public use and the public interest will be subserved by the granting of such easement for public use.

SECTION 2. The Commissioner of Transportation is hereby authorized to accept and approve a separate redevelopment agreement or similar instrument restricting the use and improvement of the public way vacated in Section 1 of this ordinance to a perpetual, non-exclusive dedicated access area with a perpetual, nonexclusive, easement for the Adjacent Owners, and a perpetual easement for continued, unimpeded, open public pedestrian and vehicular access as depicted on the attached Plat of Easement herein made part of this ordinance, and for such use and improvements that are accessory, as that term is defined in the Chicago Zoning Ordinance, subject to the approval of the Department of Transportation, and the Corporation Counsel as to form and legality.

SECTION 3. The City of Chicago hereby reserves for the benefit of Commonwealth Edison, AT&T/SBC, Comcast and their successors or assigns, a non-exclusive utility easement to operate, maintain, construct, replace and renew overhead wires, poles, and associated equipment and underground conduit, cables, and associated equipment for the transmission and distribution of electrical energy, telephonic and associated services under, over and along the alleys herein vacated, with the right of ingress and egress. The grade of the vacated public way shall not be altered in a manner so as to interfere with the operation and maintenance of Commonwealth Edison, AT&T/SBC, and/or Comcast facilities. No construction, buildings, permanent structures or obstructions shall occur or be placed over the area herein vacated without express written release of easement by the involved utilities. Any future vacation-beneficiary prompted relocation of facilities lying within the area being vacated will be accomplished by the involved utility, and be done at the expense of the beneficiary of the vacation.

SECTION 4. The vacation herein provided for is made upon the express condition that within 180 days after the passage of this ordinance, the Developer shall pay or cause to be paid to the City of Chicago as compensation for the benefits which will accrue to the owner of the property abutting said part of public alleys hereby vacated the sum \_\_\_\_\_ dollars (\$ \_\_\_\_\_), which sum in the judgment of this body will be equal to such benefits.

SECTION 5. The vacation herein provided for is made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, the Developer shall file or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, together with the associated full sized plat as approved by the Superintendent of Maps and Plats ("Superintendent"), or any acting Superintendent.

SECTION 6. This ordinance shall take effect and be in force from and after its passage. The vacation shall take effect and be in force from and after its recording.
