**ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all **RT4 Residential Two-Flat, Townhouse and Multi-Unit District** of the symbols and indications as shown on Map No 20-E in the area bounded by

South Dr Martin Luther King Jr Drive; a line 74.84 feet north of and parallel to East 81st Street; the public alley next east of and parallel to South Dr Martin Luther King Jr Drive; a line 49.84 feet north of and parallel to East 81st Street;

to those of **B1-2 Neighborhood Mixed-Use District**

SECTION 2. This ordinance takes effect after its passage and approval.


